## **Zimbabwe – Complex Emergency**

Fact Sheet #2, Fiscal Year (FY) 2010

September 30, 2010

### **KEY DEVELOPMENTS**

- As of September, the USAID-funded Famine Early Warning Systems Network (FEWS NET) reports stable national food security due to an adequate 2009/2010 harvest and sufficient availability of food in local markets. However, some food-insecure populations will require emergency food assistance starting in October, according to FEWS NET. The U.N. World Food Program (WFP) and the U.N. Food and Agriculture Organization (FAO) report that approximately 1.68 million people, including 1.3 million vulnerable rural individuals, will likely require emergency food assistance from January to March 2011, the peak of the 2010/2011 lean season.
- Programs instituted by relief agencies, including USAID/OFDA and grantees, in FY 2009 and FY 2010 helped prevent a recurrence of the widespread cholera outbreak that killed nearly 4,300 Zimbabweans in 2008/2009. In 2009/2010, the number of cholera cases and deaths declined by more than 99 percent.

### **CONTEXT**

- Humanitarian conditions for most Zimbabweans have improved significantly during 2010, although many Zimbabweans remain unemployed due to the nation’s decade-long economic deterioration. Poorly maintained infrastructure for agricultural production, health, water and sanitation, and power generation, resulting from earlier Government of Zimbabwe (GoZ) corruption and policies, continue to limit access to basic services such as healthcare and clean water.
- On October 15, 2009, U.S. Chargé d’Affaires, a.i., Donald S. Petterson reissued a disaster declaration in Zimbabwe due to the complex emergency. Since FY 2007, USAID has provided more than \$658 million in humanitarian assistance to benefit vulnerable Zimbabweans.
- As in the past several years, USAID/OFDA has focused FY 2010 humanitarian assistance on agriculture and food security, urban livelihoods, protection of vulnerable populations, and water, sanitation, and hygiene (WASH) activities. Through provision of seeds and fertilizer, distribution of water purification tablets and water containers, hygiene promotion, conservation agriculture training, income generation projects, and programs to assist vulnerable children, USAID/OFDA assists Zimbabwean communities in building resilience to food insecurity, waterborne diseases, and displacement.

### ***Agriculture, Food Security, and Livelihoods***

- WFP and FAO report that the 2009/2010 harvest resulted in the production of approximately 1.66 million metric tons (MT) of cereal. The addition of approximately 317,000 MT of commercial imports and approximately 111,000 MT of emergency food assistance is expected to meet the 2.09 million MT national cereal requirement until the next

harvest, expected in April 2011. Access to food in markets remains an obstacle for vulnerable urban and rural households due to lack of access to currency.

- WFP and FAO estimate that nearly 1.68 million Zimbabweans will require emergency food assistance in early 2011. By contrast, approximately 3.5 million people relied on emergency food assistance during the 2009/2010 peak hunger season, and more than 7 million people required emergency food assistance during the same period in 2008/2009.
- In FY 2010, USAID/OFDA provided more than \$6 million to support agriculture and food security activities in rural areas of Zimbabwe, including low-input gardens to boost vulnerable households' food security and nutrition, construction and rehabilitation of water catchment structures, training in conservation farming to make better use of water, and improved farmer access to seeds, fertilizer, and tools. USAID/OFDA provided an additional \$3 million to support livelihood and food security activities for highly vulnerable households in urban areas.

### **Health and WASH**

- In 2009/2010, the rate of cholera cases and deaths declined by more than 99 percent. The U.N. World Health Organization (WHO) reported 757 cholera cases and 19 resulting deaths between February and late September 2010, compared to the 98,522 cases and 4,282 deaths reported during the 2008/2009 outbreak. However, from September 2009 to August 2010, WHO reported 11,579 suspected cases of measles, including 651 confirmed cases and 527 deaths. Following a late-May nationwide measles immunization campaign that reached 5.1 million children, the number of districts with confirmed measles outbreaks has fallen from 53 to eight, according to WHO.
- Although cholera case rates have declined, and despite water infrastructure improvements in 2010, Zimbabweans continue to lack access to regular, clean water from municipal systems. USAID/OFDA works to mitigate the risk of waterborne disease through programs in hygiene promotion, distribution of water purification tablets and water containers, and efforts to improve water quality and access to water, including rooftop rainwater harvesting projects at schools and in vulnerable households.
- In FY 2010, USAID/OFDA provided nearly \$7.7 million to support WASH activities, targeting more than 745,000 estimated beneficiaries.

### **Protection**

- According to the U.N. Office for the Coordination of Humanitarian Affairs (OCHA), the GoZ and Protection Cluster have prepared a contingency plan if the Government of South Africa begins deporting undocumented Zimbabweans, potentially resulting in an influx of returning Zimbabweans. The International Organization for Migration (IOM) estimates that as many as 1.5 million Zimbabweans reside in South Africa illegally. USAID/OFDA continues to monitor potential humanitarian consequences that could result from a significant re-migration.
- Large-scale internal displacement in urban and peri-urban areas as a result of political violence in recent years has jeopardized the livelihoods of already vulnerable populations. In FY 2010, USAID/OFDA provided \$2.5 million for protection programs in Zimbabwe, benefiting an estimated 48,850 beneficiaries, including 2,500 internally displaced persons (IDPs). USAID/OFDA protection programs help meet child protection needs, improve livelihoods, and increase food security.

State/PRM also provided \$800,000 to IOM to assist and protect vulnerable migrants and to help strengthen regional coordination of migration activities.
