Executive Summary

With the implementation of the yearlong project *Increasing Citizen's Awareness and Participation in the Justice System* from February 1, 2013 – February 1, 2014, BIRN has been provided media space so that citizens could more effectively participate in debates. Thus BIRN proactively supported efforts by justice institutions and civil society to enhance transparency, combat corruption, and ensure equal access to justice through the fair, transparent, and effective administration of justice in Kosovo. Moreover, BIRN has also strived to continuously push for more transparency and encourage an efficient implementation of reform in the justice system in Kosovo, while at the same time educating citizens on the importance of accessible justice institutions for resolution of problems.

In the course of the project implementation, BIRN has monitored 738 court hearings. The information gathered from the monitoring has fed the content of televised investigations for the TV program *Justice in Kosovo* and that of articles for the online newspaper *Gazeta Jeta në Kosovë*. It is vital to note that BIRN monitors and researchers have surpassed the initially planned number of articles, and, instead of 50, have compiled 232 articles on *Gazeta Jeta në Kosovë* looking at issues of transparency and ethics in courts across Kosovo.

Following continuous oversight of justice institutions and reporting through *Justice in Kosovo* and *Gazeta JNK* on May 31, 2013, BIRN organized a roundtable discussion with figures of the justice system in Kosovo in order to delineate issues of utmost significance with regards to transparency and ethics. Moreover, the discussion also focused on identifying the shortcomings of the system in attracting citizens to access justice and devise solutions on how their problems can be resolved through legal means.

BIRN produced 24 TV reports on the rule of law, access to justice, prosecution, police and security. Twelve TV reports have focused the roles and responsibilities of a vast number of decision-makers in the justice system, court staff, including court staff, local and central level officials, civil society representatives and other relevant stakeholders and judicial institutions in the Kosovar justice system. In addition, in the remaining 12 TV reports, BIRN has identified and broadcast cases of successful litigation, in the quest of increasing citizens' faith towards legal means of problem resolution. *Justice in Kosovo* investigations have been broadcast on the public broadcaster, Radio Television of Kosovo, during primetime Sunday, starting at 9pm. Meanwhile, BIRN has also compiled and published 24 narrative summaries of each televised report produced in the course of the project.

In the course of the project, BIRN also engaged in advocacy initiatives as well as regular meetings with civil society organizations in the rule of law sector. Specifically, BIRN met with local and

international judges, prosecutor and other stakeholders to discuss in detail ways of improving transparency in the justice system as well as citizens' access to justice institutions. Moreover, BIRN held regular meetings with CSOs active in the rule of law sector, with specific focus on issues that were elaborated as part of the TV reports and articles produced as part of the project.

Lastly, BIRN has also been active in advocating on several issues in the rule of law system by participating in local media talks, including one talk that was hosted by the Serb local TV channel, TV Puls.

In conclusion, BIRN has successfully implemented its activities, which have ultimately resulted in concrete changes in the justice system. Specifically, BIRN has placed its focus in informing citizens on the changes to the rule of law system with the new Criminal Code entering into force, which foresees changes to the overall organization of the system, among others. Lastly, investigative analyses, written articles, program summaries are all freely available on BIRN websites, *Justice in Kosovo* website, and *Gazeta Jeta në Kosovë* website.

Project Outputs and Results

Below please find an elaboration of activities carried out by BIRN from February 2013 to February 2014 in order to achieve the set objectives of the project:

Objective 1 – Enhance public awareness towards the problems faced by the justice system and ways to help resolve them

The implementation of the activities below have substantially contributed to an improved public perception of the justice system in Kosovo and an improved performance of the courts in regard to complying with rules and procedures.

1. Fifty articles and columns on transparency and ethics in courts and prosecutorial system to be published on *Gazeta Jeta në Kosovë*

This objective was achieved through the regular articles and columns depicting the state of transparency and ethics within justice institutions. *Gazeta JNK* has been among the first ones in reporting on high-profile cases tried by EULEX judges, cases of war crimes, controversial murders and an array of issues that report on the efforts to improved transparency and ethics in the court system in Kosovo. BIRN has been one of the few media outlets to have brought issues of high public interest to wider audiences which have engaged them into further discussions through the comments section.

66 articles were published only on the first phase of the project, already surpassing the initially planned 50 articles per project duration. BIRN is delighted to report that in the course of the project in total 232 such articles were published on the online news and analysis portal, Gazeta JNK which enjoyed 2,852,024 page views throughout the project duration. A rating measurement research conducted by an independent company shows that 30% of people in Kosovo are taking their information exclusively from Internet (largely through social networks such as Facebook). Thus articles were promoted widely on social media, reaching around 109,000 followers on its Facebook page and its over 5,000 followers on Twitter. Through the articles, BIRN has shed light on the flow of some of the most controversial cases, involving public servants, high-profile political servant and war crimes. The articles have followed a standard of introducing each judicial procedure the case has gone through, chronologically, in order for the readers to be better placed to grasp the ways in which these cases are dealt with by rule of law institutions in Kosovo. A few examples include:

[Limaj with new corruption case](#) – The article looked at a new case initiated against former Minister of Transport and Telecommunication; Fatmir Limaj, who was seen in the Kosovo Special Prosecution premises. Mr. Limaj has been interviewed for a new corruption case. Limaj’s defense lawyer Tahir Rrecaj, has denied the allegation for new investigation against his client.

[Bukoshi has not signed the license for drug imports](#) – This article looked at the testimony of the executive director of *Jona Med*, in the court case Tolaj, Bukoshi and others about misuse of official position, tax evasion, and bribery. The Minister of Health has asked the company in question to recall *Paracetamol* from the market. But, when the company required a license for replace those drugs with new ones, the Ministry of Health did not sign the contract, explained the witness.

[Sali Asllanaj has been judged for the misuse of one million euro](#) - Former mayor of Suhareka municipality, Sali Asllanaj – currently member of the Kosovo Assembly, is charged because on August 28, 2008 has illegally signed the agreement for using a socially owned construction land. This agreement enabled a company to construct residential business and benefited more than one million euro.

[Limaj heard the indictment for corruption](#) – This article reported on the hearing for the former Minister of Transport and Telecommunication, Fatmir Limaj, who had his charges read to him and other defendants. Among other things in this session, the court decided that lawyer Karim Khan can defend Fatmir Limaj and that the prosecutor can present the evidence he possess.

Medicus clinic is sold - Lutfi Dervishi's lawyer (the owner of Medicus clinic) at the end of the court session has notified that his client has sold the clinic due to high tax and electricity bills, even though the clinic, according to the court order, was a confiscated facility.

Kosovo Police official accused of stealing 27 euro from her colleague - According to the indictment, the defendant F.Sh is accused for committing criminal offense, taking stealthily approximately 27 euro from her colleague's purse, which was placed on the office desk where she works. The police officer in question has been fired.

Salustro requires detention of Lushtaku and others - Five arrested people including senior officials of the former Kosovo Liberation Army, suspected for war crimes by EULEX, are expected to appear before the judge on Friday in the Appeal Court premises. A detention measure is likely to follow against them.

Enver Sekiraqa tried in Dubrava - Enver Sekiraqa suspected for assaulting an officer in 2005, is to be tried in Dubrava prison, in the same place where he is suffering another sentence for the same criminal offense as well as for threatening police officers. In 2007 he was confronted with a policeman who was part of the Special Police Unit in Ferizaj municipality, while he also is suspected that in the same year he has organized the murder of police officer, Triumf Riza.

2. Twelve narrative reports to be published on BIRN Kosovo website

Furthermore, TV reports produced and broadcast in the scope of the project were translated into comprehensive summaries that will serve as an online archive for future stakeholders. BIRN has compiled, edited and published the narrative reports of each program broadcast in the scope of the project. The reports have been compiled in English and highlight the key features of each TV report.

The www.kosovo.birn.eu.com is the website where all the narrative reports are archived by date and thus serves many as basis for research or information for students, academics, research institutions and organizations. The websites of the show attract a lot of audience who engages into discussions on the comments part of each show. The narrative reports are published on BIRN Kosovo website and are accessible for free. Please refer to Annex D for the links to the published narrative reports produced in the scope of the project.

3. Regular meetings with CSOs working in the field of anti-corruption and justice

In addition to the articles on Gazeta JNK and narrative summaries on BIRN Kosovo website, regular meetings with CSOs operating in the field of rule of law have also served the purposes of Objective 1. BIRN has been conscientious about the participation and engagement of the civil

society representatives in policy discussions raised through TV reports and written articles. Providing space to numerous civil society activists, independent experts and analysts in order to widen the perspectives on topics covered in the media products was another step towards increasing the accessibility of media and civil society in decision-making regarding problems that mar the justice system in Kosovo.

The meetings have fed the content of TV reports produced and articles published as envisaged in the project. BIRN has met with the Kosovo Chamber of Advocates, the Forum for Civic Initiative, the FOL Movement, and Institute for Advanced Studies, the Group of Legal and Political Studies, and others. BIRN monitors and legal experts have discussed issues ranging from the weaknesses of the rule of law system in Kosovo with allows for corruptive affairs to prevail, the performance of anti-corruption task forces, the Anti-Corruption law and the impact of the hesitation of many public officials to declare their assets, the constitutional legacy of the motion of no confidence towards some ministries, among others. Objective 2 – Educate the public on the roles, responsibilities and duties of judges, prosecutors, lawyers and other court staff

Through the implementation of the below activities, BIRN has been able to enhance general knowledge among the public of the roles and responsibilities of different court officials.

4. Twelve televised reports (up to 10 minutes each) to be broadcast on Justice in Kosovo

BIRN Kosovo has organised, filmed and broadcast 12 TV reports for “Justice in Kosovo,” which featured judicial officials who spoke about the role, responsibilities and duties of judges, prosecutors, lawyers and other court staff from courts across Kosovo. The TV reports were dynamic and engaging and covered an array of issues including: A TV report on the function, role and responsibilities of the Kosovo Judicial Council, the work of EULEX prosecutor in Kosovo, the work of the Basic Court in Ferizaj, looking at the new competencies of this court to deal with cases with imprisonment longer than 5 years, the role and responsibilities of the Kosovo Chamber of Advocates, performance assessment of the Offices of Judicial and Prosecutorial Council, the role and responsibilities of the Kosovo Police Inspectorate, Free Legal Aid, the strategy to lower the number of cases in courts etc.

The officials have been encouraged to use legalese as little as possible and several issues were successfully illustrated with examples and case studies, so that citizens were able to grasp the important elements of the judicial system. In this way, the TV reports encouraged citizens to take their problems to judicial institutions through asking court officials to provide examples of

concrete cases that have been successfully resolved. Please see Annex D for the full list of TV reports. Examples of the TV reports include:

Kosovo Chamber of Advocates was a televised report regarding the amendments of Kosovo Chamber of Advocates' laws. Since December 2013, every citizen that chooses a lawyer will have the right to know if his or her lawyer has a criminal background. The Kosovo Chamber of Advocates decided to publish all of the disciplinary decisions for advocates and lawyers. The report also shed light at the opportunity for individuals who are seeking lawyers to look into the Kosovo Chamber of Advocates and find out if there are any open cases on a particular lawyer or advocate.

Court-ordered raids - On January 20 and 26, 2013, two televised reports focused on court-ordered raids. The Kosovo Police was ordered by the court to organize raids in cafes and bars of Prishtina. This operation was initiated because the number of criminal acts was increasing inside and near bars. Police also searched for illegal drugs and weapons. Around 80 police officers were involved in this operation. A total of nine bars were raided during the operation. Police found small bags of marijuana and weapons such as knives and iron sticks. The Kosovo Police operation was completed without any incidents.

Corruption in KPMM - On December 22, 2013, Justice in Kosovo discussed bribery at the Commission for Mines and Minerals. In 2011, the Kosovo government made a decision that banned harvesting gravel from domestic rivers. According to the decision, made on November 2, 2013, "The law will be valid for three years starting from the day it was implemented." The decision signed by Prime Minister Hashim Thaci was supposed to be carried out by the Commission for Mines and Minerals, Kosovo Police and other institutions. In 2013, the owner of the company "Elezaj," Bedri Elezaj, from Klina, told *Justice in Kosovo* that some inspectors asked him for a bribe. The report went on to further discuss how the rules of law institutions have proceeded further with the corruption case and the role and responsibilities of each institution involved.

Amnesty Law – Another report prepared by BIRN looked at the issue which aroused after the Kosovo Correcting Service, which is supervised by the Ministry of Justice, submitted to the Basic Courts a list with the names of approximately 350 prisoners who were to benefit from the Amnesty Law. The list comprised of the names of large number of individuals sentenced, accused and under investigation. However, the heads of the judicial system in Kosovo expect to exempt only a small number of persons on the list. The list also included high-profile criminals including Enver Sekiraqa, Faton Hajrizi, Nazmi Mustafi, Zarko Veselinovic. The report shed light on the concerns of many with regards to the release of such a large number of individuals, as well as criminal charges which were to be included in the law.

Free Legal Aid - *Justice in Kosovo* prepared a report on free legal aid. Free legal aid is a right of citizens who cannot afford to engage a professional who offers professional judicial services. Citizens with social assistance, citizens with no sufficient financial income, single mothers, refugees, displaced persons, elderly, citizens with special needs, minors, women, children, police administration, education administration, civil servants administration, and others have the right to ask for free legal aid. The report explained procedures on how these groups can access free legal aid, illustrated by a case when a citizen asked and obtained free aid.

Kosovo Police Inspectorate - *Justice in Kosovo* also prepared a report about how the Kosovo Police Inspectorate operates. Even though they are called to protect the law, police officers sometimes have been found to contradict the law. The Kosovo Police Inspectorate was established in order to deal with police officers that violate the law. Up until 2011, the Police of Kosovo dealt with these violations, but to avoid every possible conflict of interest, Ministry for Internal Affairs established an independent section that investigates police officers. The report explained in detail the responsibilities of this institution and the motives for investigations to be initiated against police officers.

5. Initiate 6 local media talks with judicial officials sharing legal expertise with the public

BIRN Kosovo's legal experts and researchers have successfully participated in six media talks across local and national media in Kosovo. In the scope of each talk, the participants elaborated on several pressing issues that have marred the legal system in Kosovo throughout 2013. These appearances have contributed to a better outreach of the project, and enhanced the public understanding of the justice system in Kosovo, specifically improving the perception of access to justice in resolving problems through legal means. One of the media talks that took place in January 2014 was broadcast in Serbian in the Serb local media TV Puls.

Moreover, the talks also include discussions on legislation with interest to the public, including legal base and the judicial implication of libel and hate-inciting language on online media, the protection of sources, lawyers' misleading declarations to media and the misinformed public opinion on several court cases, the freedom of media and the rights of media to report from courts, and the transparency of the justice system. 6. Advocating in Kosovo courts and in Kosovo Judicial Council

BIRN Kosovo has been active in advocating to a vast number of judicial officials to apply basic procedural rules in order to improve the legitimacy of justice institutions in front of the public and in order to get them to trust the legal system. BIRN researchers and legal experts have met

with Enver Peci – Chairman of the Kosovo Judicial Council, Marjana Papa - Senior Anti-Corruption Officer at EULEX, Bashkim Hyseni – head of the Basic Court in Ferizaj and Johannes Pickert, EULEX prosecutor for financial crimes.

Issues discussed in these meetings include: the role of the Kosovo Chamber of Advocates, performance assessment of advocates in Kosovo, political declarations of lawyers in media and their implications to court cases, cooperation with advocates, transparency of the judicial system in Kosovo, the level of citizen access to justice, access to indictments, access to court records, the implementation of Point 10 of the Kosovo-Serbia agreement for the normalization of relations between the two and difficulties regarding this implementation, Court of Appeal – the new Division, integration of Serb judges in the Kosovo judicial system, online public access to indictments and judicial decision, prosecution’s arguments in media reporting, EULEX legacy in Kosovo, and improving transparency of EULEX cases. Objective 3 – Encourage citizens to advocate through different means for legal reforms in the justice system in Kosovo as well as report cases when they experience any form of fraud in the courts

Through the implementations of the activities below, BIRN Kosovo has been able to push for an increased citizen participation in the reform and strengthening of the rule-of-law system in Kosovo, as well as improved reporting on corruption, inefficiency, mismanagement and misconduct in the justice system in Kosovo.

7. Twelve televised reports (up to 5 minutes each) featuring cases of successful litigation to be broadcast on Justice in Kosovo

BIRN Kosovo organized filmed and broadcast 12 televised reports with citizens whose cases have been successfully litigated. This has been an effective way of encouraging citizens to utilize their rights to access to justice institutions. They set good examples to others not to lose faith in fighting their case through the courts, as well as serve as guidance to those who are facing similar problems.

The reports broadcast in the scope of the year looked at issues of different nature including: libel, misuse of official position and bribery, war crimes, divorce, guilty pleas, heritage review, the notary system, murder, drug trafficking, traffic safety, and others. The reports successfully sent positive messages on how the court system deals with different cases. They clearly broke down the procedures and illustrated each phase of procedure through a given case. Please refer to Annex D the full list of reports. Below please find summaries of some of the reports produced:

Security in Traffic – This televised report, prepared in cooperation with the Kosovo Police, showed how police react to speeding cars. According to a Kosovo police officer, 32 accidents happened in 2013, in which 37 people died. The officer warned that accidents are more frequent in the winter. Therefore the Kosovo Police created a plan whereby the police stop drivers to inspect for winter equipment. In the report, the Kosovo Police monitored a few cars, which were found to be driving faster than the speed limit and some that did not have the winter equipment. The report also explained the legal procedures that citizens should follow in the aftermath of being issued a fine.

Successful Resolution of a Divorce Case - Justice in Kosovo prepared a televised report about the successful divorce of a couple processed by the Basic Court of Prishtina. This process lasted only one day. The right to get married and divorced, in Kosovo, is regulated according to the Law on Family. The report reviewed procedures that have to be followed in order to end a marriage, both through cancellation and divorce. Cancellation of marriage happens when the marriage was not legal from the beginning. Divorce happens when the couple for any reason decides to end up the marriage". It also summarized the four stages of divorce and explained the issues of property division and children custody that have to be decided by the court.

The Guilty Plea - *Justice in Kosovo* also prepared a short report about the agreements regarding the guilty plea. In this report, a case that occurred on June 14, 2013, in the Basic Court of Peja has been used as an example to illustrate the guilty plea agreement. After two court hearings, former judge Kolë Puka was sentenced to a year and a half in prison. Kolë Puka was accused for misusing his official position. Puka has made an agreement with the case prosecutor Ali Rexha. The report explained how in this case the judge had the right to make an agreement with the suspected perpetrator if he accepts the crime and the court would reduce his or her sentence.

Notary System - *Justice in Kosovo* also prepared a short report about inheritance review through notaries. The notary system has enabled citizens to win the right on their inherited cases in less than one hour. Citizens previously had to wait for months before their cases were reviewed due to the overload of court cases.

Investigations into the Massacre in Krusha e Vogël - Krusha e Vogel is the place where one of the most horrible massacres took place during the 1999 war. One-hundred-thirteen civilians were killed; 86 of the bodies have not been found yet and the assumptions are that they were cremated or thrown in the river Drini i Bardhe. EULEX had officially launched investigations in late May of 2012. The report explained the cooperation initiated between EULEX is cooperating with Serbia and ICTY in Hague, in order to prosecute perpetrators of this massacre, as well as, procedures how war crimes are prosecuted.

Cooperative Witnesses in Penal Procedures - *Justice in Kosovo* prepared a report about the role of cooperative witnesses in penal procedures. Cooperative witnesses are individuals who are suspected of committing, but are still witnesses of that crime. This person can be a witness until he is sentenced in the final verdict. They are used as witnesses in order to solve and prevent criminal cases. According to the law, these individuals receive a more lenient sentence as a reward for their evidence. One of the first cases of the cooperative witnessing was Nazim Bllaca. Bllaca helped imprison eight criminals and because of this Bllaca received a more lenient sentence than the others that were involved.

8. Develop a section in the social media platform Kallxo.com on court procedures¹

Through its partnership with Internews Kosova, BIRN utilized Kallxo.com, an online open-source platform for reporting corruption. Bearing in mind the 181,685 pageviews that Kallxo.com enjoys on daily basis, BIRN has created a separate section offering free information to citizens on the procedures of filing cases with the courts, prosecution offices and the office of the disciplinary prosecution. BIRN believes that such section has enhanced citizen understanding of the court system and explained which doors to knock on for justice related problems citizens may face. This has increased the public awareness of the role and responsibilities of each relevant institution, with the ultimate aim of restoring faith in the current rule-of-law system. 9. A roundtable discussion on transparency and ethics in the justice system in Kosovo

In cooperation with Media Center Caglavica, BIRN Kosovo hosted judicial officials at a roundtable discussion on transparency and ethics in the justice system. Apart from the officials and judicial experts, BIRN also hosted several representatives of civil society in Kosovo. The discussion enabled the officials to identify their shortcomings in attracting citizens to come to courts and devise solutions on how these issues could be resolved. The roundtable took place on May 31, 2013 in Hotel Prishtina and was moderated by *Justice in Kosovo* editor, Kreshnik Gashi. The panel consisted of Rafet Haxha, judge in the Prishtina Basic Court, Nenad Lazic, judge in the Court of Appeals, Musa Dragusha, from the Kosovo Chamber of Advocates.

¹ Please note that the funds for this activity have been reallocated, following the approval from the USAID side on April 30, 2013. Nonetheless, the section has been picked by the Swiss Development Cooperation. The reallocated funds from this activity have been used for the purposes of compiling articles from the courts and publishing them on Gazeta JNK.

The discussion centered around the level of transparency of the legal system in Kosovo, focusing on the elaboration of cases in media, the cooperation between media and the Kosovo Judicial Council, feedback on the work of the KJC to ensure better collaboration with the civil society organizations, the receptiveness of courts towards recommendations from civil society etc.

Problems Encountered

BIRN is delighted to report that no problems have been encountered during the implementation of the project. Issues of doubt have been addressed through regular meetings with the AOR and communication with the USAID has been vital in ensuring that the project is flowing according to the set timeline.

Branding and Marking – Project Visibility

In terms of visibility, BIRN has been highly attentive to the Branding and Marking Plan approved with the grant agreement, in the sense that it has ensured for all of its public events, TV productions and publications to bear distinct indications of USAID support and contribution. Specifically:

The following materials bore USAID identity:

- a. The credits section at the end of each *Justice in Kosovo* TV programme;
- b. www.gazetajnk.com website where 232 written articles were published;
- c. The roundtable invitation, participant lists and agenda;
- e. 12 written reports published on BIRN Kosovo website.

Sustainability Strategy

BIRN's main aim in its work in Kosovo remains the judicial reform and increasing citizens' confidence and participation in the judicial institutions. BIRN continues to work to fulfill this objective and has been fundraising to secure funds for the sustainability of its activities in this field. So far, BIRN has secured funds from a number of donors, including the European Union Office in Kosovo, the Ministry of Foreign Affairs of Netherlands and the Rockefeller Brothers fund, who will generously support *Justice in Kosovo* TV program, Gazeta JNK for articles on justice system, monitoring of public services – including courts, among others. In the meantime, BIRN will continue its cooperation with CSOs working in the field of rule of law and be a vocal advocate to the issues of concern to citizens as well as legislation in Kosovo.

All of BIRN's media products are self-sustainable partly through commercial funding, public TV funding and donor funding, which should be an indicator that the project will continue beyond USAID Rule of Law project. More specifically, TV reports for *Justice in Kosovo* will remain part of a local ownership; especially since this program already exists as a part of one public institution in Kosovo - RTK with a considerable and loyal audience.
