

I. INTRODUCTION:

This Project Agreement provides for cooperation between the United States Agency for International Development, as represented by the Agency's Mission in Guyana (USAID) and the Government of Guyana (GOG) as represented by the Deputy Prime Minister, to provide selected Guyanese with the necessary international transportation, and per diem when required to permit attendance at seminars, conferences and specialized courses in disciplines not covered by existing Project Agreements.

II. BACKGROUND:

Guyanese officials, both public and private, are participating more and more in international conferences and seminars and in special training programs. This is in recognition of the leadership role that Guyana is playing in Eastern Caribbean and international affairs. Many times Guyanese officials, both public and private, are invited to seminars and conferences or offered special training opportunities which they cannot accept because appropriate funds are not budgeted or otherwise available to finance the cost of their participation, including international transportation and subsistence, e.g: a distinguished Guyanese expert in the field of rice production, representing both the public and the private sector, was invited to participate in the 70th Annual Convention of the Rice Millers Association in Puerto Rico in May 1969. Funds were not available from his parent organization to finance his transportation and per diem to attend this important conference. USAID was able to provide invitational travel orders and thus he was able to attend the conference. Another example involved attendance at the Third Pan American Congress on Engineering Education in Panama City in late 1968. There are many similar examples where the provision of international transportation and per diem have permitted Guyanese to improve their knowledge and thus play a larger role in the acceleration of Guyanese economic development. Were it not the fact that USAID provided transportation the officials could not have attended the seminars or conference. This Project Agreement is entered into to formalize and place on a more orderly basis such assistance.

III. NATURE AND SCOPE OF SERVICES:

The USAID agrees to provide during FY 1970 up to US \$12,000 to cover the cost of international transportation and, when required,

per diem for approximately 12 Guyanese drawn from the public and private sector for attendance at seminars, conferences and specialized programs. The international transportation provided will be round trip, economy class air transportation from Georgetown to the principal city where the seminar or the specialized program or conference is being held. It may also include internal transportation to other locations if such travel is germane to the main purpose of the trip. Per diem where required will be limited to a maximum of 21 days and would be in accordance with the standardized U.S. Government regulations on per diem. When approved in advance conference or seminar related expenses may be reimbursed.

Travel will be effected by the issuance of invitational travel orders by USAID/Guyana, and the Government of Guyana will use its good offices to facilitate the proposed trip including the issuance of passports and other travel documents and granting permission for the traveller to take necessary currencies with him for his own personal use.

IV. FUNDING REQUIREMENTS:

A. U.S. Contribution

The USAID will provide up to \$12,000 to finance the specific services described in Section II of this Agreement.

B. GOG Contribution

The Government of Guyana will facilitate the issuance of necessary travel documents and currencies as are required.

V. SCHEDULE AND UTILIZATION:

It is anticipated that about 12 Guyanese from both the public and private sectors will be provided with travel and, as required, per diem through the issuance of the invitational travel orders under this Project Agreement on the basis of roughly three such persons each quarter of the U.S. Fiscal Year which begins on July 1 of a particular year and ends June 30, the following year. The selection of persons to be provided travel and per diem under this agreement will be made by the Director/USAID and the Deputy Prime Minister.

I. DESCRIPTION

This Project Agreement provides for continued cooperation between the United States Agency for International Development, as represented by the Agency's Mission in Guyana (USAID) and the Government of Guyana (GOG) as represented by the Minister of Finance, to provide commodity and contractual assistance to selected self-help sub-projects through June 30, 1972. The sub-projects to be assisted under this project are to be selected by the Minister of Finance and the Director of USAID. The commodity or contractual assistance provided by the USAID to a single sub-project will not exceed U.S.\$ 5,000. The sub-projects themselves may involve any field of activity not specifically prohibited under AID regulations. The governing criteria for selection will be as follows: (1) the degree of participation by self-helpers, in the form of labor or additional commodities; and (2) the economic and social benefit to be derived. Each sub-project will be implemented by appropriate work orders or purchase orders.

II. FUNDING

A. U.S. Contribution

The USAID will provide up to U.S.\$ 25,000 to finance the specific services described in Part I of the Agreement.

B. GOG Contribution

While the GOG may or may not make specific contributions to the sub-projects there should be a considerable self-help input as described in Part I of this Agreement.
