ACTION MEMORANDUM FOR THE ACTING ASSISTANT ADMINISTRATOR (LAC)

SUBJECT: Increase in Authorization for RDO/C Basic Human
Needs Employment Sector Project (538-0030)

Discussion: The Basic Human Needs Employment Sector Project was originally authorized in FY 79 at the \$10.0 million level of which \$7.7 million was obligated in FY 79 and \$2.3 million was to be obligated in FY 80. The project was designed to address the dual problems of unemployment and the expansion and rehabilitation of essential public infrastructure in the LDCs of the Eastern Caribbean. Due to the interest shown in this project among the LDCs and the magnitude of the unemployment problem, an additional \$2.5 million in grant funds is proposed to increase the FY 1980 funding level to \$4.8 million and the life of project funding to \$12.5 million.

The \$2.3 million originally proposed for FY 80 is to be taken from a reprogramming of AID funds. The reprogramming is being done at the request of the President. The proposed additional \$2.5 million is being taken from the Mission's OYB.

The RDO/C has prepared an amendment to the project agreement and will sign the amendment with the Caribbean Development Bank as soon as we inform them of the increase in the authorization. The Congressional Notification waiting period for this increase expired on November 21, 1979.

Recommendation: That you sign the attached authorization amendment.

Pursuant to the authority vested in me as Assistant Administrator, Bureau for Latin America and the Caribbean, by the Foreign Assistance Act of 1961, as amended, and the delegations of authority issued thereunder, I hereby amend the Project Authorization and Request for Allotment of Funds, dated August 24, 1979, and as amended on September 28, 1979 ("PAF"), which authorized a Loan and a Grant to the Caribbean Development Bank ("CDB"), as follows:

1. By deleting the words "Ten Million United States Dollars (\$10,000,000)" in lines 2 and 3 of paragraph 3 and substituting therefor the words "Twelve Million Five Hundred Thousand United States Dollars (\$12,500,000)."
2. By deleting the figure "\$8,000,000" in line 4 of paragraph 3 and substituting therefor "\$10,500,000."
3. By deleting the words "Two Million Three Hundred Seventy-Five Thousand United States Dollars (\$2,375,000)" in lines 8 and 9 of paragraph 3 and substituting therefor the words "Four Million Eight Hundred Seventy-Five Thousand United States Dollars (\$4,875,000)."
4. Except as expressly modified hereby, the PAF remains in full force and effect.
