AMENDMENT NUMBER ONE

Date: November 18, 1980

Between

The United Republic of Tanzania ("Grantee")

And

The United States of America, acting through the Agency for International Development ("A.I.D.").

Article 1: The Agreement

The purpose of this Amendment is to set out the understanding of the parties named above ("Parties") with respect to provisions of an additional contribution to the costs of the project.

Article 3 Section 3.1 and Annex 1, Section V are modified as indicated below. All other provisions and conditions of Grant Agreement No. 80-07 dated August 29, 1980, remain the same.

Article 3: Financing

Section 3.1: The Grant

To assist the Grantee meet the costs of carrying out the project, AID, pursuant to the Foreign Assistance Act of 1961 as amended, agrees to grant to the Grantee, under the terms of this agreement, a final tranche of fund not to exceed one million three hundred forty five thousand ("U.S.") dollars (\$1,345,000) ("Grant"). It is understood that the present grant, when added to prior increments under this project, brings the total AID grant contributions to eight million four hundred ninety six thousand ("U.S.") dollars (\$8,496,000) ("Grant"). The Grant may be used to finance foreign exchange costs, as defined in Section 6.1 and local currency costs, as defined in Section 6.2 of goods and services required for the project. This final increment will increase A.I.D.'s total contribution to the project to an amount not to exceed eight million, four hundred ninety six thousand ("U.S.") dollars (\$8,496,000) ("Grant").

An illustrative financial plan incorporating the funds added by this amendment is attached hereto as Annex 1.

IN WITNESS WHEREOF, the Grantee and the United States of America, each acting through its duly authorized representative, have caused this Agreement Amendment.
