Dear Ms. Goodin:

I am pleased to advise you that, on behalf of the Agency for International Development (A.I.D.), and given the satisfaction of the Conditions Precedent to disbursement set forth in the original agreement dated March 1, 1984, I hereby authorize Amendment No. 1 to the subject Grant to the Overseas Education Fund, OEF, (the "Grantee") to provide an additional \$73,000 to fund project activities during the first year of the project, and to arrange for the provision of L300,000 of local currency made available by the Government of Honduras and A.I.D. under the Economic Recovery Program No. 522-0230, to provide support for the project.

Attachment E to the original Agreement is hereby amended to include:

"Payment Procedures for AID/GOH Resources

1. Proper documentation should be maintained for the GOH local currency resources generated by the Economic Recovery Program No. 522-0230. It is the responsibility of the Grantee to keep separate and adequate records pertaining to expenditure of these funds in accordance with generally accepted accounting principles. Supporting documentation for the GOH resources does not have to be submitted to A.I.D., but must be maintained for a period of three years after the final disbursement is made under this Grant. A.I.D. and the GOH reserve the right to audit or inspect the files in reference to ensure that funds are being used for eligible costs as defined in the Grant Agreement.

2. The Grantee shall submit quarterly to A.I.D. a cumulative detailed report of disbursements by budget line item."


Except as specified above, the project description and all terms and conditions set forth in the original Grant Agreement shall remain in full force and effect. This Amendment is effective as of the date of this letter.
