1. THERE WERE NO DESIGN DOCUMENTS PER SE FOR THE TWO PROJECTS LISTED IN PARA 3 OF REFTEL. AS REQUESTED PARA 2 REFTEL, THERE FOLLOWS A DESCRIPTION OF THE PURPOSES OF THESE TWO PROJECTS:

A. SMALL PROJECT ASSISTANCE/PC 664-0330

THE PURPOSE OF THIS PROJECT IS TO DEVELOP AND MANAGE SMALL VILLAGE LEVEL ACTIVITIES, THEREBY ENCOURAGING AND SUPPORTING SELF HELP EFFORTS BY LOCAL COMMUNITIES. THE PROJECT IS IN COOPERATION WITH THE PEACE CORPS AND INDIVIDUAL ACTIVITIES ARE IMPLEMENTED BY PEACE CORPS VOLUNTEERS.

B. LEGAL RIGHTS FOR WOMEN I (OPG) 664-0335 (COMPLETED)

THE PURPOSE OF THE PROJECT WAS TO OBTAIN A BETTER UNDERSTANDING OF FACTORS AFFECTING WOMEN'S RIGHTS IN TUNISIA AND TO DISSEMINATE INFORMATION CONCERNING SUCH RIGHTS. THE PROJECT WAS DESIGNED TO COVER THE FOLLOWING AFCJ (TUNISIAN FEDERATION OF WOMEN JURISTS) ACTIVITIES:

1. DEVELOPMENT, PUBLICATION AND DISSEMINATION OF A QUESTION-AND ANSWER (Q AND A) GUIDE ON THE RIGHTS OF WOMEN IN TUNISIA
2. CONDUCT OF PUBLIC DISCUSSIONS, SEMINARS AND CONFERENCES
3. STUDIES OF LAWS AFFECTING RIGHTS OF WOMEN
4. STATISTICAL RESEARCH AND ANALYSIS.

2. MISSION POLICY HAS BEEN AND CONTINUES TO BE THAT OF KEEPING AID/W PROJECT SUPPORT OFFICER (S) AND REGIONAL BUREAU INFORMED OF THE VARIOUS DOCUMENTS ISSUED FOR OUR PROGRAM.
