


In accordance with the original PASA signed in August 1983 between Peace Corps/Niger and USAID/Niger, AID agrees to finance small village level activities that Peace Corps will develop and manage in areas of concentration outlined under the MOU signed by Peace Corps/Washington and AID/Washington on January 28, 1983 as revised as of December 12, 1985 and to encourage and support self-help efforts by local communities

13. GOVERNING PROVISIONS: PURSUANT TO THE GENERAL AGREEMENT DATED August 1983 BETWEEN AID AND THE Peace Corps/Niger, THE AGENCY NAMED ABOVE AGREES TO PROVIDE THE SERVICES OUTLINED IN BLOCK 12 AMPLIFIED AS NEEDED BY APPENDIX A UNLESS OTHERWISE AUTHORIZED BY AID. ALL SERVICES SHALL BE OF U.S. ORIGIN. ANY APPENDICES ATTACHED HERETO ARE CONSIDERED PART OF THIS PASA.
