Fisheries Treaty Program assistance supports economic development purposes as provided under Part I of Schedule 2 of Annex II of the Treaty on Fisheries Between the Governments of Certain Pacific Island States and the Government of the United States of America, and the related agreement between the United States of America and the South Pacific Forum Fisheries Agency, both signed at Port Moresby, Papua New Guinea on April 2, 1987.

The Assistant Administrator, Bureau for Asia and Near East, authorized the Program Assistance Approval Document (PAAD) for the South Pacific Regional Fisheries Treaty Program June 13, 1988 and a second PAAD on May 11, 1989. Both PAADs involved planned obligations of not to exceed \$50,000,000, subject to the availability of funds, with \$10,000,000 available for FY 1988 and \$10,000,000 available for FY 1989.

Pursuant to Section 531 of the Foreign Assistance Act of 1961, as amended, I hereby authorize \$10,000,000 to be available for the Fisheries Treaty Program in FY 1990. All other terms and conditions of the PAADs authorized June 13, 1988 and May 11, 1989 remain in effect.

The program and project agreements which may be negotiated and executed by the officers to whom such authority is delegated in accordance with A.I.D. regulations and Delegations of Authority shall contain terms and conditions consistent with this PAAD and the PAADs authorized May 11, 1989 and June 13, 1988.
