

INTRODUCTION

During this reporting period, INTRAH initiated PAC-IIb family planning training development efforts in Uganda, Cape Verde, Kenya, Côte d'Ivoire and Tanzania and laid groundwork for new activities in Cameroon, Rwanda, Niger and Burkina Faso.

With financial support from ST/POP/IT, several USAID missions and REDSO/WCA, INTRAH also continued to build on its nearly twelve years of PAC training assistance to African public and private sector family planning agencies. Several activities which have taken place in the past six months deserve special mention:

- As the USAID bilateral family planning project approaches start-up in Tanzania, INTRAH's Regional Office in Nairobi has already initiated a working relationship with the Ministry of Health and the UNFPA Representatives there. INTRAH is working to strengthen the impact of combined donor resources by helping to link the service provider training needs to be served by the USAID bilateral with those identified by the UNFPA-funded national family planning project.
- After a five-year absence, INTRAH has returned to Cameroon at the invitation of the USAID mission and the Ministry of Public Health. INTRAH/Lomé's February-March needs assessment in Cameroon created the basis for a training development strategy that will support the country's new initiative to dramatically expand the delivery of integrated family planning/maternal-child health services.
- INTRAH/Nairobi is providing technical assistance to the MCH/FP training and service delivery units of Chogoria Hospital, a Kenya NGO, to expand Chogoria's capacity to train both local and international service providers. Following the model used successfully in the Philippines in PAC-IIa, INTRAH will help Chogoria personnel build the curriculum, training skills and clinical service techniques so that Chogoria can more effectively serve its own constituents and programs in other countries as well.

 In both Uganda and Burkina Faso, INTRAH has helped to build strong and effective national teams of skilled family planning trainers. Those teams have become their governments' central resources for training in family planning projects sponsored by other A.I.D. Cooperating Agencies and other donors. INTRAH is returning to both countries to assist the training teams in national efforts to decentralize training as a means to accelerate service delivery in previously unserved and underserved areas of their countries.

Continuity in technical assistance and cooperation strengthens development partnerships and serves the goal of institutionalization. INTRAH always enjoys responding to new opportunities to help build family planning service capacities through training. But it's also gratifying to work with "old" partners as they flourish, grow and mature into sustainable family planning training resources for their countries and the region.

HIGHLIGHT

A highlight of PAC-IIb activity in Africa during this reporting period has been the documentation of the positive impact of training assistance on family planning service delivery. A review of PAC-IIa final project evaluations and of studies conducted by other CAs confirms that strengthening host country institutional capacities to train service providers and supervisors is a key factor in expanding service availability, attracting new acceptors and retaining users of family planning services. Some examples:

- Two years after the conclusion of an INTRAH-assisted project to train new provider personnel in Niger, a USAID evaluation documented the successful operation of 41 new family planning service delivery sites staffed by 60 skilled INTRAH-trained providers.
- In Burkina Faso, the INTRAH and the MOPH's national training team used six Ouagadougou clinics as clinical training sites. A later study by another assistance organization showed a 125% increase in the utilization of MCH/FP services at those clinics.
- A field evaluation of the impact of INTRAH's work to develop the Uganda Core Training Team documented a 21% increase in new acceptors and a 75% increase in continuing users of family planning services at the trainees' work sites.

It has traditionally been difficult to track the impact of training on improvements in family planning programs beyond the improved technical performance of individual trainees. So it is particularly gratifying to note facts and figures that document the central value of training in the overall effort to develop, expand and institutionalize family planning services.

INTRAH PUBLICATIONS

In PAC IIb, INTRAH supports the development of two types of materials: prototypes or generic materials and country or region-specific training materials. The prototypes are designed with adaptation potential in mind. Adaptations of INTRAH prototypes include the Bangladesh *Quality Assurance Manual*, which was adapted from the INTRAH *Guidelines for Clinical Procedures in Family Planning and Sexually Transmitted Diseases*, and the translation in Egyptian Arabic of the INTRAH TIP: *Sterilization, Disinfection, Decontamination and Cleaning of FP/MCH Clinic Equipment*, published in 1989. The texts which accompany the annual INTRAH Trainers' Calendar have been used as trainer and trainee reference materials in Uganda, Botswana, Somalia, Burkina Faso and Togo, and at regional workshops and meetings in Thailand, Sri Lanka, the Philippines, Kenya, Burkina Faso and Togo.

Two examples of generic materials were produced during this report period. An INTRAH TIP, the *List of Free Materials in Family Planning/Maternal and Child Health*, 4th edition, is a compilation of more than 260 informational and reference documents in English and French, available free of charge to persons in developing countries. The List was sent to 1800 persons and institutions. Numerous requests have been received for additional copies, confirming the usefulness and relevance of this publication to health and family planning professionals and training institutions throughout the world. INTRAH welcomes information about free materials for inclusion in the next edition.

In December 1990, 1000 copies of the 1991 INTRAH Calendar for Trainers were sent to training, service and international assistance agencies. The theme of the calendar is: *Preventing Accidental Infection in the Clinic/Comment prévenir las infections accidentelles dans les centres de santé*. The 1991 calendar, like its predecessors, is designed to be used as a reference booklet as well as a calendar. User feedback and additional requests indicate that the calendar content is timely, useful and highly appreciated as a reference and training resource.

QUANTITATIVE SUMMARY

From September 25, 1989 to March 31, 1991, INTRAH supported 337 formula trainees (229 individual trainees) of the PAC IIb target of 15,000 during 1,825 trainee days of first generation training activities. Participants from 9 African countries attended 18 training activities: 12 in-country, 1 regional, 2 third country and 3 U.S.-based training activities. Regional, U.S.-based and third country training accounted for 20 trainees and 194 trainee days.

INTRAH assistance was provided in 14 of the 18 PAC IIb target countries: Botswana, Burkina Faso, Cameroon, Cape Verde, Chad, Côte d'Ivoire, Kenya, Madagascar, Niger, Rwanda, Tanzania, Togo, Uganda and Zaire. INTRAH worked with 17 host country institutions -- Botswana MOH, Burkina Faso MOH, Cameroon MOH, Cape Verde MOH, Côte d'Ivoire MOH, Côte d'Ivoire AIBEF, Kenya DFH, Madagascar MOH, Niger MOH, Rwanda ONAPO, Tanzania MOH, Togo MOH, Togo ATBEF, Uganda MOH, Zaire AZBEF and Zaire PSND -- and assisted 1 third-country institution.



TRAINING AND TECHNICAL ASSISTANCE

II. ANGLOPHONE AFRICA

A. IN-COUNTRY ACTIVITIES

During the third semi-annual reporting period of PAC IIb, the anglophone Africa program provided training and/or technical assistance in Kenya, Uganda and Tanzania and coordinated training, technical assistance and/or training plans with AVSC, SEATS, Population Council, Mothercare, PATH, UNFPA, USAID in Kenya, Uganda and Tanzania, REDSO/ESA, the Kenya Red Cross Society, the Kenya Museums, and the Chogoria Community Health Department.

The **Uganda** MOH-INTRAH three-year training project began during this report period: a subcontract was negotiated in October 1990, two national training team nurse/trainers were trained at Chogoria in October, and four Ministry of Health senior managers visited Chogoria in January to study possible applications for Uganda. The training project was inaugurated in March 1991 by a Start-Up Workshop facilitated by INTRAH and Training Resources Group (an INTRAH subcontractor) and attended by 47 representatives of ministries, NGO's and donor assistance agencies. The Start-Up Workshop was followed by a Team Building Workshop for the training team. The project is funded through a buy-in from USAID/Uganda.

INTRAH assistance to the UNFPA-funded family planning training project in **Tanzania** was planned during this reporting period. INTRAH staff in Nairobi worked with staff of the National Family Program and UNFPA to prepare a training plan that will result in regional training capacity and capability for training in family planning, which is intended to accelerate service availability. INTRAH has also discussed participation in the USAID/Tanzania-funded bilateral project with REDSO/ESA and the incoming Population Officer for USAID/Tanzania.

In Kenya, INTRAH worked with training staff of the Division of Family Health/Ministry of Health to review the results of INTRAH's annual, two-week training assistance to the DFH during PAC IIa, and the recommendations of the recentlyreleased USAID training evaluation of the DFH. In connection with the evaluation report, INTRAH furnished USAID with copies of 5 curricula used during INTRAH workshops for the DFH during 1985-89, in order to correct a factual error or impression, which appeared in the report. The INTRAH-DFH meetings during January resulted in an inventory of training needs and a three-year training plan, upon which the DFH can base requests for training, technical and financial assistance.

INTRAH, Population Council/Nairobi and PATH/Nairobi worked on preparation of a follow-up design and follow-up instrumentation for assessment of NORPLANT®

training, recently conducted in Nairobi by Kenyans for Kenyans, and funded by the Population Council. The assessment will be completed in March 1991. INTRAH provided a technical review of training curricula to be used in the Population Councilsponsored project in Tanzania, at the request of the project director, a former INTRAHtrained nurse/trainer at UMATI.

Collaboration with PATH on training materials and curricula and with AVSC on training curricula was discussed during this report period.

Planning for the anglophone Technical Advisory Committee meeting to be held in April, identification of the contents and preparation of a distribution and evaluation plan for Trainers' and Clinicians' Resource Collections, discussion of data applications for evaluation, and preparation and publication of an article in <u>Africa Health</u> were collaboratively undertaken with the INTRAH/Chapel Hill staff.

During the next report period, the anglophone program will provide training, technical and/or financial assistance in Kenya, Uganda and Tanzania.

<u>Kenya</u>

April - May 1991: INTRAH and the DFH will develop a training assistance schedule to strengthen DFH training section cabability.

INTRAH/Nairobi will provide guidance to the Chogoria Community Health Department in formulation of family planning client management protocols.

<u>Uganda</u>

From April - June 1991 INTRAH will provide assistance to Uganda MCH/FP Division of the Ministry of Health in formulation of family planning service policy guidelines and standards.

Program for International Training in Health

From July 15 - August 2, 1991, INTRAH will provide assistance to the Ugandan master training team in development of a clinical FP update and preceptorship skills curriculum and training materials. The curriculum will be implemented from August 5 - 24, 1991.

FP/MH basic and comprehensive clinical curricula and training materials will be developed with INTRAH assistance from September 9 - October 4, 1991.

INTRAH/Nairobi will re-negotiate with ZNFPC between March 22 - June 30, 1991 for:

- a. the study visit for 4 senior MOH project officers which was cancelled due to travel restrictions during January/February 1991.
- b. placement of 4 Ugandan FP trainers in the ZNFPC comprehensive FP clinical skills training.

INTRAH/Nairobi will place a Resident Clinical Consultant in Uganda as per the project agreement.

Tanzania

Between April and September INTRAH will undertake project development activities under the USAID/Government of Tanzania bilateral project. INTRAH and UNFPA will collaborate in development of family planning service protocols, service procedure manuals, and trainers guides during the period April - September 1991.

B. REGIONAL ACTIVITIES

INTRAH/Nairobi will conduct the 1991 Anglophone Technical Advisory Committee meeting, April 15 - 19, 1991, in Nairobi. Dr. V.N. Ngconcgco, WHO staff, will co-facilitate the meeting with INTRAH Deputy Regional Director for Anglophone Africa Jedida Wachira and INTRAH Deputy Director Lynn Knauff. INTRAH Director Dr. James W. Lea will also attend. INTRAH/Nairobi held a three day staff retreat, November 6 - November 8, in order to develop a common understanding of conflict and conflict management styles, to review and discuss RO/N accomplishments and limitations since April 1990, and review the INTRAH FY 1991 workplan.

USAID/Kenya Population Officer David Oot held a semi-annual meeting of Nairobi-based CAs on November 7. Attending organizations -- including INTRAH, AVSC, PSI, Thunder and Associates, JSI, Pop Council, SEATS, FPMD and Pathfinder Fund -- reported on their activities in Kenya.

INTRAH Consultant Stembile Matatu provided assistance to INTRAH/Nairobi, November 10 - November 21, in developing a list for two types of Trainers' Reference Libraries.

On November 13 INTRAH Deputy Regional Director Jedida Wachira represented INTRAH at a meeting for NGOs called by the Kenya AIDS Control Program of the MOH for the purposes of coordinating NGO in-country AIDS activities and seeking NGO contributions to the Kenya World AIDS Day activities. INTRAH donated 100 1991 appointment calendars on "Preventing Accidental Infection in the Clinic" for distribution to health workers as INTRAH's contribution to the World AIDS Day in Kenya.

At the request of AVSC, Clinical Program Officer Grace Mtawali attended an AVSC workshop, "Involving Men in FP and Vasectomy Initiatives," in Nairobi on November 14.

Mrs. Lydia Cege, Head of the Training Division of the DFH, formally requested that INTRAH conduct a 3 week management course for 25 DFH and DTC trainers in September 1991.

<u>Tanzania</u>

Anglophone Regional Director Pauline Muhuhu, at the request of the MOH, visited Dar es Salaam November 12 - November 14 to work with the MOH and UNFPA in developing a project for the training of service providers in 4 urban areas. Miss Muhuhu provided assistance in developing an activity workplan for 150 service providers and supervisors in 50 service sites. The project objectives and the MOH training plan were left in-country with USAID/Tanzania Health and Population Officer Dallas Voran. The workplan was also sent to Dana Vogel in Bangladesh who will replace Dallas Voran as the Health and Population Officer in January 1991.

INTRAH Anglophone Regional Director Pauline Muhuhu met on November 2 with REDSO/ESA Population and Health Officer Ms. Margaret Neuse who briefed Miss Muhuhu on Madagascar and Tanzania. INTRAH Clinical Program Officer Grace Mtawali, Anglophone Regional Director Pauline Muhuhu, INTRAH Clinical Officer Dr. Marcia Angle and INTRAH Director Dr. James W. Lea were the authors of the lead article, "Pregnancy Diagnosis and Contraception," in the November issue of <u>Africa Health</u>.

January 1991

<u>Kenya</u>

On January 11 and January 15, Anglophone Regional Director Pauline Muhuhu and Deputy Regional Director Jedida Wachira met with Mrs. Lydia Cege, Head of the DFH Training Unit, and Mrs. Charity Nkonge, Head of the DFH Training Materials Section, to review documentation of needs and recommendations made to the Unit. Additional meetings were held on January 24 and January 30 with Mrs. Cege, Mrs. Nkonge and Mrs. Martha Warratho, Head of the DFH Evaluation/Supervision Section, to review DFH expectations of the three sections and training and other needs relevant to the expectations. An action plan was prepared.

On January 9 discussions were held at RO/N with Dr. Colin Fischbacher, Director of the Community Health Department in Chogoria, to finalize arrangements for the Ugandan study tour.

INTRAH Consultant Mrs. Stembile Matatu conducted a review of clinical and training skills material, January 7 - February 28, in Nairobi, as well as formulating a prototype clinical curriculum.

<u>Tanzania</u>

Anglophone Regional Director Pauline Muhuhu and Deputy Regional Director Jedida Wachira met in Nairobi on January 9 with Ms. Dana Vogel, newly appointed Health and Population Officer for USAID/Tanzania, and Mrs. Angela Franklin-Lord, Program Assistant for REDSO/ESA, to discuss INTRAH's training and technical assistance activities in Tanzania.

At the request of Mrs. Eliseba Delem, Pop Council's Tanzania Training Coordinator, Pop Council/Nairobi asked that INTRAH review the clinical curriculum for Pop Council's occupational health project in Tanzania.

<u>Uganda</u>

An Ugandan study tour team (Dr. Florence O. Ebanyat, Assistant Director of Medical Services, MCH/FP Division, Dr. Osiga-Gamba, District Medical Officer, Mrs. Martha Bekiita, District Health Visitor, and Mrs. Rachael Rushota, INTRAH Training Coordinator), accompanied by INTRAH Deputy Regional Director for Anglophone Africa Jedida Wachira, visited the DFH in Nairobi, Clinic #66 at Kenyatta Hospital, the Embu District Hospital, the Kianjokma Health Centre in Embu and the Chogoria, Kenya Community Health Program, January 27 -February 2, 1991, to examine the existing linkages between pre-service and inservice training and service systems and increase insights in planning various components of an integrated FP/MCH program. The team briefed with INTRAH Anglophone Regional Director Pauline Muhuhu and Mrs. Wachira in Nairobi on January 27 and visited a Kenya DFH clinic on January 28. The scheduled visit by the Ugandan team to Zimbabwe was postponed due to A.I.D. travel restrictions.

Until an INTRAH Resident Consultant is present in Uganda, RO/N is holding weekly telecons with Mrs. Rachael Rushota, INTRAH Project Training Coordinator for update purposes.

<u>Other</u>

On January 29, AVSC Deputy Regional Director Karen Blythe held a consultation with INTRAH Anglophone Regional Director Pauline Muhuhu on INTRAH's participation in an AVSC-sponsored Anglophone Advanced TOT and Quality Assurance Workshop to be held in Mombasa, August 5 - 16, 1991.

February 1991

<u>Kenya</u>

From February 5 - 11, Anglophone Clinical Program Officer Grace Mtawali was an observer during NORPLANT training of Kenyan physicians and nurses, cosponsored by the Population Council and the Department of OB/GYN at the University of Nairobi's Kenyatta Medical Centre. INTRAH/Nairobi met with the Population Council and PATH about Mrs. Mtawali's participation in a follow-up performance assessment of the Kenyan trainees to evaluate their application of skills, protocols and standards of service taught in the workshop and to assess the impact of counseling training on client acceptance and continuation of the method.

INTRAH/Nairobi also met with Ms. Lynn Cogswell, PATH/Nairobi Associate Program Officer, about possible collaboration between INTRAH and PATH, particularly in the area of curriculum development.

Kenya Museums asked for INTRAH/Nairobi assistance in developing a proposal for IEC in family planning for an exhibit in the museum in Nairobi. Anglophone Regional Director Pauline Muhuhu met with Museum staff on February 21 to discuss the project. Anglophone Clinical Program Officer Grace Mtawali represented INTRAH at another meeting of the committee on February 26.

Miss Muhuhu attended a meeting of CAs working in Kenya, held by USAID on February 7, to discuss registration of NGOs in Kenya. Representatives from the

Population Council, AVSC, Pathfinder, PATH, Pritech, MIHV, FPPS and World Visions attended. INTRAH/Nairobi also attended a meeting funded by Ford and UNDP to discuss NGOs' status in Kenya.

A.I.D. informed USAID/Botswana, USAID/The Gambia, USAID/Kenya, USAID/Mozambique, USAID/Namibia, USAID/Tanzania, USAID/Uganda and USAID Zimbabwe of the INTRAH 1991 Anglophone Technical Advisory Committee (TAC) Meeting for MCH/FP or FP Directors and FP Training Coordinators, April 15 - 19, in Nairobi, and requested nominations for TAC meeting participants.

<u>Tanzania</u>

From February 11 - 12, Anglophone Regional Director Pauline Muhuhu and Deputy Regional Director Jedida Wachira met in Arusha with MOH and UNFPA representatives to discuss INTRAH's potential role in the UNFPA-assisted family planning project and a changed training strategy, which will result in capability and capacity at the regional level.

Miss Muhuhu and Mrs. Wachira also met with Ms. Dana Vogel, Health and Population Officer for USAID/Tanzania, and Ms. Margaret Neuse, REDSO/ESA Population Officer, to discuss INTRAH's potential role in the USAID/Tanzania bilateral project. Ms. Neuse and Ms. Vogel asked that INTRAH write a concept paper showing how UNFPA and USAID training inputs could complement each other in the context of institution-building.

<u>Uganda</u>

February 24 - March 1, Anglophone Deputy Regional Director Jedida Wachira and Mr. Lee Jennings, TRG Consultant, were in Uganda to plan for the Start-Up Workshop, March 4 - 8, activity #2 in the Uganda MOH/INTRAH subcontract.

<u>Other</u>

On February 3, Anglophone Regional Director Pauline Muhuhu met with Dr. Magagwa, on sabbatical as the Director of ZNFPC, a World Bank consultant on population and manpower.

March 1991

<u>Kenya</u>

On March 1 and March 4, INTRAH Clinical Program Officer Grace Mtawali met with Ms. Lynn Cogswell, PATH/Nairobi Associate Program Officer, and Ms. Martha Brady, PATH/Nairobi Staff Associate to re-define the purpose, objectives, scope of work and roles of the NORPLANT Counselling Study in which Mrs. Mtawali will participate.

On March 25, INTRAH/Nairobi developed a plan (including the purpose, objectives and outlined activities) for INTRAH technical assistance to the

Chogoria Community Health Department, at the request of Chogoria. The plan will be discussed with Chogoria on April 3.

<u>Tanzania</u>

On March 4, two curricula on FP Clinical and Communication skills were returned to Pop Council/Nairobi after having been reviewed and suggestions made by INTRAH/Nairobi at the request of Mrs. Eliseba Delem, Pop Council's Tanzania Training Coordinator.

Uganda

Anglophone Deputy Regional Director Jedida Wachira and TRG Consultant Lee Jennings conducted a Start-Up Workshop for 47 representatives of ministries, NGO's and donor assistance agencies, March 4 - 8. The workshop marked the start of the MOH/INTRAH 3-year project in the Western Region to train districtlevel trainers along with supervisors and service providers who will staff new FP service delivery points. The participants discussed the project's rationale, objectives and methods and resolved major implementation issues. The project is funded through a buy-in from USAID/Uganda.

From March 13 - 15, Mrs. Wachira and INTRAH Anglophone Regional Director Pauline Muhuhu conducted a Team Building Workshop for 8 MOH staff involved in the Uganda MOH/INTRAH training project. The workshop was designed to strengthen relationships among the team members responsible for implementing the training project.

Miss Muhuhu met with Dr. Florence Ebanyat, ADMS, and Mrs. Rachael Rushota, INTRAH Training Coordinator, to discuss project implementation, March 18 and 19, and worked with Mrs. Rushota to prepare a draft job description or the Training Coordinator. Miss Muhuhu also provided written guidelines for reviewing documents for upcoming activities. Mrs. Wachira provided additional written guidelines to Mrs. Rushota on March 27.



III. FRANCOPHONE AFRICA

A. IN-COUNTRY ACTIVITIES

During the third semi-annual reporting period of PAC IIb, INTRAH provided technical and/or training assistance in 7 francophone and lusophone countries: Burkina Faso, Cameroon, Cape Verde, Cote d'Ivoire, Madagascar, Niger and Rwanda, and continued discussions for project start-ups in Togo and Zaire.

In **Burkina Faso**, a clinical training needs assessment and clinic site inventory in the 15 provinces covered by the USAID-supported bilateral MCH/FP/nutrition project were conducted in October/November 1990. Based on the findings and recommendations, a 2 1/2 year training project proposal for INTRAH assistance was prepared by a MOHSA/INTRAH/USAID team in December 1990; a PCS representative joined the proposal writing team to coordinate INTRAH/PCS activities in Burkina. In March 1991 a visit was made to finalize the first-year training schedule. It is expected that approximately two-thirds of INTRAH's support to Burkina will be funded through buy-ins from USAID/Burkina Faso.

At the request of USAID/Cameroon, a planning visit and a clinical needs assessment and clinic inventory of 17 MCH centers were conducted. INTRAH support to **Cameroon** will be funded through a buy-in.

An INTRAH-assisted National FP Seminar was held in **Cape Verde** for 14 health delegates and physicians responsible for MCH/FP activities, and MOH/L/SA policy makers for the purposes of creating awareness and informing participants about FP as an MCH intervention and soliciting their ideas about integrating FP into ongoing MCH services. The seminar was funded by a REDSO/WCA buy-in. Subsequently, a MOH/L/SA committee established during the seminar prepared a draft FP service policy and service standards document to guide training and service delivery, and submitted it for review by INTRAH. A PIO/T for a second REDSO/WCA buy-in for the first year of INTRAH's proposed assistance to the MCH/FP program was sent to A.I.D. in September 1990. However, A.I.D. has postponed action on the PIO/T pending clarification of questions cabled to USAID/Cape Verde in January 1991.

Supported by a REDSO/WCA buy-in, a clinical FP refresher and orientation to precepting techniques workshop was conducted in **Côte d'Ivoire** for 11 AIBEF and MOPH/SP service providers. At the request of REDSO/WCA, work sessions were held with SEATS/WARO and 14 Ivoirians representing government agencies and NGOs to

prepare a strategy for the training of FP service providers in the 33 sites covered by SEATS 3-year project with AIBEF. Planning also continued for the National FP Seminar whose purposes are to build awareness of the benefits of family planning and apply the awareness to plans for the expansion of quality FP services. The seminar, scheduled for April 2-6, 1991, in Grand Bassam, will be facilitated by an INTRAH/SEATS team and supported through a buy-in from REDSO/WCA.

In **Madagascar**, INTRAH Regional Director for Francophone Africa participated on a 10 person team from March 11 - April 5 to provide the training perspective during preparations for a family planning project paper. The activity is coordinated by POPTECH. Central funds supported INTRAH's participation.

INTRAH provided technical assistance to the MOSA/PW and the MOH in Niger for the preparation of a plan for the development of an MCH/FP service policy, service standards and protocols, in the context of the USAID/Niger supported bilateral Family Health and Demography project. A buy-in from USAID/Niger is expected to support future INTRAH-assisted activities in Niger.

A training needs assessment was conducted in **Rwanda** in preparation for an INTRAH-assisted FP training project with ONAPO. Because of civil unrest in the country at the time of the visit, the assessment was limited to 3 of 11 prefectures.

In **Togo**, planning continued for the INTRAH assisted training project with the MCH Division of the MOPH, to be supported through a USAID/Togo buy-in. A project and contract development visit proposed for February 1991 was postponed due to A.I.D. travel restrictions resulting from the Gulf War, causing a delay in the start-up of project activities.

INTRAH received a request from USAID/Zaire for an INTRAH team to visit **Zaire** to discuss alternate methods to finance a planned project with PSND and finalize agreements for the start-up of a project with AZBEF.

Planning for the francophone Regional Evaluation Seminar/Workshop for directors and training coordinators of INTRAH assisted family planning projects to be held in May was collaboratively undertaken with the INTRAH/Chapel Hill Evaluation Officer.

During the next semi-annual PAC IIb reporting period, INTRAH will provide training, technical and/or financial assistance in Burkina Faso, Cameroon, Cape Verde, Cote d'Ivoire, Rwanda, Togo and Zaire.

Burkina Faso

In April 1991, the subcontract with the MOHSA will be amended and negotiations with the fiscal agent will be finalized.

From April 22-25, 1991, a Start-Up Workshop will be facilitated by INTRAH, Population Communication Services (PCS) and Training Resources Group (an INTRAH subcontractor) for 60 representatives from the central directorates of the MOHSA, including the Provincial Directors of Health and of Social Action, and the heads of MCH/FP from the 15 provinces covered by the USAID-supported bilateral project.

May - October 1991: INTRAH will provide assistance for the preparation of MCH/FP service policy, service standards and service protocols. UNICEF will provide the technical assistance for child health.

June - July 1991: The Directorate of Professional Training will conduct two training of trainers workshops for 35 new members of the Provincial Training Teams (PTT) and

two training of trainers update workshops for 34 members of the PTTs, with technical and financial assistance from INTRAH.

From August 24 - September INTRAH will sponsor five senior MOHSA MCH/FP staff for a visit to Chogoria Hospital's integrated MCH/FP/PHC program in Kenya to study possible applications for Burkina.

An inventory of needs and available resources for the development c2 a MCH curriculum will be conducted with INTRAH assistance from September 23 - October 5, 1991.

Cameroon

April - September 1991: INTRAH will undertake project and contract development with the MOPH and USAID/Cameroon, and begin project implementation. INTRAH is expected to provide assistance to the DFMH for the preparation of MCH/FP service policy, service standards and protocols, and a clinical FP curriculum, and for the training of clinical preceptors and a national team of FP trainers.

Cape Verde

May 13-17, 1991: The MOH/L/SA Director of MCH/FP will visit Togo to meet with RO/L staff for project planning and with Togolese MOPH officials involved in the preparation and dissemination of the Togo National FP Service Policy and Standards document. The visit had been scheduled for February 1991 but was postponed due to the A.I.D. travel restrictions resulting from the Gulf War.

Cote d'Ivoire

April 2-6, 1991: An INTRAH/SEATS team will facilitate a National FP Seminar, with funding through a REDSO/WCA buy-in.

Between April and September 1991, INTRAH will undertake project development activities for assistance to develop in-country clinical FP training capability and capacity.

Togo

April 1991: INTRAH and the MOPH will complete project and subcontract development and INTRAH will facilitate a Start-Up Workshop in May. A senior MOPH technical officer is expected to join INTRAH for the purpose of providing technical assistance in activating and monitoring the workplan.

From May - September INTRAH will provide assistance to the MOPH for the formulation of FP service protocols; revision of three curricula, based on expectations in the service standards and protocols; preparation of new clinical training sites, including the training of clinical preceptors; and, training of FP service supervisors.

Zaire

May 1991: At the request of USAID/Zaire, an INTRAH team will visit Zaire for the purposes of discussing implementation and management of PSND and AZBEF projects and future INTRAH assistance in Zaire, and finalizing agreements for the start-up of a project with AZBEF.

B. REGIONAL ACTIVITIES

During this reporting period, the RO/L Clinical Specialist participated in a study visit to Chogoria Community Health Department with two Ugandan nurse/trainers, October 3 - 19, 1990.

At the request of REDSO/WCA, INTRAH Regional Director for Francophone Africa, Mr. Pape Gaye, and Regional Training and Training Materials Officer, Dr. Aliou Boly, participated in an October 15-19, 1990 meeting in Abidjan, Cote d'Ivoire for Cooperating Agencies (CAs) to coordinate assistance to the Ministry of Public Health and Social Protection and AIBEF in the development of a FP program.

From November 26-28, 1990, Mr. Pape Gaye represented the Regional Office/Lomé at the annual Office of Population CAs meeting held in Washington, D.C. During the meeting Mr. Gaye met with Miss Pauline Muhuhu, INTRAH Regional Director for Anglophone Africa to discuss office coordination issues. Mr. Gaye also met with Training Resources Group (an INTRAH subcontractor) to discuss TRG involvement in Start-Up Workshops in the francophone region.

During the next reporting period, INTRAH Francophone Training and Training Materials Officer Aliou Boly and Mrs. Fatoumata Batta, National Training Coordinator at the DFP in Burkina Faso, will participate in the anglophone Technical Advisory Committee meeting, April 15 - 19, in Nairobi.

From May 21 - 28, INTRAH will conduct a francophone Regional Evaluation Seminar/Workshop in Lomé for directors and training coordinators of family planning training projects.

INTRAH/Lomé will conduct the 1991 francophone Technical Advisory Committee meeting in July 1991.

INTRAH's 1991 annual meeting will be held in Chapel Hill from August 12 - 23, 1991 with RO/L and RO/N staff members joining the Chapel Hill staff.

C. SUMMARY OF ACTIVITIES

<u>October 1990</u>

Burkina Faso

INTRAH Francophone Regional Director Pape Gaye, Francophone Evaluation and Supervision Specialist Onanga Bongwele, Francophone Clinical Specialist Djariatou Thiam and INTRAH Consultant Dr. Anne Charlotte Royer conducted a clinic needs assessment and clinical personnel training needs assessment in 14 of the 15 provinces covered by the USAID-supported bilateral MCH/FP/Nutrition project, from October 29 - November 17, 1990, in preparation for an INTRAH-assisted training project with the Ministry of Health and Social Action (MOHSA). Burkinabé team members were Mrs. Pascaline Sebgo, Head of Family Planning at the Directorate of Family Health (DSF), Ms. Marie Ouedraogo, MCH Division at the DSF, Mrs. Fatoumata Batta and Mrs. Awa Dipama, trainers at the Directorate of Professional Training (DFP), and Mr. Joanny Kaboré, an INTRAH consultant. A round table meeting was organized at the end of the assessment to share preliminary findings and recommendations with representatives from the MOHSA, USAID/Burkina Faso, the Population Council and UNFPA.

DSF Director Dr. Dider Bakouan supported the proposed December 10 - 15, 1990 activity in Lomé, for a team of two Burkinabé from the MOHSA, together with Mrs. Roxana de Sole, USAID/Burkina Faso Project Manager, to work with INTRAH/Lomé and INTRAH/Chapel Hill staff and INTRAH Consultant Mr. Joanny Kaboré to prepare a PAC IIb project proposal for INTRAH assistance. Plans were also confirmed with PCS Senior Program Officer Philippe Langlois for his December 13 - 15 participation in the proposal development activity to discuss INTRAH/PCS collaboration in Burkina Faso.

USAID/Burkina Faso informed INTRAH that the supervision visits of MCH/FP service providers by central level DSF staff, scheduled to take place March - June 1990 with financial assistance from INTRAH, were not completed.

<u>Cameroon</u>

INTRAH Director Dr. James W. Lea and Francophone Regional Director Pape Gaye finalized plans for a site visit, December 3 - 7, to discuss proposed PAC IIb assistance with USAID/Cameroon and the Ministry of Public Health (MOPH), who requested the visit.

Cape Verde

The MOH/L/SA and USAID/Cape Verde confirmed the December 1 - 5, 1990 dates for the INTRAH-assisted National FP Seminar to be held in Praia for 14 health delegates and physicians responsible for managing the MCH/FP program in the regions and in Praia.

Côte d'Ivoire

At REDSO/WCA's request, INTRAH Francophone Regional Director Pape Gaye and Training and Training Materials Officer Dr. Aliou Boly participated in a meeting for Cooperating Agencies involved in family planning in Côte d'Ivoire, October 15 - 18, 1990. INTRAH has been asked by REDSO/WCA to conduct clinical preceptors' training, work with SEATS on the National FP Seminar, and facilitate work sessions with Ivoirian MCH/FP personnel and SEATS to prepare a strategy for the training of FP service providers in the service sites to be covered by SEATS' 3-year project with AIBEF.

Togo

At the invitation of SEATS, INTRAH Francophone Evaluation and Supervision Specialist Onanga Bongwele attended the SEATS-sponsored Quality Assurance Conference, October 15 -19, in Kpalimé, as an observer. The national FP Service Policy and Service Standards document, developed with INTRAH assistance, was referred to and used as the basis for much of what was discussed.

On October 22, Peace Corps representative Mrs. Maia Ambegaokar visited RO/L to discuss a potential FP Peace Corps project in Togo. Mrs. Ambegaokar was briefed on INTRAH's work with the MCH Division of the MOPH.

INTRAH Francophone Clinical Specialist Djariatou Thiam participated in a study visit to Chogoria, Kenya, October 3 - 19, 1990, following the anglophone Regional Training Methodologies workshop.

On October 5, 1990 Francophone Evaluation and Supervision Specialist Onanga Bongwele and INTRAH Consultant Dr. Manuel Pina debriefed with SEATS/WARO Resident Advisor in Côte d'Ivoire Mr. Tharcisse Mwamba and Program Development Officer Mr. Paul Sossa on the FP clinic inventory assessment of clinicians' training needs conducted in Côte d'Ivoire, September 17 - 28, 1990.

November 1990

Cameroon

SEATS/WARO IEC Specialist M'Baya Seye discussed SEATS' proposed activities in Cameroon with Francophone Regional Director Pape Gaye in preparation for Mr. Gaye's and INTRAH Director Dr. James W. Lea's site visit to Cameroon, December 3 - December 7, 1990.

Cape Verde

INTRAH Consultants Nancy McCharen and Dr. Luis Bahamondes were in Lomé November 18 - 23 to prepare for the National FP Seminar to be held in Praia, December 1 - December 5, 1990, with financial support through a REDSO/WCA buy-in. In Praia from November 24 - 30, Dr. Bahamondes and Mrs. McCharen finalized seminar topics and content of presentations with the MOH/L/SA seminar planning committee and briefed seminar presenters and resource persons.

Côte d'Ivoire

From November 19 - December 8, INTRAH Training and Training Materials Officer Dr. Aliou Boly, INTRAH Consultant Dr. Manuel Pina and AIBEF Clinical Coordinator Mrs. Houmou Kaba conducted a Clinical FP Refresher and Preceptors' Skills workshop for 11 AIBEF and MOPH/SP service providers (10 midwives and 1 RN). The workshop was supported through a REDSO/WCA buy-in.

On November 9, Francophone Regional Director Pape Gaye met with SEATS/WARO Training Specialist Dr. Ismail Thioye to discuss the organization of work sessions in Abidjan to develop a strategy for the training of service providers in the service sites to be covered by SEATS' 3-year project with AIBEF. REDSO/WCA had requested INTRAH leadership in facilitating the training strategy development work sessions during the October 1990 meeting in Abidjan of CAs working in Côte d'Ivoire. Mr. Gaye and Mr. Thioye agreed that INTRAH and SEATS would propose work sessions in Abidjan during the week of January 7 - 12, 1990, for officials from the MOPH/SP, Ministry of Social Affairs and the Promotion of Woman, and AIBEF. Results of the sessions would then be shared by the Ivoirians, INTRAH and SEATS with Pathfinder, PCS and Population Council representatives.

<u>Niger</u>

At the request of USAID/Niger and the MOH, INTRAH Consultant Dr. Alain Fontaine visited Niamey from November 7 - 16 to discuss INTRAH assistance for the preparation of MCH/FP service policy, standards and protocols with the MOSA/PW, URC and USAID/Niger.

<u>Rwanda</u>

ONAPO Director Mrs. Gaudence Habimana requested in a letter to Mr. Pape Gaye, dated October 12 and received at INTRAH/Lomé on November 9, that the proposed January 1991 training needs assessment be moved to the fourth quarter of CY 1990. Mr. Gaye responded in a November 13 letter that INTRAH was unable to respond to this request due to the current unrest in Rwanda, but would re-schedule the visit as early as possible in CY 1991.

<u>Togo</u>

A work session with the MCH Division of the MOPH, the Ministry of Social Affairs and the Condition of Women, UNFPA, USAID and ATBEF was held at INTRAH/Lomé on November 8 to agree on a workplan for INTRAH-assisted activities with the MOPH. A training project proposal will be prepared and submitted to ST/POP for review and approval. Activities are scheduled to be underway in April 1991.

Zaire

INTRAH/Lomé received a letter from PSND in response to proposed modifications to the INTRAH/PSND workplan developed in Zaire during an August 1990 project development visit. PSND concurred with all the proposed revisions except for the supervision activities. INTRAH requested AZBEF's and USAID/Zaire's responses to the proposed revisions.

INTRAH learned in a telex sent from USAID/Zaire on November 8 and received in Chapel Hill on November 20, that the revised SOW for the PIO/T had been sent to A.I.D.; however, A.I.D. had not received it. At the INTRAH Project Monitor's request, a telex was sent to USAID/Zaire on November 26 requesting that another copy of the revised PIO/T be sent immediately to ST/POP/IT, att: Bonnie Pedersen.

December 1990

Burkina Faso

INTRAH Deputy Director Lynn Knauff and Program Officer Maureen Corbett visited Lome, Togo December 3 - 15 to work with INTRAH Francophone Regional Director Pape Gaye and Francophone Evaluation and Supervision Specialist Onanga Bongwele, Ministry c Health and Social Action of Burkina Faso Representatives Mrs. Pascaline Sebgo (Head of Family Planning at the Directorate of Family Health) and Mrs. Fatoumata Batta (National Training Coordinator at the Directorate of Professional Training), USAID/Burkina Faso Project Manager Roxana de Sole, and PCS Senior Program Officer Philippe Langlois, to develop a draft project proposal for PAC IIb assistance in Burkina Faso, based on findings and recommendations from the October/November 1990 training needs assessment and in support of the MOHSA's policy to decentralize MCH/FP training to the provincial-level. The proposal describes how the capability and capacity of 15 provincial training teams will be developed to plan, manage, conduct and evaluate MCH/FP training in order to increase the quality, quantity and accessibility of services. After the project proposal is reviewed and approved by the MOHSA, INTRAH and A.I.D., it is expected that project activities will begin in the second quarter of 1991.

Cameroon

From December 2 - 7, 1990, INTRAH Director Dr. James W. Lea and Francophone Regional Director Pape Gaye were in Cameroon, at the request of USAID/Cameroon and the MOPH to discuss possibilities for INTRAH assistance to the MOPH in the context of FHI-II project (to be supported by a buy-in) and the prospective bilateral Integrated Family Health Project. Proposed areas of INTRAH assistance will be verified and activities planned following a TNA.

On December 21, USAID/Cameroon concurrence was requested by INTRAH/Lomé for an INTRAH training needs assessment team (INTRAH Francophone Evaluation and Supervision Specialist Onanga Bongwele, INTRAH Francophone Clinical Specialist Djariatou Thiam and INTRAH Consultants Mr. Mutombo Yatshita and Dr. Manuel Pina) to travel to Cameroon, January 23 - February 13, 1991.

On December 28, INTRAH Francophone Regional Director Pape Gaye and Francophone Evaluation and Supervision Specialist Onanga Bongwele attended a meeting at SEATS' office in Lomé to discuss INTRAH and SEATS' coordination of activities in Cameroon.

Cape Verde

INTRAH Consultant Dr. Luis Bahamondes and Mrs. Nancy McCharen facilitated a National Family Planning Seminar, in Praia, December 1 - 5, for 14 physicians responsible for managing the MCH/FP program in the regions and in Praia. The purposes of the seminar were to create awareness and disseminate information among participants about FP as an MCH intervention to solicit participants' ideas about how FP services in the country should be integrated into ongoing MCH services. Funding for the seminar was provided through a REDSO/WCA buy-in.

Rwanda

On December 21, USAID/Rwanda concurrence was requested by INTRAH/Lomé for an INTRAH training needs assessment team (INTRAH Francophone Regional Director Pape Gaye, INTRAH Francophone Training and Training Materials Officer Dr. Aliou Boly, and INTRAH Consultant Dr. Penda Seck) to travel to Rwanda, January 14 - February 2, 1991.

Togo

INTRAH Evaluation Officer Constance Newman provided technical assistance to the INTRAH Regional Office/Lomé, December 3 - 10, for the preparation of a proposal for a Regional Evaluation Workshop/Seminar for directors and training coordinators of FP training projects. Ms. Newman also made recommendations on the format of training project proposal evaluation plans.

INTRAH Francophone Clinical Specialist Djariatou Thiam and INTRAH Consultant Dr. Manuel Pina attended the first seminar of the African Society of Ob/Gyns in Lomé, Togo, December 10 - 14, 1990.

January 1991

Burkina Faso

USAID/Burkina Faso was informed that travel by Francophone Regional Director Pape Gaye for a Project Development and Subcontract Amendment visit, scheduled for February 18 - 23, would not take place due to INTRAH's understanding of A.I.D. travel restrictions.

<u>Cameroon</u>

An INTRAH team (Francophone Evaluation and Supervision Specialist Onanga Bongwele, Francophone Clinical Specialist Djariatou Thiam and INTRAH Consultants Dr. Manuel Pina and Mr. Mutombo Yatshita) worked with Dr. David Awasum, Director of the Department of Family and Mental Health (DSFM), Ministry of Public Health (MOPH), and Dr. Robert Leke, Professor at the University (of Cameroon) Center for Health Sciences, to conduct an assessment of clinical training needs from January 23 - February 11. The team inventoried 17 MCH/FP service sites, of which 9 are possible clinical practicum sites. Only one site has at least half of the standard equipment suggested by the DSFM. Fifteen of the sites inventoried are under the SEATS-assisted project and are expected to be provided the full range of equipment. The team also assessed the performance of 26 clinical FP service providers, of whom 14 are potential clinical FP preceptors. Based on TNA findings and recommendations, the team proposed a plan for the development of MCH/FP service policy and standards, and practical clinical FP training sites, between now and the PACD of FHI-II (September 1991).

Although the needs assessment was to have been supported by the USAID/Cameroon buy-in to INTRAH, central funds were used to support the team's expenses because the buy-in process at A.I.D. was not completed.

Cape Verde

USAID/Cape Verde was informed that the planned travel to INTRAH/Lomé and the MOPH/Togo in February by Dr. Alice Dupret, MCH/FP Director at the MOH/L/SA, for project planning and discussion on INTRAH's approach to FP service policy development would not be possible due to INTRAH's understanding of A.I.D. travel restrictions. Ms. Nancy Nolan, REDSO/WCA Population Advisor, who was to have joined the team in Togo was also informed of the postponement.

Côte d'Ivoire

At the request of REDSO/WCA, an INTRAH team (Training and Training Materials Officer Dr. Aliou Boly, Francophone Evaluation and Supervision Specialist Onanga Bongwele and INTRAH Consultant Dr. Manuel Pina) facilitated work sessions with 3 SEATS staff and 14 Ivoirians representing government agencies and NGOs from January 7 - 12 to prepare a strategy for the training of service providers in the 33 service sites covered by SEATS' 3-year project with AIBEF. In addition to preparing a training strategy for proposed INTRAH assistance in the FP program, products of the work sessions included a project goal, project and operational objectives, a 21/2-year workplan and an evaluation plan.

REDSO/WCA, Pathfinder Fund and Population Council representatives joined the sessions to discuss funding and technical support for the FP program.

Rwanda

An INTRAH team (INTRAH Francophone Regional Director Pape Gaye, INTRAH Francophone Training and Training Materials Officer Dr. Aliou Boly, and INTRAH Consultant Dr. Penda Seck) conducted a training needs assessment in Rwanda, January 14 - February 2, 1991, in preparation for a FP training project with ONAPO (National Office of Population). Because of civil unrest in the country at the time of the visit, the TNA was limited to 3 of 11 prefectures. Eight FP service sites were inventoried (2 hospitals, 5 health centers and a public center at the University) and a performance assessment of 12 service providers was conducted.

Togo

Francophone Regional Director Pape Gaye and Training and Training Materials Officer Dr. Aliou Boly met with USAID/Lomé HPN Officer Mr. Paul Ehmer and HPN Assistant Dr. Koffi Agbékou at USAID/Lomé on January 4 to review the draft proposal of the INTRAH/DME (MCH Division of the MOPH) PAC IIb training project.

On January 9 Francophone Regional Director Pape Gaye met with Dr. Kampatibe, Acting Director for the MCH Division, to discuss the draft proposal of the INTRAH/DME PAC IIb training project.

Travel to Lomé by INTRAH Associate Director of Administration Raymond Baker for a contract development visit, February 10 - 21, was not possible due to INTRAH's understanding of A.I.D. travel restrictions.

INTRAH Francophone Clinical Specialist Djariatou Thiam was a rapporteur for a Safe Motherhood/Family Planning meeting on January 10 in Lomé, Togo, at the request of the Togo Ministry of Public Health.

<u>Niger</u>

A.I.D. informed USAID/Niger of the INTRAH-sponsored Regional Seminar/Workshop in Evaluation for Directors and Coordinators of FP training projects, May 21 - 29, in Lomé, Togo, and requested nominations for workshop participants.

<u>Rwanda</u>

A.I.D. informed USAID/Rwanda of the INTRAH-sponsored Regional Seminar/Workshop in Evaluation for Directors and Coordinators of FP training projects, May 21 - 29, in Lomé, Togo, and requested nominations for workshop participants.

Togo

Travel to Lomé by INTRAH Associate Director of Administration Raymond Baker for a project and contract development visit with the Togo MOPH and Pannell-Kerr-Forster, originally scheduled for February 10 - 21 but postponed due to INTRAH's understanding of A.I.D. travel restrictions, was re-scheduled for March 18 - 27. However, a request from USAID/Togo to ST/POP for the essential and non-deferrable travel of Mr. Baker was disapproved by ST/POP. The visit is now proposed for late April 1991.

A.I.D. informed USAID/Togo of the INTRAH-sponsored Regional Seminar/Workshop in Evaluation for Directors and Coordinators of FP training projects, May 21 - 29, in Lomé, and requested nominations for workshop participants.

<u>Zaire</u>

At the request of USAID/Zaire, INTRAH Associate Director of Administration Raymond Baker and Francophone Evaluation and Supervision Specialist Onanga Bongwele proposed a visit to Zaire in late March/early April to explore alternate methods to finance a planned project with PSND and review action required to initiate a project with AZBEF. INTRAH assistance to PSND and AZBEF will be supported by a USAID/Zaire buy-in.

A.I.D. informed USAID/Zaire of the INTRAH-sponsored Regional Seminar/Workshop in Evaluation for Directors and Coordinators of FP training projects, May 21 - 29, in Lomé, Togo, and requested nominations for workshop participants.

March 1991

Burkina Faso

INTRAH Francophone Regional Director Pape Gaye conducted a Project Development visit, March 4 - 6. Accomplishments of his visit were the confirmation of the Start-Up Workshop dates, clarification of the SUW objectives, determination of dates for first year project activities and modification of in-country budgets. Because of the absence from Burkina Faso of Mrs. Pascaline Sebgo, Head of Family Planning at the Directorate of Family Health (DSF), and the minimal availability of Dr. Didier Bakouan, Director of the DSF, Mr. Gaye was unable to reach agreement with the DSF on the descriptions of project activities, finalize the amendment to the subcontract and complete negotiations with the fiscal agent. INTRAH is disucssing with the DSF and USAID/Burkina Faso a plan to complete unfinished business in order that project activities can begin in May/June 1991. The project will be supported in part by a USAID/Burkina Faso buy-in.

Côte d'Ivoire

From March 25 - April 1, INTRAH Training and Training Materials Officer Dr. Aliou Boly and INTRAH Consultants Dr. Manuel Pina and Dr. Halima Maidouka are planning for the National Family Planing Seminar to be conducted in collaboration with SEATS, in Grand Bassam, April 2 - 6.

<u>Madagascar</u>

INTRAH Francophone Regional Director Pape Gaye joined a 10 person CA and A.I.D. team as the training specialist from March 11 - April 5 to prepare for a project paper, which will result in an RFP. The activity was requested by the USAID/Madagascar Director and is being coordinated by POPTECH. AVSC, PCS, SEATS and OPTIONS are also represented on the team. Ms. Sarah Clark, Deputy Director of ST/POP, will join the team during the last week. INTRAH central funds are supporting Mr. Gaye's participation.

Zaire

INTRAH reconsidered the team proposed in a March 1 cable from ST/POP/IT to USAID/Zaire and recommended in a March 21 telex a May 6 - 9 visit by INTRAH Director Dr. James W. Lea, Associate Director of Administration Raymond Baker and Program Officer Maureen Corbett.

On March 25, a telex retransmission of a March 14 cable to ST/POP/IT from USAID/Zaire was received. The telex acknowledged agreement with the proposed visit and outlined topics of discussion during the visit. The proposed travel is subject to current A.I.D. travel restrictions.

II. PROJECT FINDINGS: PAST SIX MONTHS (October 1, 1990 - March 31, 1991)

ACCOMPLISHMENTS:

- 1. A TWA was conducted in preparation for a PAC 11b training project with the DSF. The TWA covered 14 of the 15 provinces under the USAID/Burkina Faso supported MCH/FP/nutrition bilateral project.
- 2. A PAC IIb project proposal was developed in collaboration with the DSF, the DFP, USAID/Burkina Faso and PCS. The 3-year project will focus on developing the capability and capacity of members of the provincial training teams to plan, manage, conduct and evaluate MCH/FP training, in support of the MOHSA policy to decentralize MCH/FP training to the provinces.
- 3. A project development visit was made during which Start-up Workshop (SUW) dates were confirmed, SUW objectives were clarified, dates for the first year of project activities were determined and in-country budgets were modified. The SUW will be conducted in collaboration with PCS.

PROBLEMS ENCOUNTERED:

- The estimated costs for the proposed PAC IIb project exceeded the total available budget in the USAID/Burkina Faso buyin to INTRAH, to be incrementally funded. It is expected that the buy-in will support approximately two-thirds of the estimated project costs.
- 2. The MOHSA decision to integrate FP into on-going MCH activities nationwide (following the Columbia University sponsored OR project in Kadiogo Province) was not preceded by research in the provinces to ascertain the feasibility of integrated MCH/FP service provision. As a result, it is still not known to what extent MCH/FP integration is possible.
- 3. Despite the MOHSA's many requests, INTRAH and the Population Council were not able to coordinate their needs assessment activities in the 15 bilateral project provinces. Population Council's situational analysis will cover a sample of all 30 provinces in the country.

FINDINGS/CONCLUSIONS/RECOMMENDATIONS:

- 1. During the first project review a financial assessment should be conducted and agreements reached as to how the remaining project activities will be financed.
- 2. The decision to integrate MCH/FP services nationwide should be supported by data on the status of MCH/FP service delivery in all 30 provinces. Data from the INTRAH training needs assessment and Population Council's situational analysis, as well as data on service provider performance collected at the time of MCH/FP training and during field follow-ups, should be analyzed and interpreted for use as a basis for MOHSA decision-making about the integration policy.
- 3. INTRAH and Population Council should strengthen collaboration in the area of evaluation. Efforts should be made to coordinate future activities, including the follow-up of trained personnel in the field.

- 11) Conduct reviews of project accomplishments every six months with a formal review of field follow-up findings every year.
- 12) Provide training reference libraries to the "WE for use of the national trainers, the Family Planning Association (ATBEF), four health training professional schools and the WHO Training Center.

ACCOMPLISHMENTS:

A PAC IIb project proposal for INTRAH assistance was developed in collaboration with the DME and ATBEF. Approximately 1. 243 service providers, trainers and supervisors will be trained during the life of the project.

PROBLEMS ENCOUNTERED:

- Arrangements are not yet completed for a senior MOPH technical officer to join INTRAH for the purposes of providing 1. assistance in activating and monitoring the workplan, because a replacement has not been hired by the MOPH. The DME Director has submitted four candidates for consideration by the Minister.
- 2. There was some confusion about proposed INTRAH assistance for the development of family planning method protocols. Because UNFPA had helped prepare FP reference materials, it was thought that those materials were FP protocols and that INTRAH assistance would duplicate work already completed. The DME and UNFPA finally decided that the materials developed were training reference materials and were not to be used by service providers as protocols. The problem was another indication of the need for family planning agencies to coordinate their assistance to the National FP Program (PNBEF) to reinforce the complementarity of assistance and avoid duplication of efforts.
- 3. The delay experienced in beginning project activities was further aggravated by A.I.D. travel restrictions due to the Gulf War, which caused the proposed February 18-22 project and subcontract development visit to be postponed until April. As a result of the delay, there will be time pressure to complete the proposed activities in the workplan prior to the PACD of USAID/Togo's FHI-II buy-in funds.
- The new DME Director is questioning the length of comprehensive clinical FP skills training (6 weeks). This issue was 4. discussed at length with the previous DME Director, who also questioned the 6-week duration at the beginning of the PAC IIa project but became convinced after he saw the results from the follow-up/performance assessment of trained service providers. The new Director expects the Minister of Public Health to object to the length of time that service providers are spending in training.

FINDINGS/CONCLUSIONS/RECOMMENDATIONS:

- 1. The preparation of FP protocols to guide service delivery in accordance with the national FP service policy and standards should take place at the beginning of the project.
- 2. To avoid further delay in project implementation, project and subcontract development and the start-up workshop should be conducted in April and May, respectively. Arrangements for the senior MOPH technical officer to join INTRAH should be finalized before conducting the project start-up workshop.

- 3. In collaboration with the Evaluation and Program Specialists, a prototype follow-up and evaluation plan was prepared for training materials developed by INTRAH. The prototype was applied to the development of the evaluation plans for the "List of Free Materials in FP/MCH" and the "1991 INTRAH Calendar for Trainers," and data collection was begun.

4. Other activities of the Training Materials Service:

Completed information entry of materials, for the INTRAH/Anglophone Office, for a computer database of family planning training and reference materials in Anglophone Africa. The INTRAH/Anglophone Office will continue to update the database for use by their staff, consultants and Anglophone projects.

Participated in a meeting for the IEC/Training Materials Working Group of the IT/CAs' Steering Committee.

Attended the Seventh Annual A.I.D./Office of Population Cooperating Agencies Meeting. Prepared and displayed an exhibit of recent INTRAH publications during the Networking Exposition.


Completed production of an INTRAH display for professional meetings and conferences, including the NCIH conference in June, 1991.

Provided the Regional Offices with information on computer programs for library collections. Subscribed to 34 journals for the Regional Office in Lomé. Continued to provide materials and information retrieval services to staff members in Chapel Hill, Nairobi, and Lomé.

B. Projected Activities Next Six Months: April 1, 1991 - September 31, 1991

- 1. Finalize, print and begin distribution of the updated English version of *Guidelines for Clinical Procedures in Family Planning and Sexually Transmitted Diseases: A Reference for Trainers*. Distribution will include INTRAH training colleagues in Africa, participants of relevant INTRAH-sponsored workshops, CA's, international family planning assistance agencies, USAID offices in Africa, and ST/POP divisions. The *Guidelines* will be available on computer disk and in published, hardcopy form.
- 2. In collaboration with various INTRAH staff, continue development of the French edition of *Guidelines for Clinical Procedures in Family Planning and Sexually Transmitted Diseases: A Reference for Trainers*, and various INTRAH TIPs.
- 3. Assist regional offices in ordering and distributing workshop materials. Continue providing resource materials to institutions collaborating with INTRAH and in response to specific requests from institutions and individuals working in developing countries.
- 4. In collaboration with various INTRAH staff, continue selecting and ordering materials to be included in the English and French Trainers' Reference Libraries and identifying recipient training teams and training institutions.
- 5. Begin follow-up and evaluation of the "List of Free Materials in FP/MCH" and the "1991 INTRAH Calendar for Trainers." Develop follow-up and evaluation plans for the Trainers' Reference Libraries and the *Guidelines for Clinical Procedures in FP and STDs*.
- 6. Continue to participate in meetings for the Training Materials Working Group of the IT/CAs' Steering Committee and to participate in the Working Group's training materials database. Continue to share information about training materials with A.I.D. Cooperating Agencies and other international organizations.
- 7. Computerize records of materials which have been ordered and/or sent to the Regional Offices for their resource collections. Continue to develop a system for organizing audio-visual materials in the Chapel Hill resource collection. Continue to provide books, journals, and research information to INTRAH staff in Chapel Hill and the Regional Offices.

II. EVALUATION

A. Review of Past Six Months: October 1, 1990 - March 31, 1991

1. <u>Staff Development, October 1990</u>

The Evaluation Officer, together with INTRAH Deputy Director Lynn Knauff and Training Materials Specialist Gabrielle Beasley, participated in a workshop on performance technology conducted by the Center for Effective Performance in Atlanta, Georgia. The workshop focused on identification of the causes of, and solutions to, work performance problems.

2. <u>Representation of INTRAH at Meetings of Cooperating Agencies.</u> <u>November 1990-March 1991</u>

The Evaluation Officer attended the following meetings: The Office of Population's Meeting of the Cooperating Agencies, held during November 26-28, 1990, in Washington, D.C.; a meeting of the Ad Hoc Training Evaluation Group, held during January 9-10, 1991 at the Pathfinder office in Watertown, Massachusetts; two meetings of the Training Sub-committee of the ST/POP/IT Evaluation Working Group, on January 29, 1991 and March 11, 1991, respectively; and one meeting of the Evaluation Working Group on March 12, 1991.

- 3. Application and Revision of INTRAH's PAC IIb Evaluation Plan. Ongoing 1990-1991
 - a. <u>Fieldtest of a Format for Country Evaluation Plans Included in Country</u> <u>Project Proposals. March/April 1991</u>

In December 1990, INTRAH's Regional Office in Lomé used the format for developing the Burkina Faso training proposal evaluation plan and gave feedback to the Evaluation Officer.

b. Format and Content Revisions on the "Trainers' Jobs Tasks and Performance Standards" Document. March/April 1991

Revisions recommended at the 1990 Annual Meeting were made in the "Trainers' Jobs" document, and approval from INTRAH Regional Offices was sought. These revisions will undergo French translation in April, 1991.

A major change introduced at the 1990 annual meeting is the use of the term "master training team," defined as "A team whose members represent various areas of expertise devote varied percentages of time to training and perform various training-related functions, such as administration, consultation, stand-up training and technical assistance. The scope of the technical assistance provided by a master training team includes training design, curriculum development, preparation of other training teams, selection and use of training materials, training evaluation and decisionmaking about the quality (relevance, timliness, appropriateness, adequacy) of training."

c. <u>Developing a List of Terms for a Glossary of Training Evaluation.</u> <u>November 1990-January 1991</u>

During November 1990-January 1991, INTRAH Regional and Central office staffs participated in the development of a comprehensive list of training evaluation terms to be defined and standardized by INTRAH.

d. <u>Revision of Section V of the Evaluation Plan. Entitled the "Evaluation Workplan." March/April 1991</u>

Agreement was reached by INTRAH Regional Offices on how to document results from the "Trainers' Reaction Form" and from Pre/post tests. Based on these agreements, the workplan (as well as written materials/instructions to consultants) were revised. This section will be revised in French in April 1991.

e. Revision of Second Generation Tracking Form, January-March 1991

The Evaluation Officer coordinated INTRAH's Regional and Central offices inputs to revise the instrument to track second generation trainee numbers during PAC IIb.

f. <u>Development of Standards for Clinical FP Preceptors. January 1991-</u> Ongoing

Based on recommendations made at the 1990 INTRAH Evaluation Round Table, INTRAH's regional office in Nairobi began working on a draft set of standards for clinical FP preceptors. This effort was considered to have immediate applicability to training and program development and will be overseen by INTRAH/CH Deputy Director.

4. <u>Preparation of a Proposal for the May 21-29, 1991 Francophone</u> <u>Regional Seminar/Workshop in Evaluation, December 1-10, 1990</u>

The Evaluation Officer was in Lome December 1-10, 1990, to assist the Regional Office in the development of a draft proposal and action plan for implementing the proposal. The proposal was approved by AID in mid-February and a circular announcement cable was sent to USAID missions by ST/POP/IT at the end of February.

5. INTRAH's Program Management Information System

In March 1991, the Evaluation Officer reviewed a software system entitled "Training Evaluator" with the INTRAH Computer Systems Administrator, in order to explore ways of expanding INTRAH's capability/capacity to analyze data.

In addition, the Evaluation Officer interviewed and arranged to hire a graduate student assistant from the University of North Carolina's Department of Economics (assignment is decribed in #4, below).

7. Anglophone Regional Performance Evaluation Workshop

The Evaluation Officer coordinated RO/N efforts to engage training consultants for a proposed regional performance evaluation workshop, now scheduled for December 1991 to accomodate consultants' availability.

B. <u>Projected Activities for Next 6 Months: April 1-September</u> 30, 1991

1. <u>Finalization/Translation of Selected Parts of the Evaluation Plan, March-September, 1991</u>

The Evaluation Officer will finalize selected parts of the evaluation plan (See #3, above) by April, in order that the revised French version will be available for use in the May 1991 Francophone regional seminar/ workshop in evaluation.

2. <u>Technical Assistance to Develop a Curriculum for the Francophone</u> <u>Regional Seminar/Workshop in Evaluation for Directors and</u> <u>Coordinators of Training Projects. April 8-19, 1991</u>

The Evaluation Officer will be in Lome April 8-19, 1991 to assist in the development of parts of a curriculum that will be used in the regional evaluation seminar/workshop scheduled for May 1991. This activity will include development of technical materials which will be continued in Chapel Hill during April/May 1991.

3. <u>Regional Seminar/Workshop in Evaluation for Directors and</u> <u>Coordinators of FP Training Projects. May 21-29, 1991</u>

The Evaluation Officer will participate as a co-facilitator in the Regional Seminar/Workshop in Evaluation for Directors and Coordinators of FP Training Projects in Lome. Other co-facilitators will be: Mr. Onanga Bongwele, INTRAH Regional Evaluation/ Supervision Specialist, Mr. Pape Gaye, INTRAH Regional Director for Francophone Africa and INTERAH Training/Evaluation consultant Mr. Joanny Kabore.

4. <u>Technical Assistance to INTRAH Regional Offices and Within Chapel Hill</u> on Evaluation Plan Implementation and on Technical Issues and Problems Associated with Implementation. March-September 1991

The Evaluation Officer will work with the Deputy Director and Francophone Program Officer in providing technical support to regional offices for the following activities: planning, implementation and monitoring of baseline data collection; development of project proposal evaluation plans; implementation of participant follow-up plans (for RO/N's October 1990 Regional TOT and RO/L's May 1991 Seminar/Workshop in Evaluation); and the formulation of questions and their integration into operations research in new INTRAH training projects.

In addition, the Evaluation Officer will work with the Training Materials Officer to coordinate integration of training materials evaluation approaches into country projects in Anglophone and Francophone regions.

5. Revision of Baseline Guidelines. March/April 1991

The current guidelines for collecting baseline data will be revised to more closely reflect INTRAH regional office practice regarding the collection of trainee and project baseline.

6. Supervision of Graduate Student Assistant, May-July 1991

The Evaluation Officer will work with Ms. Sumana Dhar, a Ph. D candidate from the UNC Department of Economics, to develop a draft framework for assessing the costs/benefits of INTRAH training. Ms. Dhar will also work with the Computer Systems Administrator, who will provide assistance to Ms. Dhar in understanding INTRAH's activity cost system.

7. <u>Participation in the Evaluation Working Group of the ST/POP/IT Steering</u> <u>Committee. Ongoing</u>

The Evaluation Officer will represent INTRAH in the Evaluation Working Group.

8. Participation in the NCIH Annual Meeting. June 24-26. 1991

The Evaluation Officer will attend the NCIH meeting.

9. Participation in INTRAH's Annual Meeting. August 12-23, 1991

In July 1991, the Evaluation Officer will participate in planning for INTRAH's Annual Meeting, and will participate in meetings from August 12-23, 1991.

10. <u>Development of a First Draft of a Glossary of Training Evaluation Terms.</u> June-December. 1991

The Evaluation Officer will attempt to hire a graduate assistant, who will develop a first draft glossary of training evaluation terms, based on a list of terms developed by INTRAK staff November 1990- January 1991.

Upgrades from two IBM 8088 dual drive PCs have been made to two IBM-compatible 286 PCs with 40 MB hard disks for INTRAH/Chapel Hill's Translator and Program Assistant. The older machines are now being used for instruction and backstopping.

Data System

After the purchase of Fastback Plus software, a new backup system has been implemented that ensures safety of the training, financial, library, directory databases as well as other important computerized documentation.

Data were provided for several A.I. D. requests, such as the number of nurses trained in PAC IIb for the Office of Health.

B. <u>Projected Activities Next Six Months:</u> <u>April 1, 1991 - September</u> <u>30, 1991</u>

Computer System

Data Management Services will continue to seek technical assistance and explore options for improving INTRAH's computer network systems.

Data System

In the next six months, INTRAH plans to put into effect procedures for the cost activity system.

The Computer Systems Administrator will attend a two day seminar on programming in dBase III+.


