AMENDMENT THREE

Name of Country: Peru  
Name of Project: Administration of Justice  
Number of Project: 527-0303

A. Pursuant to Section 534 of the Foreign Assistance Act of 1961, as amended, the Administration of Justice Project for Peru was authorized on June 24, 1986 and amended on August 31, 1987 and August 26, 1988 (as amended, the "Authorization"). The Authorization is hereby amended as follows:

1. Section 1 of the Authorization is deleted in its entirety and the following is substituted in lieu thereof:

"1. Pursuant to Section 534 of the Foreign Assistance Act of 1961, as amended, I hereby authorize the Administration of Justice Project ("Projects for Peru, involving planned obligations of not to exceed Two Million Eight Hundred and Fifty Thousand United States Dollars (US\$2,850,000) in grant funds ("Grant") over a four year period from the date of authorization, subject to the availability of funds in accordance with the AID OYB/allotment process, to help in financing foreign exchange and local currency costs for the Project. The planned life of the Project is seventy eight months from the date of initial obligation."

B. Except as modified herein, the Authorization remains in full force and effect.
