AMENDMENT NO. 3

Name of Country: Jamaica (Central American and Caribbean Region)
Name of Project: Caribbean Justice Improvement Project
Number of Project: 532-0162 (598-0645.08)

1. Pursuant to Sections 531 and 534 of the Foreign Assistance Act of 1961, as amended, the Caribbean Justice Improvement Project was authorized on July 15, 1986 and amended on July 8, 1988 and June 23, 1989. The original Project Authorization approved a life of project total of \$10,000,000, of which \$7,800,000 was allocated to the University of the West Indies component and \$2,200,000 was allocated to the Jamaican component. Amendment Number 1 increased the Jamaican component by \$600,000 to \$2,800,000. Amendment Number 2 increased the University of the West Indies component by \$2,600,000 making a project total of \$13,200,000. In order to further increase the Jamaican component by \$50,000, the authorization is hereby amended to read as follows:

Pursuant to Sections 531 and 534 of the Foreign Assistance Act of 1961, as amended, I hereby authorize the Caribbean Justice Improvement Project, involving planned life of project obligations of not to exceed Thirteen Million Two Hundred & Fifty Thousand United States Dollars (\$13,250,000) in grant funds ("Grant"), subject to the availability of funds in accordance with the AID/OYB allotment process, to help in financing foreign exchange and local currency costs for the Project.

2. The new Project Assistance Date (PACD) is August 30, 1991.
3. The authorization cited above remains in force except as hereby amended.




