18. Summary Description

The program goal is the improved quality of life of the rural population through sustained and broad-based, market-oriented growth in agricultural production. The program purpose is to increase the efficiency of the agricultural marketing system for non-industrial crops. The Conditions Precedent for the first tranche of funds are summarized in the attached policy matrix. Non-program assistance funds will be applied only to payroll expenditures at the Ministry of Agriculture. These funds are intended to offset short-term revenue losses to the GOC caused by policy reforms proposed by the program.

Whereas the Grantee and USAID entered into a Project Grant Agreement dated September 12, 1993 (the "Agreement"); and

Whereas the Grantee and USAID desire to further amend the Agreement to add \$2,000,000 to the USAID grant,

Now therefore, the Agreement is hereby amended as follows:

**ARTICLE 3: FINANCING**

Section 3.1. The Grant. From the first paragraph, delete the phrase "not to exceed two million United States dollars (\$2,000,000.00)", and insert in lieu thereof "not to exceed four million United States dollars (\$4,000,000.00)".

Except as amended herein, the agreement remains unchanged and in full force and effect.

In witness whereof, the Governments of the Republic of Chad and the United States of America, each acting through its duly authorized representative have caused this Amendment No. 2 to be signed in their names and delivered as of the day and date last written below.


Il en résulte à présent l'amendement qui suit:

Subject: Amendment # 1 to the Program Assistance Approval Document (PAAD) for the Agricultural Trade Policy Reform Program 677-0068.

**Problem:** Your approval is requested for Amendment # 1 to the Program Assistance Approval Document (PAAD) for the Agricultural Trade Policy Reform Program 677-0068. This amendment will obligate an additional two million dollars (\$2,000,000) for the Program.

**Discussion:** The Program Assistance Approval Document (PAAD) for the subject program was signed September 11, 1992. This document authorized and obligated funding for FY 1992 of \$2,000,000 for the program. As this NPA program may not be authorized for the total planned multi-year level of \$9,000,000 and incrementally obligated, it is necessary for each funding tranche to be incrementally authorized and obligated in each fiscal year in which an obligation is made.

On August 13, 1993, USAIL/Chad received the allowance cable from FM/A/PNP which insures Congressional Notification has been received and provides a budget allowance for \$2,000,000 for FY 1993 as well as the PAAD amendment number. This allows the mission to proceed with the necessary incremental obligation for FY 1993 through subject PAAD Amendment #1.

Whereas, the funding is within the overall program amount that has been previously approved; the amendment entails no substantive changes in conditionalities of the program as approved; the amendment serves only as an authorization and obligation document for FY 1993; and you have been delegated authority through the Africa Bureau Delegation of Authority 551 to authorize the incremental funding for a program/project: a) whose duration does not exceed 10 years; b) which has a funding level of less than \$20 million; and c) which does not present any significant policy issues; and d) which does not require waivers that only the Assistant Administrator or Administrator can approve; these conditions being met, you have authority to approve this program assistance approval document (PAAD) amendment.

**Recommendation:** The Program Office recommends that you sign the attached PAAD Amendment #1, and thereby provide authorization to obligate funding of \$2,000,000 for FY 1993 for the Agricultural Trade Policy and Reform Program.
