

1. Pursuant to Section 531 of the Foreign Assistance Act of 1961, as amended, the LAC Regional Administration of Justice Support project was authorized on March 13, 1991. That authorization is hereby amended as follows:

a. Paragraph 1 is deleted and replaced with the following: Pursuant to Sections 531 and 106 of the Foreign Assistance Act of 1961, as amended I hereby authorize the Latin America and the Caribbean Regional Administration of Justice Support project involving planned obligations of not to exceed Seven Million Fifty Thousand United States Dollars (US \$7,050,000) in grant funds over a four year period from date of authorization subject to the availability of funds in accordance with the USAID OYB/allotment process, to help in financing foreign exchange and local currency costs for the project. The planned life of project is four and one-half years from the date of initial obligation.

b. In the last sentence of Paragraph 3a, the figure "\$150,000" is deleted and replaced with "\$250,000."

The authorization cited above remains in force except as hereby amended.
