I. GENERAL STATEMENT

USAID/Caucasus, covering The Republics of Georgia and Azerbaijan, signed a Task Order with World Learning, under the START IQC – Strategic Technical Assistance for Results with Training – to support its human capacity development activities. The Task Order, covering a three-year period from January 15, 2002 to January 15, 2005, supports USAID in the Caucasus in their efforts to integrate training within most of its sectoral programs to supplement and strengthen the impact of its technical assistance.

The Task Order, known as START/Caucasus, supports each Mission's participant training program and is designed and implemented to contribute to the accomplishment of development results as defined by each Mission, and supports all strategic objectives in each Mission's portfolio. There are four major elements: short-term training; longer-term, academic training; post-training support; and institutional human resource assessments and analyses. Support within each elements includes, but is not necessarily limited to:

- Needs assessment and analyses
- Planning and development of training programs
- > Recruitment and selection of qualified candidates
- Programming and placement
- Pre-departure interventions
- Monitoring and Administrative arrangements
- > Follow-up and alumni development
- Assessment of training effectiveness
- Data maintenance and reporting
- Services provided to other USAID activities

World Learning is supported in this activity by its START IQC partners, the Institute of International Education for US placement and monitoring, and Development Info-Structure and Partners International for data management and technology support.



2003 IMPLEMENTED TRAINING PROGRAMS:

The following interventions were conducted during CY2003 by World Learning:

SPECIALIZED LEGAL TRAINING TARGETED AT THEORETICAL STUDY OF NOTARY PRACTICE (BAKU, AZERBAIJAN, FEBRUARY 24 – MARCH 7, 2003)

This training was implemented by the Order of Notaries of Quebec, Canada and targeted public notaries and staff of the Ministry of Justice, totaling 40 people. The Department of the Notary and the Civil Status Acts in the Ministry of Justice requested the training.

The participants of the training received sound professional advice regarding the requirements of a well functioning notarial system and the important role it plays in Azerbaijan's emerging market economy.

SPECIALIZED LEGAL TRAINING TARGETED AT PRACTICAL STUDY OF NOTARY PRACTICE (MONTREAL, CANADA, APRIL 21 – MAY 2, 2003)

This Canada-based follow-on course for 4 public notaries and 3 representatives of the Department of the Notary and the Civil Status Acts in the Ministry of Justice provided

practical hands-on training. This course was provided by the Order of Notaries of Quebec, Canada and was dedicated to the study of Notarial System of Quebec with visits to various notarial institutions in Canada as well as ONQ office, thus offering a model for reform.

This program addressed significant issues surrounding the alignment of Azerbaijan with international notarial standards (standards of the International Union of Latin Notaries) including creating a new class of legal professionals and improving the climate for international investment

BANK MANAGEMENT TRAINING (BAKU, AZERBAIJAN, MARCH 31 - NOVEMBER 7, 2003)

This series of training programs was requested by the Azerbaijan Bank Training Center (ABTC) for 381 managers of commercial and non-commercial banks. It consisted of 7 events covering four main topics: Bank Management (March 31 – April 10, 2003 / October 27 – November 7, 2003), Loan Management (May 12 – 30, 2003 / September 29 – October 10, 2003 / October 13 – 23, 2003), Risk Management (June 2 – 20, 2003) and Bank Marketing (September 8 – 26, 2003). The purpose of the training course was to strengthen the training capacity of ABTC training staff and to provide participant training for managers of commercial and non-commercial banks.

The training providers were Savings Bank Foundation for International Cooperation, Germany; Bank World International, USA; Andrew Fight Consulting, Ireland.

International Training Workshop on Designing Policies and Institutions That Promote Competitive Agricultural Input Markets in Transitional Economies (Baku, Azerbaijan, April 7-11, 2003)

Eight professionals from the Government of Azerbaijan and private sector participated in this workshop that promoted the development of Agricultural Input Markets (AIMs) in transitional economies through appropriate policies and supportive institutions. The program focused on the issues related to seed, fertilizer, and other agricultural inputs and agricultural systems in general.

This was the fourth in a series of policy training workshops that was provided by International Center for Soil Fertility and Agricultural Development (IFDC).

Quality Standardization in the Food Industry (Skopje, Macedonia, April 15-25, 2003)

World Leaning jointly with Land O'Lakes organized this training for 10 production and technology specialists employed in dairy and meat processing companies. The central goal of the training was to introduce the trainees to various aspects of quality control systems (QCS) applicable in food industry and to provide comprehensive and detailed information about those QCS methodologies and techniques that specifically relate to dairy and meat industries.

This event was conducted by the Macedonian Association of Private Milk and Meat Processors.

INTERNATIONAL INSTITUTE FOR SECURITIES MARKET DEVELOPMENT (WASHINGTON, DC, USA, APRIL 21 – MAY 1, 2003)

One participant from the State Committee for Securities under the auspices of the President of Azerbaijan Republic was sent to attend this program held at the Securities and Exchange Commission in Washington, DC, USA. This program included a full schedule of lectures and small group workshops led by senior SEC officials, as well as representatives from other U.S. government agencies, multilateral development institutions, securities exchanges, and other key securities industry participants was to foster a dynamic exchange of information and viewpoints among market professionals and regulators.

Upon completion of his training, Mr. Samir Dadashev, Head of Department in State Committee for Securities under the auspices of the President of Azerbaijan indicated that he intended promote the creation of an organization in Azerbaijan analogical to SIPC (Securities Investors protection Corporation) in order to protect the rights of the securities investors more effectively.

The training provider was the International Institute for Securities Market Development, United States Securities and Exchange Commission, Office of International Affairs.

MINISTERIAL CONFERENCE AND EXPO ON AGRICULTURAL SCIENCE AND TECHNOLOGY (SACRAMENTO, CALIFORNIA, USA, JUNE 23 – 25, 2003)

The Minister of Agriculture was sent to attend the conference that was organized by the United States Department of Agriculture. The conference focused on the critical role science and technology could play in raising sustainable agricultural productivity in developing countries. The conference broadened the Minister of Agriculture's knowledge and understanding of relevant science and technology, including biotechnology and how to access to new technologies through public-private partnerships. Increasing agricultural productivity through technology adoption is a key means of boosting both food availability and access and improving nutrition.

SECOND NEW INDEPENDENT STATES POLICY FORUM ON MICROFINANCE LAW AND REGULATION (KRAKOW, POLAND, JUNE 26 – 28, 2003)

World Learning sent two highly positioned policymakers from Licensing and Control's Methodology Department of the National Bank and the Department for Refugees, IDPs and Migration of the Cabinet of Ministers to participate in the conference provided by The Microfinance Center for Central and Eastern Europe and the New Independent State.

The Forum was designed as a "policymakers event" in order to provide actors in key positions with an opportunity for a free exchange of views and experience among peers on the key issues concerning the regulation of microfinance.

LEGAL AND METHODOLOGICAL BASIS ON REAL ESTATE APPRAISAL (TBILISI, GEORGIA, JULY 5 - 11, 2003)

Four members of the Azerbaijan Appraisers Society attended this seven-day training provided by the Georgian Federation of Professional Asset Valuators that focused on increasing the participants' professional skills in terms of real estate evaluation and prepare them to provide input in developing national standards.

Business Case Competition Winners Study Tour (Houston, Texas, USA and Glendale, Arizona, USA, September 29 – October 17, 2003)

In the fall of 2002, Citizen Democracy Corps (CDC) organized a Business Case Study Competition amongst master's degree students from various universities in Azerbaijan. The winning team was awarded participation in a study tour to the US in the fall of 2003. The three winners of the CDC Case Competition, who were master's degree students of the Oil Academy, participated in the study tour, which was organized by World Learning, Inc.

The winning team attended a Project Management course provided by Rice University, Houston, Texas and an Advanced Management Program for Oil and Gas Industry Executives at Thunderbird, Glendale, Arizona. Additionally, the participants were exposed to the business operations of several Houston-based oil companies such as Exxon-Mobil, Halliburton and McDermott to provide exposure to world class best practices in the field of corporate finance, project management, operations research.

THE NINTH INTERNATIONAL CENTRAL EUROPEAN REAL ESTATE ASSOCIATION NETWORK (CEREAN) CONFERENCE (KRAKOW, POLAND, OCTOBER 17 – 19, 2003)

Eight participants from the Azerbaijan Appraisers Society and Shorebank were sent to attend three-day-conference on Preparing for the Integrated European Real Estate Market organized by Central European Real Estate Association Network.

The International Annual CEREAN Conference, organized since 1994, provided a platform for establishing and strengthening personal contacts, exchanging information and offers between real estate brokers, property managers and valuers, developers, investors, representatives of banks, investment funds, insurance and construction companies.

Workshop for Journalists Reporting on Energy-Sector Issues (Tbilisi, Georgia, October 18, 2003)

Three journalists from "Turan" Information Agency, "Sharg" Information Agency and "Mingachevir Ishiglari" Newspaper in Mingachevir region attended a one-day-conference, which was organized by Caucasus School for Journalism and Media Management at the Institute of Public Affairs in Tbilis, Georgia.

The purpose of this conference was to increase the journalists' skills at reporting accurately and in an unbiased manner on energy related issues. Journalists were provided with additional skills and knowledge that enhanced their ability to work with a more well-informed and professional approach to covering energy issues, including: learning how the Caucasian electrical system works; learning the appropriate sources to contact to get reliable information; and learning the types of stories to write to provide useful information to readers. Much of the materials used during the training were articles written after the recent major blackout in the northeastern United States. Upon returning to Azerbaijan, one of the participants, Mr. Farman Nabiyev wrote an article about his trip in regional newspaper "Mingachevir Ishiglari".

PUBLIC ADVOCACY COMPETITION ON THE ECONOMIC COSTS OF CORRUPTION (AZERBAIJAN, MAY 10 - SEPTEMBER 10, 2003)

The main goal of the first two-part program was to improve advocacy and active support on the part of the citizens of Azerbaijan to voice in public the economic costs of corruption and seek public support for its reduction. The first component entitled, "Essay and Political Cartoon Competition" was held within grades 10 and 11 and university students from Lenkoran, Ganja, Mingachevir, Guba and Zagatala regions. It was dedicated

to encouraging the students to depict corruption's economic harm through creative essays and cartoons. This component was administered by the local NGO "Saniva".

The second part entitled, "Nationwide Journalist Competition", was held among print and TV journalists and was dedicated to developing newspaper articles and TV documentaries on the economic costs of corruption in Azerbaijan. This component was implemented by the local NGO "Internews". This component also included the preparation and broadcast of 8 public service announcements (PSAs) on economic costs of corruption.

INTERNATIONAL LEGISLATIVE DRAFTING INSTITUTE PROGRAM UST (NEW ORLEANS, LOUISIANA, USA, JUNE 16 - 27, 2003) AND ICT FOLLOW-ON (BAKU, AZERBAIJAN, AUGUST 25 - SEPTEMBER 2, 2003)

A group of 9 representatives of Milli Mejlis Apparatus and civil society attended the "International Legislative Drafting Institute" in New Orleans, Louisiana, USA provided by The Public Law Center. The follow-on activity was designed for the same actors and was conducted in Baku, Azerbaijan by Mr. Bruce Feustel, Senior Fellow at the National Center for State Legislatures (NCSL) in Denver, CO, USA.

The overall program was designed to improve legislative drafting skills of the participants and address greater transparency and implementation of Azerbaijan laws and policies.

Non-Government Organizations' Sustainability Index Assessment (Azerbaijan, July 1 – August 15, 2003)

The NGO Sustainability Index for Central and Eastern Europe and Eurasia is a tool used by USAID to study the strength and overall viability of NGO sectors in each country in the region. By analyzing seven dimensions that are critical to sectoral sustainability, the Index allows for comparisons both across countries and over time. The assessment work included three group and individual interviews with representatives of NGOs who were nominated by INGOs, in 4 regions of Azerbaijan: Baku, Shaki, Guba, and Imishli. The overall number of responders in the survey was 47 representing various local and international organizations.

The survey was conducted by Catholic Relief Services (CRS).

PRESIDENTIAL ELECTIONS 2003: TRAINING OF PRECINCT ELECTION COMMISSION MEMBERS (SEPTEMBER 15 – OCTOBER 8, 2003)

The primary aim of the Precinct Election Commission (PEC) training project was to assist the Central Election Commission in designing and implementing a PEC training program in selected constituencies in order to improve the overall preparedness of PEC members for the upcoming elections, thereby contributing to the improvement of the elections process in Azerbaijan. This training was competitively bid and awarded to International Foundation for Election Systems (IFES) who worked in close cooperation with the Central Election Commission (CEC) for local trainers and precinct election commission (PEC) members.

The training was held in Baku, Ganja, Tovuz, Ismayilli, Shaki, Guba and Sabirabad. The core training team conducted two, three-day TOT courses for a trainers' group comprised of 24 Azerbaijanis; the trainers' group subsequently conducted 359 training sessions for a total of 10,351 PEC members representing 66 constituencies; training teams had on-going

consultations with 66 Constituency Election Commissions (ConEC) chairpersons and 32 Executive Commission (ExCom) representatives.

2003 PRO-MEDIA PARTNERS CONFERENCE: STRENGTHENING INDEPENDENT NEWS REPORTING THROUGH PARTNERSHIPS (LITHUANIA, VILNIUS, OCTOBER 22 - 24, 2003)

Each year, The International Research & Exchanges Board (IREX) organizes a conference in Eurasia or Southeastern Europe to serve as a forum for IREX field staff, USAID representatives, journalists, and partner organizations to discuss contemporary issues and development strategies in regards to independent media. As world interest and resources shift from Southeastern Europe and Eurasia, media donors need to strengthen efforts to consolidate the gains that donors and implementers have achieved to date, while fostering those changes that are still necessary for independent media to thrive. As such, the conference addressed how donors can harness private investment to stabilize the position of media partners and how donors can support aggressive independent journalism.

This year participation included two Azerbaijani journalists nominated by "Internews" and "New Generation Journalists' Union". They were from newspaper "Zerkalo" and Internet newspaper "Baku Today".

NEGOTIATION, COMMUNICATION, PRESENTATION SKILLS AND CONFLICT RESOLUTION (BARDA, AZERBAIJAN, FEBRUARY 24 – MARCH 4, 2003)
NEGOTIATION, COMMUNICATION, PRESENTATION SKILLS AND CONFLICT RESOLUTION (IMISHLI, AZERBAIJAN, JULY 28 – AUGUST 1, 2003)

NEGOTIATION, COMMUNICATION, PRESENTATION SKILLS AND CONFLICT RESOLUTION NAKHCHIVAN I (SEPTEMBER 22-26, 2003) AND NAKHCHIVAN II (OCTOBER 6-10, 2003)

This series of trainings was designed for 20 community leaders and representatives of community based organizations (CBOs). The training focused on improving skills of community leaders to effectively communicate and negotiate with other sectors, such as government, municipalities, NGOs, local businesses, other communities as well as international organizations and foundations. Specific topics included definition of communication; types of communication that are appropriate and necessary for effective advocacy; barriers to communication; negotiation skills (preparing for and conducting negotiations); negotiation with Government; negotiation with International Donors; listening and questioning techniques; barriers to successful negotiation and how to deal with them; presentation skills and techniques including delivery techniques; managing the audience; meeting and influencing the response; creating presentations, types of meetings and their purpose; planning and conducting effective meetings and conflict resolution techniques.

The training provider was a local NGO Azerbaijan Community Development Research, Training and Resource Center (ACDRTRC).

CAMBRIDGE INTERNATIONAL HEALTH LEADERSHIP PROGRAM TRANSFORMING HEALTH: FROM POLICY TO ACTION (CAMBRIDGE, UNITED KINGDOM, APRIL 22 – May 1, 2003)

A representative of World Health Organization who works in the Ministry of Health was sent to this seminar, which offered an unrivalled opportunity for a small group of

senior health sector practitioners and policy makers to tackle issues of health sector reform at a highly strategic level, in consultation with leading international leaders in the field. Through a combination of lectures, workshops, case analyses and discussions groups, the program strengthened and enriched the participants' ability to manage complexities and improve performance. Group work on selected topics was integrated into the program, constructed around participants' own issues, giving participants the opportunity to learn from each other as well as with the faculty. They learned the latest approaches to systems improvement and will have the opportunity to develop their own plans and approaches in moving from Policy to Action.

Participation in the seminar linked delegates into an influential network involving both their peers, faculty and the agencies supporting and driving health sector reform.

The organizer of the off-the-shelf conference was the University of Cambridge.

Cluster Regional Planning, Networking, Coalition Building (Barda, Azerbaijan, May 6 – 9, 2003)

This course was organized for 20 community group leaders and members from various communities of Barda Cluster to improve delivery of social services to rural communities through the improved ability to work with external partners such as government agencies and private business, as a result of increased community planning, networking, and coalition building activities.

The training was provided by Azerbaijan Community Development Research, Training and Resource Center (ACDRTRC).

COLLABORATION WITH EXCOMS AND MUNICIPALITIES TRAINING. AZERBAIJAN COMMUNITIES TODAY: COMMUNITY AND GOVERNMENT RELATIONS CONFERENCE (BAKU, AZERBAIJAN, MAY 15, 2003)

A one-day conference was designed for community leaders and Executive Power representatives as well as international and local NGOs. Overall number of participants was approximately 156. The conference, provided by ACDRTRC, created a forum for participants to share their experiences and recommendations. WL organized participation of 17 community leaders and members at the conference.

CLUSTER REGIONAL PLANNING, NETWORKING, COALITION BUILDING (IMISHLI, AZERBAIJAN NOVEMBER 3 – 7, 2003 AND NAKHCHIVAN, AZERBAIJAN, NOVEMBER 24 – 28, 2003)

This course was organized for 40 community group leaders and members from various communities of Imishli and Nakhchivan Cluster to improve delivery of social services to rural community through the improved ability to work with external partners such as government agencies and private business, as a result of increased cluster regional planning, networking, and coalition building activities.

MASTER'S DEGREE PROGRAM 2003 - 2005

The aim of this program is to further prepare young Azeri men and women who have demonstrated strong leadership capacity in their professional, technical and managerial careers to become progressive, forward thinking and visionary leaders. The long-term goal of the program is to create a cadre of internationally trained and high quality professional

economic policy- and decision-makers, managers and administrators. The finalists of the program were allocated to the following US institutions:

SHORT TERM TRAINING:

Training, regardless of location that is not designed to lead to the awarding of an academic degree. Short-term training normally lasts between one week and nine months. Recognizing that many leaders and professionals will not be free for extensive training periods, the primary focus will be on shorter-term training programs of 1-4 weeks in duration.

Out of 34 training programs implemented in the reporting period, 26 events were short-term trainings. 15 trainings lasted up to 1 week, 6 trainings up to 2 weeks, 1 training up to 3 weeks and 4 programs had longer duration: 1 month, 1 and a half month, 3 months and 4 months.

LONG TERM TRAINING:

Long term training occurs in academic settings lasting nine months or longer, whether for an academic degree or technical certificate of completion.

Eight out of 34 programs were long-term academic trainings where the participants (eight in total) are seeking Masters Degrees. Each program's duration is 24 months.

POST TRAINING SUPPORT:

World Learning/Azerbaijan has rendered the following post training support activities:

> Offered its conference room for follow up meeting of trainees of Legislative Drafting Seminar (International Legislative Drafting Institute Program)

CHALLENGES & CONSTRAINTS:

- > Long-term academic trainings present particular constraints in terms of attracting qualified English speaking candidates. Furthermore, cultural expectations seem to hinder female applicants. For the 2004 academic year, World Learning implemented two rounds of advertising; one campaign during the summer and one during the fall. Despite a targeted recruitment strategy, only 16% of all applicants that were invited to sit for the English language testing phase passed to the interview stage. The advertising campaign included television (ANS TV channel - creeping line for 2 weeks and "Space TV" channel - creeping line for 2 weeks), newspaper ("ECHO" daily newspaper announcement placed 3 times, "Musavat" daily newspaper - announcement placed 3 times, "Zerkalo" daily newspaper - announcement placed 3 times, "Mingechevir Ishiglari", Mingechevir regional newspaper - 2 times, "GanjaBasar", Ganja regional newspaper - 2 times, and "Hugug Gazeti" - weekly newspaper, 2 times), over 400 targeted emails to local and international organizations (relevant government ministries and universities, Peace Corps, IFDC, Ganja Educational Information Center, Baku Educational Information Center, regional trips (to Ganja, Mingechevir and Sheki in order to make presentations at INGO, LNGO and relevant Universities and distribute the announcement by hand) and internet websites (<u>www.azerweb.com</u>, <u>www.osi.az</u>, <u>www.aznet.org</u>, <u>www.abtc.az</u>).
- The lead-time for issuance of J-1 visas for US-based trainings continues to limit World Learning's ability to react quickly to last minute training opportunities. For example, at the request of the US Ambassador, the Ministerial Conference and Expo on Agricultural Science and Technology was incorporated into World Learning's training plan 3 weeks before the event date. Under normal circumstances, eight weeks are required to solicit all necessary approvals for J-1 visas. Due to such short notice, World Learning was not able to secure a J-1 visa for the Minister of Agriculture. Based on communications between World Learning's Country Director and USAID's Country Coordinator, William D. McKinney, it was agreed that the Minister of Agriculture would secure an A-1 visa (foreign government officials visa).

III. ANNUAL UPDATE OF FEE-FOR-SERVICE (FFS) ACTIVITIES

In addition to the implementation of the Participant Training Program, World Learning is also responsible to provide training services to USAID-funded implementers upon request. Training Fee-for-Service activities are provided within the framework of the USG ADS 253 and USAID Europe and Eurasia Participant Training regulations. These activities are most often associated with, but not limited to the US-based training and include obtaining a J-1 visa, facilitating medical reviews, arranging for HAC insurance, and conducting English Language testing. World Learning enters into an agreement with the USAID-funded implementers for the specific training support services they need.

In order to clarify the concept of Training for Fee-for-Services for the USAID-funded implementers, as well as facilitate the service selection process and provide the required data for reporting, World Learning drafted a Fee-for-Service (FFS) Application Package.

The Package was submitted and approved by USAID - Azerbaijan and then distributed among all USAID funded implementers.

For the period of January 1, 2003 – December 31, 2003 World Learning negotiated and implemented the following FFS agreements:

- ➤ 1 Fee for Service Agreement with American Bar Association / Central East & European Legal Initiative (ABA/CEELI),
- ➤ 1 Fee for Service Agreement with Energy Regulators Regional Association (ERRA),
- ➤ 8 Fee-for-Service Agreements with American International Health Alliance (AIHA).

The total number of participants processed under Fee-for-Service Agreements this year was 25, of which 56% were female (Please see <u>Attachment 2</u>: Matrix of Fee for Service Contracts).

TRAINING NEEDS ASSESSMENT AND PERFORMANCE ANALYSIS:

To identify key institutions throughout Azerbaijan and critical skill deficiencies or performance gaps to be addressed through training.

World Learning staff implemented the following needs assessment and analysis activities:

- ➤ USAID AHAP partners (CHF, Save the Children, ADRA) to identify needs of the trainings under SO 3.1. The meeting identified an importance of conducting trainings for Executive Committees and Municipalities;
- ➤ IOM and ADRA to identify World Learning, IOM, ADRA collaborative work capabilities and priorities in Nakhchivan region;
- Representatives of Milli Mejlis, Municipalities and ExComs to identify specifics and priorities of trainings under SO 3.1;
- ➤ USAID SO 1.3 partners (CDC, IFDC, ACDI/VOCA) and USAID which identified capacity building needs in agricultural sector: best farmers practices, training for agronomists; trainings for loan officers, business owners;
- Supporting SO teams in the identification of indicators by which to measure capacity development;
- ➤ Various USAID Partners to identify areas in which WL collaboration would strengthen the technical assistance work;
- Meeting with the Ministry of Economic Development's Agrarian Reform Department;
- Meeting with University personnel regarding business curriculum development;
- Assess participant skills, knowledge and attitude prior to and following each training project.

PLANNING AND DEVELOPMENT OF TRAINING EVENTS:

To work with the Mission, contactors and partner organizations to design training event plans that are responsive to partner needs and Mission Strategic Objectives (SO).

World Learning continues to actively coordinate all training activities to ensure that the trainings that are implemented support the technical assistance work of USAID partners and specific mission strategic objectives. Every effort is made on the behalf of World Learning to synthesize input from all USAID Partners and partner organizations and present it to USAID in a format that identifies performance gaps, objectives of the training and critical skills/attitudes needed to accomplish objectives.

World Learning maintains a high level of contact within the community in a variety of ways including conducting one-on-one meetings with USAID and its partners on a regular basis to discuss potential areas of training activities. Additionally, World Learning staff are invited to participate in SO-specific USAID Partner meetings where USAID project updates are provided including other relevant sector information.

RECRUITMENT AND SELECTION OF PROSPECTIVE TRAINING CANDIDATES:

To identify qualified trainees while meeting Mission gender participation targets.

The Mission's Strategic Objective Teams, its contractors and grantees, other USG agencies, and country partner organizations nominated training participants. Recruitment was also done using technical assistance contractor referrals, host country mass media, training announcements, staff referrals, consultants and other unbiased means of attracting candidates.

In total there were 11,663* (2223 women and 9440 men) recruited and selected persons for the training events. The selection of highly motivated participants was based on the following criteria:

- > Need the trainings for improving job performance,
- > Need the trainings for improving performance of an institution where they work,
- > Are interested in learning new knowledge and skills,
- Able to fully participate in the trainings,
- > Have clear vision of how new knowledge and skills will be applied in their jobs,
- Have clear vision of how new knowledge and skills will improve performance of their institutions,
- Able to apply new knowledge and skills for improving performance of their institutions.

PLACEMENT AND PROGRAMMING:

To identify training providers and events that meet requirements of the training request; to develop the best mix of activities according to trainee needs that reflect experiential/adult learning approaches.

World Learning used the following procedures for programming and placement for training site and identifying training provider to satisfy the training objectives:

- Conducted research for potential in-country, US- and third-country training providers with the guidance of USAID and its partners, when needed,
- Worked with subcontracting partner, International Institute for Education (IIE) to search for US-based training providers,
- Prepared and sent out Requests for Training Proposals (RFTP) to potential training providers to ensure a competitive environment that would elicit the most cost-effective programming,
- Conducted evaluation of training proposals adhering to the criteria indicated in E&E Handbook of Participant Training Policies and Procedures for competitive procurement,
- > Applied sole-source and non-competitive procurements with Mission approval.

PRE-DEPARTURE INTERVENTIONS (ORIENTATION, SETTING OF TRAINING OBJECTIVES AND TRAINEE COMMITMENTS, VISA PROCESSING, FLIGHT ARRANGEMENTS, LANGUAGE TESTING, MEDICAL CLEARANCES):

To prepare participants for training; to address participant concerns about their programs; to ensure that trainees are prepared logistically.

During the period, World Learning conducted 4 pre-departure orientations for third country trainings and 8 pre-departure orientations for the trainings conducted in the U.S. In all cases a pre-departure orientation checklist was used as a basis for discussion and the training implementation plan was discussed in detail with the participants. Each pre-departure orientation included a session on action planning during which the participants were given a document that includes guidelines on action planning and a sample action plan format.

In the case of sending training participants to US and third country trainings World Learning/Azerbaijan staff provided pre-departure processing services and orientation. This included:

- Pre-departure orientations in accordance with ADS 253 that cover required logistical issues and focus on objective setting session with trainees,
- ▶ J-1 visa processing, including entering participants' data into TraiNET, receiving signed DS2019, filling out visa applications and their submission to the US Embassy Consular Section,
- > Third country visa processing, including filling out visa applications and their submission to a consulate,
- English Language Testing, if needed,
- Coordination of medical clearances and enrollment of participants in USAID's health and accident insurance plan,
- > International travel arrangements including meeting of participants and lodging arrangements required during layover stops,
- Preparation of a Training Implementation Plan for each training program for USAID approval,
- Explanation to participants on US Government's and USAID's role in funding their training as well as the objectives of USAID's development assistance program and how the particular program fits into these objectives.

ADMINISTRATIVE ARRANGEMENTS FOR PARTICIPANTS (ORIENTATION IN USA, PAYMENTS AND FINANCIAL SERVICES, HAC, TAX):

To prepare participants for training to ensure that administrative requirements go smoothly.

During this second half of CY2003, World Learning and IIE have conducted 8 orientation meetings for 10 participants of 8 UST programs:

Masters Program (7 participants)
CDC Business Case Winners Study Tour (3 participants)

All the participants were enrolled in Health and Accident Coverage (HAC) with the assistance of IIE. During orientation meetings the participants were paid their M&IE, as well as other payments for ground transportation and airport transfers. IIE dealt with tax payment issues. All the participants passed medical examination in German Clinic located in Baku.

POST-TRAINING FOLLOW-UP:

To build networks and relationships among alumni and partner organizations to share/exchange information, lessons learned and provide mutual support; to provide needed interventions so that trainees apply their new skills/knowledge in their workplaces.

In order to assess effectiveness of conducted training programs World Learning staff used different evaluation methods such as:

- Exit evaluation questionnaires,
- Action plans,
- Success stories
- > Telephone conversations with participants and training provider offices,
- > Final reports submitted by training providers,
- > TIME

Follow-up debriefings were scheduled for all programs. In addition, World Learning will plan to contact participants within six months of their return to discuss the progress that they have made toward the achievement of their action plans. See <u>Attachment 5</u>: 6-month Post-Training Assessment.

In June 2002 World Learning developed the guidelines for the Follow-on Financing component of the START task order. The guidelines were entitled: "USAID/Caucasus Follow-On Financing Application Kit." The proposed Application Kit included program and budget development guidelines, eligibility requirements and restrictions. To date WL/Azerbaijan hasn't had any requests.

V. LOCAL TRAINING PROVIDER STRENGTHENING

Many World Learning programs focused on strengthening local training institutions. World Learning has competitively bid out several training interventions to local training providers and having worked closely with them has increased their training and institutional capacity. These local organizations have complied with USG financial reporting standards as well as local accounting laws, strengthened their evaluation and monitoring techniques of training activities and increased their ability to manage both the technical side as well as the logistical side of training management.

The following activities have been implemented:

➤ World Learning contracted with a local NGO to implement several of USAID's SO 3.1 in-country training activities. Azerbaijan Community Development Resource Training and Research Center (ACDRTRC) conducted trainings on "Presentation and Communication Skills, Conflict Resolution and Negotiation Skills - Imishli", "Presentation and Communication Skills, Conflict Resolution and Negotiation Skills - Nakhchivan I", "Presentation and Communication Skills, Conflict Resolution and Negotiation Skills - Nakhchivan II" and "Cluster Regional Planning. Networking. Coalition Building".

- On competitive basis two training providers were chosen among local NGOs to conduct training for SO 2.1 on "Economic Cost of Corruption". NGO "Saniya" conducted the first component of the program, which was Cartoon and Essay Competition among high school and university students. NGO Internews conducted the second component of the program, which was Nationwide Journalist Competition.
- ➤ Local NGO "Umid" together with its partner local NGO "Simurg" was selected as a training provider on competitive basis for Public Education and Outreach Program in the frame of The State Program on Poverty Reduction and Economic Development, SO 2.1. The training is on-going during this period.

World Learning has also focused on strengthening the training capacity of local institutions by hosting qualified western experts that transfer training knowledge, skills and curricula development:

Highly qualified international banking consultants worked closely with the local organization Azerbaijan Bank Training Center (ABTC) to conduct a series of bank trainings. During the first part of the day, the international experts conducted trainings at the training center for local commercial banks. The afternoon sessions include a training-of-trainer sessions for the ABTC trainers which focused on developing new training modules.

World Learning will conduct a proposal writing and management workshop. The workshop will focus on how potential training providers can better address the requirements of requests for training proposals (RFTP), the importance of basing training program design on the approved objectives, budget development and financial reporting.

VI. PROGRESS ON GENDER DEVELOPMENT

When participant lists are being developed for individual programs, World Learning is careful to ask the nominating officials to consider the nomination of women who match the approved participant profile indicators. This is especially important in sectors where initial participant lists more often than not yield only men. When asked to consider gender when developing participant lists, partners are often able to include appropriate female candidates in the participant lists. World Learning will continue to promote women by looking for creative and effective ways to encourage partners to make participant nominations from a base of equality.

TAXATION/LEGAL ISSUES

VAT: World Learning has been working closely with USAID in terms of filing for VAT refunds with the local tax inspectorate. During this period World Learning requested and received a total VAT refund in the amount of 17,130,592 AZM.

REGISTRATION: The World Learning office was officially registered as an affilial international NGO with the Ministry of Justice on April 24, 2003.

Monthly, quarterly, semi-annual and annual reports are sent to WL Washington, USAID Tbilisi and USAID Baku offices. Monthly reports are in the form of a monthly pipeline.

Context:

Both the legal infrastructure and the parliament are ill-equipped and poorly organized to play an active role in Azerbaijan's transitional democracy. It is often difficult for lawyers to obtain access to pertinent legal codes and other law publications required to represent clients effectively. Laws and decrees are not published in a timely manner in Azerbaijan.

Legislative drafting remains tightly in the control of a few individuals and under the directive of the Presidential Apparatus. As part of its Council Of Europe (COE) succession, Azerbaijan has taken steps to pass a number of weak but required laws with little regard for the implementation of these newly passed laws. It is critical that the implementation of well-drafted democratic laws in Azerbaijan and the transfer of control of legislative initiatives from the Presidential Apparatus to the Milli Mejlis (Parliament) take place. Additionally, civil society representatives should be more active in the development and implementation of legislation. These important changes are seen as critical to a stable and prosperous Azerbaijan.

Organizational Objectives:

By strengthening legislative drafting skills of members of the Presidential Apparatus, members of the Parliament and civil society, the implementation of Azerbaijan laws and policies will be more transparent, relevant and enforced. Civil society representatives should play a more active role in the development and implementation of legislation in Azerbaijan in order to create a stable and prosperous Azerbaijan.

While Anar Kazimov practices law in a private legal firm he is at the same time a well-known legislator in the country in the field of non-profit legislation. As a civil society representative involved in this field for several years advocating for quality and democratic laws, improving his legislative drafting skills will ensure the a more transparent legal system which is inclusive of civil society concerns.

Primary Location:

(UST) New Orleans, Louisiana, USA, June 16-27, 2003; (ICT) Baku, Azerbaijan, August 25-September 2, 2003

Nine Azerbaijani representatives attended the "International Legislative Drafting Institute" in New Orleans, Louisiana. American legislative drafters, lobbyists, academia, agency personnel, and legislators exposed the participants to the preparation processes of a variety of legislative instruments including bills and resolutions, constitutional amendments, ordinances, appropriations, agency regulations and committee and floor amendments. Participants were exposed to the ethics of drafting, confidentiality, matters of style (gender-neutral language, grammar, and punctuation), agency rulemaking, constitutional revision, international trade agreements, and codification agencies. Participants learned of the importance of public participation and the appropriate role interest groups and individuals play in the legislative process.

To strengthen the application of newly acquired skills and knowledge on legislative drafting, an Azerbaijan-based training followed. This program ensured that skills learned are applied including the development of a drafting office/institute at the Milli Mejlis (parliament) and in the civil society. In August and September 2003 the National Conference of State Legislatures conducted a 10-day program of training and assistance to improve legislative drafting in Azerbaijan.

Outcomes of Training:

Since his training, Anar Kazimov has attended several meetings in the Parliament of the Republic of Azerbaija and has arranged roundtables and meetings with media representatives specific to a draft law on "Registration of Legal Entities and State Register". While having discussions at Parliament, Anar Kazimov put forth several amendments to the draft law. For example, Mr. Kazimov recommended using plain Azeri language to express legal definitions and being consistent throughout the document so that that the populace can understand laws more clearly. Most of the proposals made by Mr. Kazimov were incorporated into the draft law that was sent to the Parliament for the third reading. In December 2003 the law on "Registration of Legal Entities and State Register" was adopted.

Analysis:

Mr. Kazimov's recent achievement demonstrates a more active role by civil society in development and implementation of legislation in Azerbaijan and demonstrates a stronger cooperation between state legislative bodies and civil society that results in legislation that reflects civil society input.

What Next?

During the US training there were several examples of manuals for legislative drafters published in the existing in the US. After the training Anar Kazimov came up to trainers with an idea of drafting a Legislative Drafting Manual that could help lawyers to have general rules on how to draft laws and regulations. That was well supported by trainers interested in drafting this manual together with local experts and trainers. Legislative Drafting Manual would be a good tool for young lawyers and students willing to draft a law or regulation.

Testimony:

Mr. Fazil Mamedov, Head of the Department of Registration of Legal Entities of the Ministry of Justice, Ms. Elmira Suleymanova, Head of Ombudsman Apparatus, and Mssrs. Ali Huseynov and Latif Huseynov, Parliament representatives expressed their support of Mr. Kazimov's proposals and expressed their gratitude for the valuable recommendations.

SUCCESS STORY ON ECONOMIC COSTS OF CORRUPTION PROGRAM

Advocacy Framework

Context:

The level of corruption in Azerbaijan is extremely high. According to the Transparency International Corruption Perception Index of 2003, Azerbaijan is ranked 125 out of 133 countries in terms of level of corruption. Azerbaijan also ranks as the most corrupt countries within the former Soviet Union, according to the IMF and World Bank research, although recent data shows slight improvement in this area (Source: Information by Turan news agency, December 24, 2002).

Objectives:

Overall, the ultimate goal of the project was to raise public awareness amongst the population of Azerbaijan regarding corruption and its consequences for social and economic development. The project clearly displayed that the public is being threatened by overwhelming corruption destroying every sphere of public life, and it's critical for the public to take individual responsibility for this.

Description of Project:

General Field of Study: Anti-corruption/economic development

Title: Economic Cost Of Corruption

Training Provider: Internews Azerbaijan Public Association

Primary Location: Baku and regions, Azerbaijan, May-September 2003

A newspaper article competition for 30 journalists was held covering the same economic cost of corruption theme. In total, 35 articles were submitted which analyzed corruption problem in various spheres of public life. The articles were published in more than 10 popular national newspapers that reached a reading audience of roughly 300,000 people and successfully generated public discussions on the topic. Three journalists were awarded recognition for their submissions.

Simultaneously, a TV program competition for journalists on the topic of "Economic cost of the corruption" was held. According to the results of the competition 4 TV programs

were awarded recognition. Two journalists tied for third place. Approximately 5 million viewers were the potential audience of the television programs.

Subsequently, eight 30 – 58 second public service announcements (PSAs) on the economic cost of the corruption were produced and broadcasted on eight rural non-state TV stations as well as two Baku-based stations. The potential viewing audience of the PSAs was approximately 6.5 million people. Four information sessions were held for 80 journalists from both newspapers and TV.

Outcomes of Training:

In light of the pervasiveness of corruption throughout all sectors of Azeri society, it was a major success to have the PSAs aired on eight regional and 2 capitol-based TV stations. Taking into consideration the corruption rate in Azerbaijan and the amount of state control over the media sector, it was not certain that the PSAs related to corruption would air at all. The newspaper journalist competition set the stage perfectly for the airing of the PSAs in that set the framework for serious discussion on the topic in society. This affected both the government and the ruling board, in particular those state-controlled mass media outlets.

It is notable that the PSAs were broadcast between 15 September and 13 October 2003 just before the Azerbaijan presidential election.

Analysis:

The journalist competition and the airing of public service announcement raised public awareness on corruption and the economic costs associated with it. By personalizing the costs of corruption, the general public gains a sense of responsibility in putting a stop to corruption and denying the social acceptance of it. At the state level, corruption issues were raised in many institutions and within Parliament. Recently the law "On Combating Corruption" was adopted through the third reading at the Milli Mejlis.

Context:

As a post communist country, Azerbaijan's independent media and journalism are just developing. Azerbaijan has made little headway in realizing democratic principles. The government has a poor human rights record. Violations of citizens' political and civil rights are commonplace. The judiciary remains an instrument of the executive branch, and

corruption is known to be widespread. All of the national elections held in the past ten years for the presidency, parliament and local councils have fallen short of internationally accepted standards. Opposition political parties are oppressed. Non governmental organizations are very impoverished and face numerous difficult bureaucratic and attitudinal obstacles. There is a low level of political awareness among citizens, which is in part a function of state domination of the media. Independent media outlets are faced with restrictions on press freedom, including constraints on licensing and frequency allocation and lack of skills and know-how among print and broadcast journalists. Such restrictions constitute major barriers to a better informed, politically-active citizenry and to the democratic process.

Organizational Objectives:

Rashid Hajili is a Director of Internews' newly established "Institute for Media Defense, Education and Advocacy". The Institute strives to provide analysis, legislative drafting, advocacy and information dissemination services. The Institute's lawyers analyze and strive to improve media legislation. This includes sound, internationally accepted regulations and policies governing the creation and operation of Public TV in Azerbaijan, and drafting amendments and improvements to media-related laws such as Mass Media and the TV broadcast law. Based on research the Institute issues timely alerts and/or analyses of pending or passed legislation. The institute publishes brochures and books on journalists' rights and national and comparative international media law, in order to build capacity among media lawyers and media outlets. The Institute conducts roundtables and seminars to build capacity and to increase participation in legislative reforms.

Description of Training:

The Forum meeting in Seoul will bring together a diverse group of democracy support organizations, representatives of civil society, trade unions, the business community, party and political leaders and other democracy experts to develop a plan of action to expand and strengthen democracy throughout the world. Working groups meeting at the Forum will make recommendations that will help define priorities on the basic challenges facing democracy practitioners in the period ahead.

The Non-Governmental Forum discussed the major challenges to democracy, and offered recommendation for formulating strategy in seven Regional and eight Topical Workshops. The international NGO leaders would make final recommendations for action on how to expand and strengthen democracy in their report to the Ministerial Meeting at the Plenary Session.

The second non-governmental forum conference consists of plenary sessions, regional workshops and thematic workshops. The plenary sessions will focus on the participants' common interest of sharing a universal value of democracy with others; the regional workshops will focus on the participants' identity as residents of a particular region; and thematic workshops will focus on experts of particular themes and issues.

General Field of Study: Communications/Media

Title: Community of Democracies Non-Governmental Forum Training Provider: The Council for a Community of Democracies (CCD)

Primary Location: (TCT) Seoul, Korea, October 2002

Outcomes of Training:

Rashid Hajili especially appreciated gaining information on media-government relations in other countries, media's role in democratic societies, and media's independence and legal basis of professionalism. As a member of parliament's working group to draft the "Law on TV and Radio" and "Public Broadcast", Rashid Hajili directly represented civil society's interest in this law. Specifically, Mr. Hajili's proposals supported making the proposed public television station completely independent from state control. The draft law recommended that the proposed public television be under the control of the state television, including budgetary control, sharing of physical space and being under the control of a directorate that was appointed directly by the Presidential Apparat. His recommendations included establishing a small income taxes increase in order to provide financing for the public station, thus remove state control, separating the proposed public television completely from State television and ensuring that directorate of the public television would not be affiliated with the State. Rashid Hajili's comments and ideas were highlighted in the Milli Mejlis and appreciated by the democratic circles, but unfortunately were declined by the parliament.

Amongst many other trainings, Rashid Hajili organized eight round tables with the participation of media lawyers, journalists, newspaper editors on different urgent problems associated media law, such as the independence of public broadcast, issues of compensation for moral injuries in court verdicts regarding defamation, legal problems of TV and Radio activities, etc. within the Institute for Media Defense.

According to Rashid Hajili, the knowledge that he gained in the training conference and the relations he has built with colleagues from other countries made him more active in his strive to built a more developed Media and increased his thirst for a more opportunities for independent Mass Media in Azerbaijan. The contacts that he made in 2002 conference allowed him to find outside source to fund his participation in 2003 Community of Democracies Non-Governmental Forum in Romania in November 2003.

What Next?

Rashid Hajili's continues working to promote and develop media related legislation and find solutions to legal issues faced by members of media community in Azerbaijan in the Media Rights Institute. He continues to assist by analyzing and commenting on media related legislative acts and decrees; drafting and preparation of media related laws based on the principles of free and independent media and democratic society; suggesting improvements to existing media laws and informing media, lawyers, NGOs, international agencies, monitoring groups, diplomatic missions and community at large; supporting and defending independent media from external pressures; participating in the court hearings on the media side and providing legal defense and advice; free legal advice; providing free legal advice to representatives of independent media; publication and free distribution of books in order to establish media legislation; round tables; seminars and training courses.
