Dear Mr. Koval:

Pursuant to the authority contained in the Foreign Assistance Act of 1961, as amended, the Agency for International Development (hereinafter referred to as "A.I.D.") hereby amends the above referenced Cooperative Agreement dated May 25, 1988, and amended on August 3, 1988, with the Council for International Development (hereby referred to as C.I.D. or "Recipient") by modifying Attachment I and Attachment II to the Cooperative Agreement, as follows:

The Attached Revised Illustrative Financial Plan substitutes in its entirety the Illustrative Financial Plan contained in subsection D.1 of Attachment I, entitled the Schedule, of the subject Agreement.

Section H of Attachment I, "Schedule," is deleted in its entirety and substituted for the following therefor:

H. Title to Property

"Title to all property financed under this Grant shall vest in COMCORDE subject to the conditions specified under Standard Provision No. 20 entitled "Title to and use of Property (Grantee Title)."

Prior to receipt of title to property financed under the Grant, COMCORDE shall provide to C.I.D. and A.I.D. a statement, in writing and duly ratified by its Board of Directors, in which the Institution agrees to use all property financed under the Grant for purposes consistent with the Grant.

Within 30 days after the termination of the Cooperative Agreement with C.I.D., C.I.D. agrees to provide to USAID/El Salvador with a list of all property financed under the Grant which has been transferred to COMCORDE.

Section III of Attachment II, the Program Description, Project Objectives, point 1, is hereby deleted in its entirety, and the following substituted therefor:

1. To provide training, technical assistance, and operational support to the Coordinating Committee for the Development of the Eastern Region (COMCORDE), to enable this organization to carry out its program of activities more efficiently and effectively;

In Section V, of Attachment II, the Program Description, the following subsections D., Operational Support for COMCORDE, and E., A.I.D. Special Activities, are hereby added as follows:

D. Operational Support for COMCORDE

In order to assist COMCORDE in carrying out its functions in support of private enterprise in the Eastern Region, C.I.D. will provide resources made available under the Grant to COMCORDE to cover its operating costs from March 1, 1989, through May 9, 1989. The estimated monthly expenses to be covered are \$15,000.00 for an estimated total of \$36,500.00. This funding will cover personnel, rent and utilities, office expenses, transportation expenses, and other related costs.

E. A.I.D. Special Activities

Under this component, the Grant will finance activities to be mutually agreed between COMCORDE, C.I.D., and A.I.D. within the purpose of the Agreement. These activities will include seminars, workshops, analysis of the economic situation of the region, and other development activities as identified by A.I.D., C.I.D., and COMCORDE.

Please sign the original and six (6) copies of this letter to acknowledge your receipt of this Grant Amendment and return the original and five (5) copies to USAID/El Salvador.
