The International Trade Centre (ITC), with support from the USAID/U.S. State Department ASEAN-US Technical Assistance and Training Facility, conducted a workshop for ASEAN trade and commerce ministries 19-22 November, 2007 in Jakarta, Indonesia. 34 participants from seven ASEAN Member Countries and the ASEAN Secretariat participated in the training to learn how ITC tools could help them in trade negotiations. The workshop was designed to demonstrate, through interactive group case studies, hot to use ITC data and analytical tools to apply a scientific approach to prepare trade negotiating positions.

Mr. Mondher Mimouni and Mr. Mathieu Lamolle of the ITC, led the workshop. On the first day, Mr. Taufik Ismail of the Indonesian Customs Office gave a presentation about the use of the Harmonized System of tariff nomenclature, as the ASEAN harmonized tariff nomenclature (AHTN) system. The ITC representatives then provided an overview of the ITC Trade Map and Market Access Map Tools. Mr. Mimouni and Lamolle led the workshop in practical exercises based on real and hypothetical data to demonstrate the use of the tools.

In the latter portion of the workshop, participants focused on using the tools to formulate national trade negotiations positions and identify sensitive lists. The tools, though primarily used by national export agencies as trade promotion/opportunity tools, revealed themselves to be highly useful to negotiators. Participants learned how the tools could be used to generate tariff reduction scenarios. The tools could also be used to develop a regional negotiation position.

Though a slow internet connection hampered the live tests a bit, the speakers improvised and came up with creative solutions to relay information about the tools. Participants were pleased with the workshop, with 80% saying that it "significantly achieved" the objectives. Participants rated ITC speakers well, agreeing that the presentations were generally "very good." While the poor internet connection was repeatedly cited as the worst aspect of the workshop, the course content, knowledgeable and helpful speakers, and practical exercises were repeatedly complimented in participant evaluations.

Participants requested more training in the future to further refine their understanding of the tools. A follow up meeting between the ITC and the ASEAN Secretariat, facilitated by USAID and the ASEAN-US Facility, discussed other potential activities for follow up. These included a two day case study ran with the same group of participants on a particular subject (e.g. agriculture) and an exercise to use the tools to analyze a regional negotiation position. ITC representatives also stated their willingness to support ASEAN in data harmonization exercises or to include more ASEAN Member Countries in the joint UNCTAD, World Bank, World Trade Organization and ITC project on cataloguing and removing non-tariff barriers. Two ASEAN Member Countries, the Philippines and Thailand are already a part of this pilot project. The ASEAN Secretariat plans to submit a formal request for follow up assistance in the coming month.
