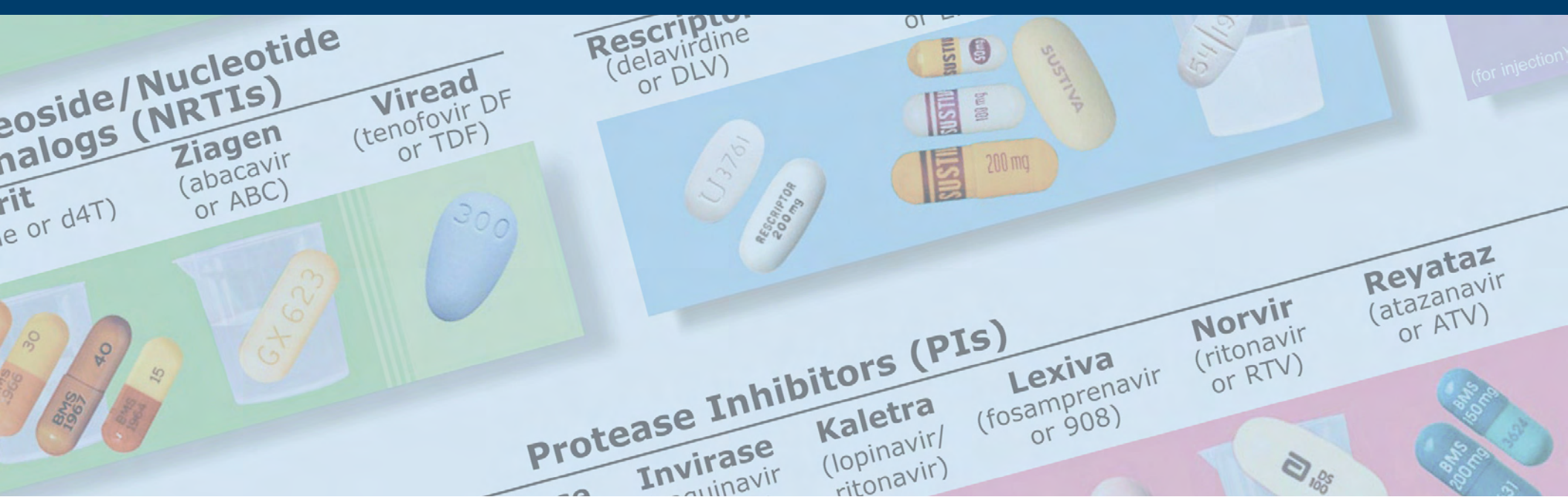

Abstract
