Dear Mr. Prime Minister:

This is in further reference to my letter of February 16, 1971 and my letter of this date regarding your request for USAID providing specialized training for Ronald M. Gordon. I am pleased to be able to advise you that we have been able to work out a program and Mr. Gordon has been accepted by the University of Massachusetts for the semester beginning September 5, 1971. We will be providing the sum of US\$3,500 to finance a full year of graduate training for Mr. Gordon at the University of Massachusetts, in the Department of Food Science and Technology. The University estimates that Mr. Gordon's expenses for the fall and spring semesters and the eight weeks summer session will cost US\$2,957 and the attached exhibit details these costs.

I am increasing the grant from approximately \$3,000 to US\$3,500 since these estimates are based on 1970-1971 University costs and there might be some slight increase for the 1971-1972 academic year. The method of financing Mr. Gordon's expenses will be to deposit the US\$3,500 in the First National Bank of Amherst, Massachusetts. Mr. Gordon's withdrawals for all his expenses will be from this bank account and the withdrawals will be countersigned by a staff member of the Department of Food Science. In this way we can be assured that Mr. Gordon will have adequate funds for his expenses for the 1971-1972 semesters and the summer session.

Several conditions must be met for us to make this special grant operational. One, Mr. Gordon's regular salary and emoluments must continue during the time he is at the University of Massachusetts. The amount of the grant is based on the minimum expenses that a student would have and of course makes very little allowance for personal expenses, clothing and the like. Two, the Government of Guyana in accordance with our regular procedure will provide

Mr. Gordon with an economy class round trip ticket to the U.S., the estimated cost of which is US\$400. Three, the Government of Guyana and USAID would carefully monitor Mr. Gordon's progress with the understanding that Mr. Gordon will diligently apply himself to his graduate studies and given his background and ability would strive for top marks. The Government of Guyana would give serious consideration to providing in next year's budget appropriate funds for Mr. Gordon to complete his training since the entire program is estimated to take between eighteen and twenty months. The funds provided under the grant are to cover at least twelve months of training and of course any funds remaining at the end of the twelve months could be applied to additional training but the remainder would be to the account of the Government of Guyana. The Government of Guyana would to the best of its ability assure that Mr. Gordon would return to Guyana at the end of his graduate program and be gainfully employed within the Government service.

If the above proposals meet with your approval I should appreciate your signing the second copy of this letter and returning it to me. We would then prepare a normal project agreement which we would ask you to sign on behalf of the Government of Guyana and the program could get under way.

I am pleased that we have been able to make the arrangements described above, for we do not normally provide training that would lead toward a university graduate degree, but I have been impressed by Mr. Gordon and the potential he has and have involved myself personally in working out these arrangements. I am taking the liberty of sending copies of this letter to Mr. Arthur W. Boatin, Foreign Student Adviser at the University of Massachusetts, who has been very helpful in arranging this program and to Dr. W.B. Esselen, Head of the Department of Food Science and Technology at the University of Massachusetts, who has been also involved in making these arrangements and who will be responsible for Mr. Gordon's work at the University.
