AS A RESULT OF THE DAEC MEETING, THE SUBJECT PROP HAS BEEN APPROVED WITH THE FOLLOWING MODIFICATIONS AND SUGGESTIONS.

1. MEASURES TO SAFEGUARD PROGRAM QUALITY: IN THE VIEW OF THE DAEC, SOME PROJECT ACCOMPLISHMENTS HAVE BEEN, TO A LARGE EXTENT THE RESULT OF CAREFUL PROJECT PREPARATION AND EXECUTION. THIS IN PART, HAS BEEN MADE POSSIBLE BY TIMELY INPUTS

5. COMBINING THE GRANT AND LOAN: SINCE THE PROP AND THE PROPOSED LOAN PROVIDE FINANCING FOR THE SAME PROJECT, THE MISSION SHOULD CONSIDER THE FEASIBILITY OF PHASING DOWN GRANT ASSISTANCE MORE RAPIDLY ONCE THE LOAN IS INITIATED AND SUBSUMING A PORTION OF THE GRANT FUNDING UNDER THE LOAN. HOWEVER, THIS CONSIDERATION SHOULD BE SUBORDINATED TO MAINTAINING THE NECESSARY QUALITY AND LEVEL OF TECHNICAL ASSISTANCE.

6. CONTRACT ARRANGEMENTS: THE DAEC AGREED, IN PRINCIPLE, THAT THE USE OF AED IS IMPORTANT, IF NOT CRITICAL TO THE SUCCESS OF THE PROJECT AND THAT A CONTRACT AMENDMENT OR NEW CONTRACT WITH AED FOR THE SUBJECT PROJECT WOULD BE JUSTIFIED ON THE BASIS OF ITS PREDOMINANT COMPETENCE. THESE CONCLUSIONS ARE SUBJECT TO A FINAL DETERMINATION BY AID/W, WHICH WILL BE MADE ON THE BASIS OF THE PRO/T TO BE SUBMITTED BY USAID.

7. THE PROJECT NUMBER HAS BEEN ADJUSTED IN ACCORDANCE WITH THE FY 75 CONGRESSIONAL PRESENTATION.
