Dear Dr. Weintraub:

Pursuant to the authority contained in the Foreign Assistance Act of 1961, as amended, the subject Grant is hereby amended to provide an additional \$3,500,000 in funding plus 74,646,000 pieces of condoms and 16,161,600 monthly cycles of oral contraceptives for the continuation of family planning activities fully described in Attachment A to this Grant, entitled "Program Description".

The total cumulative obligation of funds to this Grant is now \$27,720,317 and shall apply to commitments made by the Grantee in furtherance of program objectives during the period 10/1/75 through 12/31/78. Subject to their availability, additional funds may be provided.

The total cumulative AID contribution of contraceptive commodities total 32,161,600 cycles of oral contraceptives and 279,013,968 pieces of condoms in furtherance of program objectives during the period 10/1/75 through 12/31/78.

a. Delete the "Obligated Funds" column in its entirety and substitute in lieu thereof the following:

a. Delete the applicability statement and substitute the following in lieu thereof:

'(This provision is applicable when the sum of all advances under the Grantee's contracts and grants with AID exceeds \$120,000 per annum and AID has, or expects to have, a continuing relationship with the Grantee for at least a year.)'

b. Delete the term 'TUS' in paragraphs (a), (d)(4)(A), (d)(4)(C), and (d)(5) and substitute the term 'TFS' in lieu thereof.

c. Delete the term 'SER/FM' wherever it appears in paragraph (c) and substitute the term 'the AID Controller' in lieu thereof; also delete the term 'Office of Financial Management' in paragraph (d)(7) and substitute the term 'the AID Controller' in lieu thereof.

d. Delete the figures '\$10,000' and '\$1,000,000' in paragraph (a) and substitute the figures '\$5,000' and '\$5,000,000', respectively, in lieu thereof.

e. Delete the words 'less than' in paragraph (d)(7) and substitute the words 'more than' in lieu thereof.

Except as expressly herein amended, the subject Grant is in all respects ratified, confirmed, and continued in full force and effect in accordance with its terms.




