Dear Mr. Burnelli:

Pursuant to the authority contained in the Foreign Assistance Act of 1961, as amended, the Agency for International Development (hereinafter referred to as "A.I.D." or "Grantor") hereby provides the Associazione di Cooperazione allo Sviluppo/Italy (hereinafter referred to as "ACS" or "Grantee") the sum of Three Hundred Ten Thousand Eight Hundred Seventy Nine Dollars (\$310,879.00) in support of a village resettlement project in Sulaymaniyah Governorate, northern Iraq, as more fully described in Attachment 1 of the Grant entitled "Schedule" and the ACS proposal No. 1211/IRQ/95/fq, dated May 26 1995, which is incorporated herein by reference.

This Grant is effective and obligation is made as of the date of this cover letter and shall apply to commitments and expenditures made and/or incurred by the Grantee in furtherance of the project objectives during the period August 7, 1995 to August 6, 1996.

The total cost of the program is \$878,821.00 of which A.I.D.'S contribution shall be \$310,879.00 which is hereby obligated. A.I.D. shall not be liable for reimbursing the Grantee for any costs in excess of the obligated amount.

This Grant is made to the Grantee on condition that the funds will be administered in accordance with the terms and conditions as set forth in Attachment 1, the Schedule; Attachment 2, Standard Provisions for Grants to Non-U.S., Non-Governmental Organizations; Attachment No. 3, Required as Applicable Standard Provisions for Non-U.S., Non-Governmental Organizations; and the Grantee's application, cited above, which have been agreed to by your organization.


