Dear Mr. Kohl:

Pursuant to the authority contained in the Foreign Assistance Act of 1961, as amended, the Agency for International Development (A.I.D.) hereby provides to the Cooperative League of the USA (hereinafter referred to as "CLUSA" or "Recipient") the sum of Four Hundred Seventeen Thousand Dollars (\$417,000) in continuation of the program entitled "International Cooperative Trade Promotion," as more fully described in Attachment B to the agreement, entitled "Program Description."

The total cumulative obligation under this agreement is \$1,874,000, which shall apply to commitments made by the Recipient in furtherance of program objectives from the period January 1, 1985 to December 31, 1987.

The total estimated amount of the program, \$1,874,000, is now obligated. AID shall not be liable for reimbursing the Recipient for any costs in excess of the obligated amount. It is anticipated that the obligated amount will be sufficient through the estimated completion date of December 31, 1987.

This Cooperative Agreement is made to the Recipient on condition that the funds will be administered in accordance with the terms and conditions as set forth in this Cover Letter, Attachment A entitled "Schedule," Attachment B entitled "Program Description," and Attachment C entitled "Mandatory Standard Provisions and Optional Standard Provisions," which constitute the complete Cooperative Agreement and have been agreed to by your organization.

Specific changes to the Agreement are as follows:

ARTICLE II - Funds Obligated, Payment, and Estimated Costs

Paragraph A : Delete in its entirety. Replace with:

"A. The total estimated amount of this Agreement for the period shown in Article IV. below is \$1,847,000."

Paragraph B : Delete in its entirety. Replace with:

"B. AID hereby obligates the amount of \$1,847,000 for program expenditures during the period set forth in Article IV below and as shown in the Budget (Article VII) below."

Replace the existing budget table with the following table:


