Grant Agreement Amendment, dated the th day of October, 1983, between the Government of the Republic of Lebanon ("Grantee") acting through the Council for Development and Reconstruction ("CDR") and the Government of the United States of America, acting through the Agency for International Development ("A.I.D."), together referred to as the "Parties".

Whereas, the Parties have heretofore entered into an agreement dated February 8, 1983 (the "Grant Agreement") for the financing of telecommunications rehabilitation (the "Project"), pursuant to which A.I.D. agreed to grant the Republic of Lebanon seven million seven hundred thousand United States Dollars (\$7,700,000) and

Whereas, it is the mutual agreement of the Parties to proceed with the Project.

Now therefore, the Parties hereto agree that the Grant Agreement shall be and hereby is amended by making the following change:

The provision in Article 3, Section 3.1, "seven million seven hundred thousand United States Dollars (\$7,700,000)", is deleted and substituted therefore is the provision, "eleven million seven hundred thousand United States Dollars (\$11,700,000)".

The provision of Article 3, Section 3.3(a), "January 31, 1984", is deleted and substituted therefore is the provision "June 30, 1984".


An amendment to Annex I to the Grant Agreement is attached hereto.


