This AMENDMENT no. 1, entered into between the REPUBLIC OF INDONESIA ("Grantee") and the UNITED STATES OF AMERICA, acting through the AGENCY FOR INTERNATIONAL DEVELOPMENT ("A.I.D."),

WITNESSETH THAT

WHEREAS, the Grantee and A.I.D. entered into a Grant Agreement, on June 1, 1979 ("Grant Agreement"), whereby A.I.D. agreed to grant to the Grantee up to one million two hundred thousand United States dollars (\$1,200,000) ("Grant") to assist in financing Grantee's program to enable the provincial and lower levels of government in Bengkulu, South Kalimantan, Nusa Tenggara Timur and East Java Provinces to improve their capability for the identification, planning, implementation, management and evaluation of rural/area development projects and activities that reach and assist the rural poor; and

WHEREAS, the Grantee and A.I.D. desire to amend the Grant Agreement to add two additional provinces and three million United States dollars (\$3,000,000) to the Grant, as hereinafter set forth;

NOW, THEREFORE, the Grantee and A.I.D. hereby agree as follows:

1. Section 2. 1. Definition of Project is revised to add the two additional provinces of West Java and Nusa Tenggara Barat.

2. The first paragraph of Section 3. 1 is revised to read as follows:

"Section 3. 1. The Grant. To assist the Grantee to meet the costs of carrying out the Project, A.I.D., pursuant to the Foreign Assistance Act of 1961 as amended, agrees to grant the Grantee under the terms of this Agreement not to exceed four million two hundred thousand United States ("U. S.") dollars (\$4,200,000) ("Grant").

3. Section 3. 3. Project Assistance Completion Date. Section 3. 3(a), is revised to extend the project assistance completion date from May 23, 1984 to May 23, 1985.

4. Except as hereinabove expressly amended, the Grant Agreement is ratified, confirmed and continued in full force and effect in accordance with all of its terms.

IN WITNESS WHEREOF, the Grantee and the United States of America, each acting through its respective

duly authorized representative, have caused this Amendment No. 1 to be signed in their names and delivered as of the day and year first above written.
