12. STATEMENT OF PURPOSE

A. Small Project Assistance (SPA) Program. The purpose of the SPA Program is to finance small village level activities by Peace Corps ('PC') Volunteers and selected by the P Principal Country Representative in the Central African Republic. The Program is designed to encourage and support self-help efforts by local communities by funding projects directly.

B. Governing Provisions. The Peace Corps agrees to provide the services outlined in 12.A above, in accordance with the 'Memorandum of Understanding between AID and the PC on the Use of SPA Funds', dated January 28, 1983 and the following appendices to this agreement: 'Approval Process and Financial Procedures' (Appendix A) and 'SPA Program Guidance and Procedures' (Appendix B).

C. This amendment provides an increment of \$40,000 for Fiscal Year 1986. Except as amended herein, the SPA Program Country Agreement dated June 8, 1983 between AID and the PC remains in full force and effect.
