Food Security III Cooperative Agreement Progress Report for FY 2010

Introduction

The purpose of this report is to provide a brief overview of FS III activities for Fiscal Year 2010 (October 1, 2009 through September 30, 2010). The report covers highlights of the activities and accomplishments of the FS III Leader Award and Associate Awards, including a comparison of outputs versus work plan targets for the Leader Award.¹ The overview and accomplishments sections will be followed by Annexes that contain additional details on funding by award; project personnel; publications, presentations, and outreach/training workshops; and a guide to key FS III Web sites.

Other forms of reporting on FS III activities and accomplishments include: (a) regularly updated Web sites, including a site dedicated to administrative and management information (such as financial reports) accessible to the FS III AOTR, (b) regular MSU International Development Updates (covering publication, outreach and training activities) disseminated to USAID staff, (c) submission of results data through the annual EGAT and IEHA reporting spreadsheets, (d) regular submission of FS III publications to USAID/Development Experience Clearinghouse; and (e) written and oral reporting at our annual joint FS III/USAID review and planning meetings (usually in October or November).

Overview of Activities

The FS III Cooperative Agreement (CA) consists of a Leader Award and a set of Associate Awards. FS III is implemented by a group of faculty within the Department of Agricultural, Food and Resource Economics (AFRE). During 2010², the Leader Award was supported by \$500,000 in core funding³ from the Economic Growth, Agriculture and Trade Bureau of USAID. Functions of the Leader Award include overall management of the CA, support for obtaining new associate awards and managing existing ones, support for preparation of publications that synthesize insights gained from country and regional activities, and support for outreach activities, including maintenance of the Food Security III Web site.

Thematic areas addressed under the overall CA during 2010 were:

1. Agricultural technology and natural resource management
2. Growth-enhancing food system and output market development
3. Strategies to strengthen foundations of rural growth, poverty alleviation and structural transformation
4. Understanding vulnerability and managing food aid for long-term development
5. Strengthening policy research, outreach, and capacity building, and access to training materials

In 2010, associate awards were supported by USAID country missions in Mali, Mozambique and Zambia, and by the Africa Bureau of USAID. FS III project personnel are also involved in other international development research, training, and outreach projects managed through AFRE, some funded by USAID but not through Associate Awards, and some funded by other donors. The term “Food Security Group” refers to these faculty members and the larger set of projects, of which FS III is the cornerstone.

FS III Leader Award

Major activities under the Leader Award⁴ in 2010 included:

- Core support for FS III Associate Awards funded by the Mali, Mozambique, and Zambia missions, and an Associate Award funded by AFR/SD.
- Preparation of specific outputs identified in the work plan for completion in FY 2010:
 - A policy brief summarizing lessons learned from the past 25 years of applied research, outreach and capacity-building by the MSU FSG.⁵ This was based on a longer working paper produced in September 2009⁶ and discussed with AOTR Philip Steffen during his October 14-16, 2009, visit to MSU.
 - A concept paper on the use of regional food market sheds as a tool for USAID and CAADP food security policy, planning, and investment priority setting. A planned extension of this work to West Africa was initiated and an outline of a paper discussed with USAID/EGAT staff in September 2009. A draft paper developing the approach, together with food shed maps for sorghum and millet, and rice, was presented to AOTR Anne Williams and Activity Manager Steffen during their November 2-4, 2010, visit to MSU. Related presentations were made by Steve Haggblade (see Annex 3, section I.D).
 - A paper reporting a cross-country analysis of the potential inter-generational impacts of HIV/AIDS through loss of child schooling following adult mortality. The paper was to add analysis of data from Mozambique to earlier work in Kenya. A draft report has been prepared, and preliminary results of this study were presented to AOTR Williams and Activity Manager Steffen during their November 2010 visit to MSU.⁷ The draft report is currently being revised to incorporate further analysis.

Africa Bureau Associate Award. *Support to COMESA and CAADP*

The purpose of this award is to mobilize the expertise and analytical resources of FS III personnel to support COMESA's efforts at regional and country levels to implement CAADP Pillar 3 activities promoting food and nutrition security and dealing with the challenges of the vulnerable and food-insecure populations. Specific objectives are to conduct applied research, policy analysis and outreach relevant to achieving Pillar 3 objectives, to participate in selected COMESA planning meetings, and to contribute to building the capacity of COMESA and its partner organizations to conduct policy analysis and policy dialogue.

In September 2009, a no-cost extension of the Associate Award was granted through February 2010. USAID/AFR staff invited a proposal for additional funding to cover activities through the remainder of FY 2010. This proposal was submitted on December 16, 2009, and approved through September 30, 2010 with additional funding of \$250,000.

Highlights of 2010 activities related to the above objectives include:⁸

1. Support for CAADP Compact Design and Implementation

Significant progress was made toward completing a CAADP country compact for Zambia (with signing scheduled for January 18, 2011), and preparing for the launch of the CAADP country compact process in Mozambique, originally scheduled for December 13, 2010.⁹ Analytical support for the COMESA regional compact was completed. The regional compact will be reviewed and adjusted in the context of tri-partite East African Community discussions. An active outreach program was undertaken to support an improved policy environment regional trade, and training for policy analysts was conducted through the COMESA-funded African Agricultural Markets Program (AAMP). At the request of Africa Bureau, faculty members Jayne and Crawford conducted an all-day informal briefing session July 8, 2010, on topics related to Feed the Future Investment plans in the COMESA region. Details of all presentations can be found in Annex 3, section II C.

2. Research in support of regional input and output market development

A major study of the impacts of government policies on maize price predictability in Eastern and Southern Africa was completed. Maize is the major traded food staple in the region, and the

political sensitivities make it a critical issue for improved policy. A complementary policy brief on the need for a regional approach to enable staple food productivity growth was also completed. Published outputs resulting from the Africa Bureau Associate Award for 2009 are also listed in Annex 3, section II.

Mali Associate Award. *PROMISAM—Phase II : Projet de Mobilisation des Initiatives en Matière de Sécurité Alimentaire au Mali*

PROMISAM II, funded for the period December 2008–November 2011, originally had four objectives: (i) further enhance and develop the technical and analytical skills for the Malian Food Security Commission (CSA) and related support agencies; (ii) assist Mali in implementing local (commune-level) food security plans country-wide through the developing and testing of methods for monitoring plan implementation; (iii) help IPR/IFRA de Katibougou to develop an academic and practical curriculum in agricultural economics and food policy analysis; and (iv) provide technical support to Mali’s national team developing the country’s NEPAD/CAADP report and national compact.

The FY 2010 work plan added a fifth objective, (v) help to organize a border conference between Senegal and Mali in order to facilitate smoother cross-border trade in agricultural products. A further modification in May 2010 established a sixth objective, by calling on PROMISAM II to (vi) carry out a number of background studies on agricultural development/food security challenges facing Mali over the coming 5-10 years to assist USAID/Mali in its strategic planning of future investments and activities. A seventh objective was added to (vii) address cross-cutting activities that were implicit in this project and that support the overall project as well as the broader economic growth objective of USAID/Mali-AEG. MSU/FS III implements the PROMISAM II project in partnership with the CSA and the Permanent Assembly of the Malian Chambers of Agriculture (APCAM). Other key collaborators include the *Institut Polytechnique Rural de Formation et de Recherche Appliquée* (IPR/IFRA) de Katibougou and the *Institut d’Economie Rurale* (IER).

PROMISAM II represents part of a larger portfolio of applied research, outreach and capacity-strengthening activities on food security implemented by the MSU Food Security Group (FSG) in Mali with funding from an array of sources, including USAID/Mali, USAID/WA, the Syngenta Foundation for Sustainable Agriculture, the William and Flora Hewlett Foundation, the Bill and Melinda Gates foundation, and ECOWAS. The non-USAID/Mali-funded work complements that of PROMISAM II, thus leveraging USAID/Mali’s funding.

Key project achievements during FY 2010 included:

- The successful organization and carrying out of study tours to the U.S. and Canada for 12 Malian food policy, IPR/IFRA and USAID/Mali leaders in April, 2010.
- Organizing and facilitating the participation of the Malian Minister of Agriculture in the May 2010 symposium in Washington at which USAID officially launched its Feed the Future initiative.

- Ongoing technical support and capacity strengthening of the CSA and its affiliated organizations to carry out empirically based policy analysis. This included involvement of CSA and IER economists in the continued implementation of farm-level production and marketing studies that PROMISAM continued to implement during FY 2010.
- The launching of training (in conjunction with PGP-2 and Peace Corps/Mali) of local stakeholders in how to monitor implementation of local-level food security plans in 30 pilot communes in Mali.
- Formal approval and launching of the undergraduate agricultural economics program at IPR/IFRA de Katibougou, with the first class of 30 undergraduates admitted in October, 2009.
- The arrival of two IPR/IFRA junior faculty members at MSU to begin English training in anticipation of their beginning the graduate program in the Department of Agricultural, Food and Resource Economics.
- FS III support to Mali's national CAADP roundtable leading to approval of its CAADP compact in October 2009.
- PROMISAM's continued technical support to the Mali's Planning and Statistics Unit for Rural Development that led to the development of Mali's CAADP Priority National Investment Plan (PNIP), which was subsequently reviewed by a joint ECOWAS/African Union team.
- Preparation of 7 background documents for USAID/Mali June 2010 AEG partners' meeting, and participation of MSU/PROMISAM staff in helping facilitate that meeting.
- Expansion of the number of MSU campus-based faculty members involved in PROMISAM II, in part through their initial participation in the April 2010 study tour of Malians to MSU, Washington, D.C., and Québec, Canada.

Mozambique Associate Award. Strengthening Mozambique's Capacity for Agricultural Policy Analysis, Productivity, Growth and Poverty Reduction

This project focuses on capacity strengthening in the Ministry of Agriculture (MINAG), with “twin goals ... to expand the availability of appropriate crop, livestock and natural-resource management technologies for smallholder farmers, and to accelerate the uptake of those technologies by strengthening policy institutions and market information services”

(<http://www.aec.msu.edu/fs2/mozambique/index.htm>). To achieve these goals, the project works with the Directorate of Economics of MINAG and the national agricultural research institute (IIAM).

The primary focus of project activities has been to prepare for the CAADP launch scheduled for December 13, 2010, by the Prime Minister and Minister of Agriculture, together with civil society, donor, and SADC and NEPAD representatives. Project staff worked closely with the Director of Economics and the local SAKSS node to enable the formal launch. Several technical activities that project staff worked on during the year will feed directly into the post-launch stocktaking exercise. These include the national agricultural strategy, the national agricultural

research strategy, and preparations for the evaluation of the post-2008 world food price crisis accelerated agricultural production program.

The project also undertook joint policy analysis activities with the Faculty of Agriculture at Eduardo Mondlane University to expand national leadership on applied policy research and civil society dialog in the context of CAADP. A scope of work was prepared for MSU faculty member, Dr. Kimberly Chung, an agricultural economist with expertise in community nutrition, to undertake an assessment of how to strengthen linkages between agricultural development and nutrition outcomes in early FY 2011.

The urgency of moving ahead with CAADP was underlined by the bloody food price riots in Maputo last September, which led to the replacement of the Minister of Agriculture. The events confirmed the disappointing results of the 2008 Living Standards Measurement Survey that found persistent high levels of rural and urban poverty. The silver lining is that the government is now clearly focused on the imperative of raising agricultural productivity, creating strong demand for the project's analytical contributions over the past several years.

On the agricultural research side, the project collaborated closely with CGIAR centers and the Brazilian research agency, EMBRAPA, on a common agricultural research support platform funded by USAID. The project supported analysts in the socio-economics unit of the national agricultural research program to undertake studies of technology profitability in a value chain framework for several commodities.

The project worked closely with the national market information system (SIMA) over the past year to upgrade its technical systems (software and ITC). SIMA produced its 800th consecutive weekly information bulletin during the reporting period, and its information dissemination is now closely followed at the highest levels of government.

At the request of USAID/ Mozambique, the project agreed to design, contract and pay for an impact assessment survey of the PL480-funded MYAPs. The project also completed most of the work of compiling and documenting a complete series of the annual agricultural production and marketing surveys (TIA) from 2002 to 2008 to improve access by national and international analysts. This compiled dataset will facilitate analytics in support of CAADP investment plan design.

Zambia Associate Award.¹⁰ *Food Security Research Project (FSRP)*

FSRP's mandate is to contribute to effective policy dialogue, capacity building, and ultimately an improved agricultural policy environment in Zambia, through collaboration with government and the private sector. Consistent with this mandate, FSRP in FY 2010 has achieved progress in (a) bringing about significant policy change; (b) improving the evidence base for informed government policy discussions, which while not yet resulting in tangible policy change, has sowed the seeds for future improvements in the policy environment, and (c) capacity building of

public agricultural entities, which will also have long-term payoffs for Zambian agriculture. Specific achievements are as follows:

Support for Concrete Policy Change

- **Cotton Value Chain:** Working to support the cotton sector since early 2006, FSRP has remained engaged with cotton sector stakeholders to contribute to forward momentum towards eventual enactment of the revised Cotton Act. In addition to being an advisory member of the Cotton Board, the project has supported the board in developing the cotton sector strategy as well as developing and hosting the cotton farmers' database.
- **Maize Value Chain:** Working closely with public and private stakeholders in the maize value chain, FSRP continued to actively engage high level policy makers and provide timely research notes on maize marketing and trade issues in Zambia and the Southern Africa region.
 - During FY 2010, ACF/FSRP initiated and continued to facilitate the stakeholder consultations on the formation of the Public Private Partnership (PPP) marketing institution in Zambia. At the request of MACO, ACF/FSRP facilitated the development of an implementation manual to guide the PPP.
 - As requested by agricultural stakeholders, FSRP conducted an analysis on the factors contributing to the bumper maize harvest during the 2009-2010 cropping season (November to April), for presentation to MACO leadership, cooperating partners and the Economic Association of Zambia. The results show that, although Zambia had a good harvest in 2010, 61 percent of the maize yield growth in 2010 over prior years was due to unusually favorable weather. Because Zambia is vulnerable to major shifts in weather conditions, the country should not be lulled into a false sense of security that it will be a consistently food self-sufficient country unless efforts are made to improve the grain marketing policy environment and devote a larger share of the public agricultural budget to R&D and effective farmer extension programs. ACF/FSRP has been commended by MACO and other stakeholders in highlighting these findings.
 - Through the guidance of FSRP, MACO and CSO for the first time included a module for estimating labor costs in the Corp Forecasting Survey questionnaire. This was to provide an evidence base to inform annual debate in recent years about the cost of production of maize in order to set appropriate FRA maize purchase prices. MACO and other stakeholders indicated that accurate knowledge of maize production costs would guide discussions in the determination of the FRA maize buying price as well as determine whether unusual steps are necessary in the event that findings showed that Zambian smallholder farmers were uncompetitive regionally.
- **Fertilizer Value Chain:** As reported last year, FISP resulted from the reforms of the FSP, which ACF/FSRP actively facilitated and coordinated. These reforms were meant to improve the implementation of the government fertilizer program with increased participation from the private sector. Despite the partial implementation of the reforms advocated by ACF/FSRP, these reforms have to some extent improved the program, for example, a reduction in the amount of fertilizer received per recipient, and reliance on camp committees to select eligible recipients. These changes have modestly improved the efficiency of the FISP and fertilizer targeting. ACF/FSRP will continue to encourage

government to introduce an electronic voucher system for fertilizer distribution, and to increase private sector participation.

- **Cassava Value Chain:** ACF/FSRP facilitated and supported the development of the cassava subsector strategy, based on prior research and outreach on cassava, and provided support to the Task Force on Accelerated Cassava Utilization (ACU). The cassava subsector strategy led to an independent project that supports the commercialization and utilization of cassava.
- **Horticulture Value Chain:** Five years of applied analysis has yielded a number of significant results which have been shared with stakeholders at different levels. Stakeholders through consultations facilitated by FSRP have recognized the need to have an institution looking at the development and interests of the horticultural sector, considering the policy neglect the sector has been facing. As such, a Horticultural Task Force, with FSRP providing the Secretariat, has been formed with a long term vision of transforming itself into a horticultural association which can later develop/formulate a national horticultural development strategy/policy. FSRP's rich database will be useful for a long period to come for analyzing trends in the structure and the behavior of vegetable markets. FSRP is now visible in the sector and has been coordinating Zambia's participation in video conferences on high value agriculture in East and Southern Africa organized by the Global Horticultural Initiative and funded by the AAACP, World Bank, COMESA and GLDN.
- **GRZ Agriculture Budget Review:** ACF/FSRP continued to facilitate active stakeholder involvement in GRZ Agriculture Budget Review: By analyzing budget trends and implications for agricultural sector development and conducting outreach on these issues, ACF/FSRP raised the level of public debate regarding agricultural sector budgetary priorities. This budget analysis is currently used in high-level policy dialogue among key government ministers, facilitated by ACF/FSRP, about public expenditure and how to achieve the CAADP target of 6 percent annual growth in agriculture.
- **Renewed commitment to CAADP:** ACF/FSRP has continued interacting with stakeholders in MACO, COMESA, Donors and State House to resolve technical differences and keep the momentum in the development of the CAADP process. The signing of the CAADP Compact has been delayed, and is now scheduled to be signed on January 18, 2011.
- **Feed the Future Initiative:** During the second half of FY 2010, FSRP was asked by USAID/Zambia to contribute to the formulation of its Feed the Future Initiative Implementation Plan. FTF has become the major focus of FSRP activity since August 2010, collecting evidence on which commodity value chains offer the greatest potential to meet a range of strategic objectives, unique features of the Zambian situation that may warrant a unique response under FTF, sub-contracting FINTRAC to carry out the AgCLIR study for Zambia, involvement of FSRP staff in the AgCLIR field work and report preparation, and other tasks.

Capacity Building

- The FSRP Team provided technical support to the MACO and CSO CFS data cleaning team, training a team of 30 people (20 males and 10 females). In March and April, FSRP staff conducted 3 training courses on use of the software programs, CPro, Stata, and

SPSS. This exercise helped MACO and CSO to appreciate the need for treating data collection and cleaning as a process/chain that requires all links to be strengthened.

- FSRP continued to provide:
 - Technical guidance and assistance to 1 FSRP Research Associate (male) at the University of Zambia to complete an MSc degree in Agricultural Economics.
 - Financial assistance through graduate assistantships to students (3 females) at Michigan State University.

Improving the Substantive Content of Agricultural Policy Debates

Over the reporting period, FSRP has responded to specific requests in Zambia for empirical input on key policy issues:

- **Stimulating debate on the agricultural sector implications of the 2010 GRZ budget:** ACF/FSRP provided an analysis of the agricultural sector budget allocations. The analysis highlighted the continued significant proportion of the budget allocated for financing fertilizer and maize market subsidies at the expense of more fundamental public good investments that are missing and are required as building blocks for productivity increases in the Zambian agricultural sector.
- **The need to reform the Zambian fertilizer support program:** As summarized above, ACF/FSRP has continued facilitating the development and implementation of the new FISP and the electronic voucher system.
- **The Cotton Board:** ACF/FSRP, a non-voting advisory member of the Cotton Board has continued supporting the Board in the development of the cotton sector strategy and farmers' database.
- **Challenges of targeting assistance to smallholder households:** Responding to interests from MACO and other Zambian and donor stakeholders in designing more effective approaches to assisting different groups of small and medium scale farmers in Zambia, FSRP researchers continued to use the Zambian rural household data sets to identify relevant categories of resource poor smallholder farmers and their characteristics. A follow-up study is underway to understand poverty dynamics in Zambia.
- **Task Force on Acceleration of Cassava Utilization:** ACF/FSRP has facilitated and supported the development of the cassava sector strategy and an independent unit/project to spearhead the development of the cassava sector.
