First Amendment to the Assistance Agreement between United States of America, acting through the United States Agency for International Development (USAID) and the Republic of the Philippines ("the Grantee") (collectively, the "Parties") for Economic Growth and Democracy and Governance ("the Agreement") dated September 30, 2011.

SECTION A: To provide an additional increment of USAID financing in the amount of Twenty-Nine Million Three Hundred Twenty-three thousand United States Dollars, the Agreement is hereby amended as follows:

1. Article 3, Section 3.1 (a) of the Agreement is hereby amended by deleting "Eight Million Six Hundred Sixty-Nine Thousand Six Hundred Thirty-Four United States ("U.S.") Dollars (\$8,669,634)" and substituting in lieu thereof "Thirty-Eight Million Sixty-Seven Thousand Six Hundred Thirty-Four United States (U.S.) Dollars (\$38,067,634)."

2. The Attachment (Illustrative Financial Plan) to Annex 1 (Amplified Description) of the Agreement is deleted in its entirety and Attachment to Annex 1 is substituted in lieu thereof.


SECTION B: Except as specifically amended or modified herein the Agreement shall remain in full force and effect in accordance with all of its terms.

SECTION C: Effectiveness. This First Amendment shall enter into force when signed by both Parties hereto.
