KEY DEVELOPMENTS

- As of September 9, USAID/OFDA grantees had completed 5,535 transitional shelters (t-shelters), with an additional 675 t-shelters under construction. Shelter Cluster members, including USAID/OFDA grantees, continue to scale up t-shelter construction as rubble removal and disposal efforts increase and additional land becomes available. The Shelter Cluster reports a projected total output of more than 22,000 t-shelters by the end of September—representing a nearly 60 percent increase in the number of completed t-shelters in Haiti.
- USAID/OFDA, U.N. agencies, international organizations, non-governmental organizations (NGOs), and the Government of Haiti (GoH) continue to support the relief to recovery process, with particular focus on the identification of appropriate shelter solutions to displaced populations during the hurricane season. USAID/OFDA's neighborhoods-based approach allows earthquake-affected families to return to communities where they once lived and provides them access to existing markets, thus facilitating urban recovery.
- USAID/OFDA expects to provide shelter solutions to approximately 47,500 earthquake-affected households
 through t-shelter provision, yellow house repairs, support to hosted internally displaced persons (IDPs), and rubble
 removal to increase land availability for shelter construction. As of September 9, USAID/OFDA had provided
 shelter solutions to nearly 17 percent of targeted households.

CONTEXT

- On January 12 at 1653 hours local time, a magnitude 7.0 earthquake struck southern Haiti. According to the U.S. Geological Survey (USGS), the earthquake's epicenter was located 10 miles southwest of the capital Port-au-Prince, West Department. The earthquake killed an estimated 230,000 people and affected approximately 3 million others, according to the GoH. On January 13, U.S. Ambassador to Haiti Kenneth H. Merten declared a disaster due to the effects of the earthquake.
- During the months following the earthquake, humanitarian efforts met the immediate needs of earthquake-affected populations, through the provision of safe drinking water, food, household items, shelter assistance, and health care. USAID continues to work closely with other U.S. Government agencies, the GoH, international organizations, the U.N., and NGOs to coordinate ongoing efforts and to facilitate the transition from emergency

relief activities to recovery operations, while preparing to respond to the potential for further deterioration in humanitarian conditions during the rainy and hurricane seasons.

Shelter and Settlements

- On September 3, USAID/OFDA Haiti Program Office staff visited grantee Adventist Development and Relief Agency (ADRA) in Carrefour Commune to observe progress on a project to relocate 477 families from tents on a median in the center of a busy highway to t-shelters on nearby coastal land. ADRA has negotiated with the local mayor to obtain a coastal plot for the displaced people, thus allowing them to return to fishing and other oceanbased livelihoods.
- In addition to the new plot of land, which can hold t-shelters for 160 households, USAID/OFDA staff also observed installation of t-shelters by other Shelter Cluster members in the existing community adjacent to the plot, where the remaining 317 displaced families will live. USAID/OFDA staff noted that a number of households had already departed the median to reside in t-shelters on host families' land.
- At a September 7 Protection Cluster meeting, the Cluster's Housing, Land, and Property Working Group noted a lack of clarity regarding legal and contractual responsibilities amongst agencies managing or working in current resettlement sites. ADRA noted that securing land and permission to build t-shelters to remove families from the median required consultations with local authorities and the relevant community committee.

Water, Sanitation, and Hygiene (WASH)

- In view of increased strategic emphasis among international WASH actors on service provision in neighborhoods rather than camps, the WASH Cluster held a planning meeting on September 8 to redefine the cluster's methods and indicators to better reflect that neighborhood focus. WASH Cluster members noted that a number of relief agencies have begun providing WASH support to returnees or to neighborhoods in advance of the cluster defining a formal return package, but in line with the cluster's strategy. USAID/OFDA grantees continue to increase services in areas outside of settlement sites to meet the needs of individuals returning to neighborhoods of origin.
- WASH Cluster representatives reported that discussions are underway to develop a WASH return package to
 encourage families to return to neighborhoods of origin. The package would likely include family latrine
 installation and provision of water treatment materials. In partnership with IOM's Camp Management Operations
 Unit, the WASH Cluster is collecting information on the previous addresses of camp residents in Léogâne,
 Gressier, Grand Goâve, and Petit Goâve communes in West Department for use in return package monitoring.
- As displaced individuals have indicated that shelter concerns are a primary factor influencing the decision to return
 to areas of origin, the WASH Cluster is collaborating with the Shelter Cluster to develop complementary activities
 in affected neighborhoods.

Hurricane Preparedness

- On September 6, USAID/OFDA staff met with U.N. Stabilization Mission in Haiti (MINUSTAH) Humanitarian Affairs and Development Coordinator Pascale Lefrançois to discuss hurricane preparedness coordination.
- The U.N. Office for the Coordination for Humanitarian Affairs (OCHA) is currently updating a MINUSTAHdrafted contingency plan for U.N. agencies that includes information on various agencies' overall, nationwide prepositioning figures. MINUSTAH's humanitarian officers at the regional level are working on region-specific contingency plans, which will include information regarding pre-positioned commodities by organization.
- In the event of a hurricane or tropical storm, MINUSTAH would lead international coordination efforts for approximately 24 hours, until an OCHA emergency team was able to deploy to the affected area. MINUSTAH would then serve a supporting coordination role. The MINUSTAH Humanitarian Affairs and Development Coordinator noted that MINUSTAH's long-developed reporting systems and relationships with local, regional, and GoH authorities would help meet information-sharing needs during an emergency.
- During a September 7 U.N. Humanitarian Country Team (HCT) meeting, the U.N. World Food Program (WFP) reported having 57 all-terrain trucks, 17 medium-terrain vehicles, and significant warehouse space throughout Haiti for use following a hurricane, as well as a barge with a capacity of 1,500 metric tons. In addition, WFP prepositioned food stocks could meet the needs of 1.2 million people nationwide for one week, or 300,000 people for one month. USAID/OFDA, through a partnership with IOM, has also strategically stockpiled relief commodities sufficient for 100,000 individuals in key locations throughout Haiti.

Protection

- At a September 7 Protection Cluster meeting, representatives of the U.N. Children's Fund (UNICEF) reported that training to sensitize the U.N. Police and Haitian National Police to child protection issues in displacement camps is ongoing, primarily targeting camps in Jacmel and Léogâne.
- At the meeting, the Cluster's Housing, Land, and Property Working Group estimated that more than 8,000 displaced individuals have been subject to forced evictions to date, and more than 11,000 others remain in

situations that place them at risk of involuntary evictions. In response, Deputy Special Representative of the Secretary General for the U.N. Mission in Haiti Nigel Fisher has requested that the working group prepare a policy paper on forced evictions for submission to the HCT in the coming weeks. Upon approval, the HCT plans to submit the paper to the GoH, highlighting viable recommendations to address forced evictions at the policy and implementation levels.
