KEY DEVELOPMENTS

- On July 20, USAID/OFDA staff participated in a meeting of the international community with Government of Haiti (GoH) President René Préval regarding resettlement and shelter issues. President Préval noted the need for relief agencies to intensify resettlement and shelter activities to demonstrate progress and provide reassurance to earthquake-affected populations. President Préval indicated that sufficient land is available for construction of transitional shelters (t-shelters), but also stated that new permanent dwellings constructed in Port-au-Prince will likely need to be multi-story buildings, given limited land availability in the capital.
- From July 12 to 18, USAID/OFDA provided urban search-and-rescue (USAR) training to 25 volunteer first responders in Haiti. To help build Haitian capacity for disaster response, USAR experts from Fairfax County, Virginia, and Los Angeles County, California, trained first responders from fire departments throughout Haiti, including Cap-Haïtien, Carrefour, Limbe, Saint-Marc, and Delmas. The training developed technical skills to locate and extricate trapped individuals, focusing on the proper use of search-and-rescue equipment transferred by the Fairfax and Los Angeles teams to the Haitian Volunteer Firefighters Association in February 2010. The equipment, valued at approximately \$500,000, was used by the two teams during USAR operations following the January 12 earthquake.

CURRENT SITUATION

• On July 22, the relocation of approximately 1,300 individuals from Camp Fleurieux to Corail commenced following a GoH request to close Camp Fleurieux due to flood risk and potential for increased illness, according to IOM. IOM noted recent tensions among Corail residents informed of the new families arriving at the site. IOM camp managers and U.N. Stabilization Mission in Haiti (MINUSTAH) forces facilitated the relocation process, which occurred without incident. USAID/OFDA field staff are monitoring the situation and liaising with humanitarian staff and camp managers regarding the relocation process, which is scheduled to be completed in the coming days.

 According to IOM, the Mitigation Task Force had assessed 137 of a targeted 250 settlement sites as of July 12, averaging three assessed sites per day. Of the 137 sites, 115 sites required mitigation activities to prevent flooding or landslides during the hurricane season.

Preparedness

- On July 19, USAID/OFDA staff attended the meeting of the Groupe d'Appui de la Cooperation Internationale—
 the forum for coordination between the GoH and the international community for disaster preparedness and risk
 reduction. The meeting was chaired by Prime Minister Bellerive, with participation by the Minister of the Interior,
 the Directorate of Civil Protection, U.N. Deputy Special Representative of the Secretary-General (SRSG) Ad
 Interim for MINUSTAH and U.N. Resident Coordinator and Humanitarian Coordinator Ad Interim Nigel Fisher,
 U.N. agencies, non-governmental organizations (NGOs), and donors. The meeting addressed the state of
 preparedness for the 2010 hurricane season. Participants noted U.N. agencies' significantly improved hurricane
 preparedness compared to 2008, when four major storms hit Haiti, including pre-positioning of relief commodity
 stockpiles throughout the country. Identification and evaluation of potential evacuation and shelter sites continues.
- On July 19, USAID/OFDA staff based in Port-au-Prince and Miami participated in the U.S. Southern Command (SOUTHCOM) Rehearsal of Concept (ROC) drill, focused on preparedness for responding to a Category 3 hurricane. The ROC drill rehearsed a scenario starting 96 hours before a hurricane is predicted to make landfall in Gonaïves and ending with preparations to return to a steady state 96 hours after the hurricane.
- From July 19 to 22, USAID/OFDA staff served as observers of the MINUSTAH Joint Exercise for interagency disaster preparedness in Gonaïves. Like the ROC drill, the Joint Exercise focused on preparedness for responding to a Category 3 hurricane. The exercise simulated a scenario starting 48 hours before a hurricane is predicted to hit Gonaïves.

Logistics and Relief Commodities

- On July 16, USAID/OFDA staff met with the Logistics Cluster coordinator and the U.N. World Food Program
 (WFP) to discuss logistical issues pertaining to hurricane preparedness and pre-positioning of emergency relief
 supplies.
- The cluster makes available an in-house customs advisor for the humanitarian community and is in negotiations
 with the GoH to obtain a general waiver for humanitarian goods similar to the waiver that was in place shortly
 after the earthquake. In addition to working to pre-position relief supplies throughout Haiti and rebuild warehouse
 space lost during the earthquake, the cluster has a barge and helicopter available for transport of relief
 commodities.

Shelter and Settlements

- On July 13, IOM staff reported that although some plastic sheeting provided during initial stages of the response
 has begun to deteriorate, USAID/OFDA-provided plastic sheeting remains intact, given the high quality of the
 material.
- On July 15 and 20, USAID/OFDA staff visited an Adventist Development and Relief Agency (ADRA) site in Carrefour to gauge progress on USAID/OFDA-funded t-shelter construction. To date, ADRA has constructed nearly 800 t-shelters with USAID/OFDA funding.
- ADRA places t-shelters within existing communities, using the same locations as residents' pre-earthquake homes.
 ADRA is purchasing only local construction materials as the project continues to prevent construction delays associated with customs procedures.

Protection

- During meetings with USAID/OFDA in recent weeks, several partners have reported an increase in gender-based violence (GBV) in camps. The humanitarian community continues to enhance protection mechanisms through ongoing trainings and capacity building activities.
- On July 13 and 14, USAID/OFDA conducted a humanitarian protection workshop in San José, Costa Rica, for NGOs and U.N. agencies working in Latin America and the Caribbean. Of the 28 participants, 7 people represented 6 relief agencies working in Haiti. The workshop covered USAID/OFDA's approach to protection in disasters, including mainstreaming protection into multi-sectoral relief activities and addressing such specific areas as child protection and gender-based violence.
- On July 21, USAID/OFDA staff visited two orphanages supported by partner International Medical Corps (IMC) with USAID/OFDA funding. Staff from both orphanages had recently participated in IMC protection trainings, which covered the importance of communicating with children, including newborns; how to help children physically develop; and the importance of play for children's development. Participants reported adjusting programs at the orphanages to better meet the needs of the children following the trainings.

 On July 22, IMC planned to conduct a training with 40 female and male community leaders from four camps to discuss GBV and identify solutions.

USG HUMANITARIAN ASSISTANCE

- On January 13, U.S. Ambassador to Haiti Kenneth H. Merten declared a disaster due to the effects of the
 earthquake. To date, USAID has contributed more than \$675 million in earthquake response funding, including
 more than \$364 million from USAID/OFDA, nearly \$173 million from USAID/FFP, more than \$68 million from
 USAID/Haiti, \$67 million from USAID/OTI, and \$3 million from USAID/DR. In total, the USG has contributed
 more than \$1.1 billion in earthquake response funding for Haiti to date.
- On January 12, USAID/OFDA activated a Washington, D.C.,-based Response Management Team (RMT) to support the Disaster Assistance Response Team (USAID/DART) that deployed to Haiti early on January 13 to assess humanitarian conditions and coordinate activities with the humanitarian community. The RMT demobilized on February 28, and the USAID/DART transitioned to a USAID/OFDA Program Office on April 28 to reflect the shift in the earthquake response from relief to recovery. USAID/OFDA Program Office staff continue to assess and identify humanitarian needs and coordinate delivery of emergency relief supplies to earthquake-affected areas.
- As of July 23, State/PRM has provided \$11.2 million to support emergency food, health, nutrition, protection, and WASH interventions in border areas, as well as other programs in support of repatriated Haitians and host families.
- As of July 23, DoD's estimated cost for the Haiti earthquake relief effort was \$458.7 million. DoD supported humanitarian efforts through transportation of USG personnel and relief commodities into Haiti, as well as the provision of health and security services.
