# HORN OF AFRICA — DROUGHT

#### KEY DEVELOPMENTS

- The African Union Mission in Somalia (AMISOM) has indicated plans to launch a military offensive to capture the al-Shabaab-controlled port town of Kismayo in Lower Juba Region in the coming weeks, according to the Government of Kenya (GoK). The limited number of relief organizations operating in Kismayo and surrounding areas may be unable to meet increased humanitarian needs if the AMISOM offensive in Kismayo displaces populations and disrupts basic services, according to the U.N. Office for the Coordination of Humanitarian Affairs (OCHA). USAID is closely monitoring the situation.
- The USAID-funded Famine Early Warning Systems Network (FEWS NET) expects Crisis—Integrated Phase Classification (IPC) 3—and Emergency—IPC 4—levels of food insecurity to persist through at least September in parts of the Horn of Africa, following mixed and generally below-average March-to-May rains. As of mid-March, more than 9 million people in the Horn of Africa were food insecure, according to OCHA.
- At a June 14 meeting, representatives from the GoK, U.N. agencies, non-governmental organizations (NGOs), and the Dadaab refugee community discussed future plans for Kenya's Dadaab refugee camp complex, which currently hosts approximately 500,000 refugees, most of whom originate from Somalia. Médecins Sans Frontières, a humanitarian organization working in Dadaab, reports that many parts of the camps lack basic services and food distribution. Insecurity—including attacks targeted mostly at Kenyan police and other crimes targeting refugees—within the camps constrains the provision of basic services by humanitarian organizations.
- In FY 2011 and to date in FY 2012, the U.S. Government (USG) has provided nearly \$1.2 billion in humanitarian assistance to the Horn of Africa. Of the total, USAID's Office of U.S. Foreign Disaster assistance (USAID/OFDA) has provided nearly \$48 million for agriculture and food security, economic recovery and market systems (ERMS), health, nutrition, and water, sanitation, and hygiene (WASH) interventions, as well as support for humanitarian coordination and information management, to date in FY 2012. USAID's Office of Food for Peace (USAID/FFP) has provided approximately \$408 million in food-related assistance to the region to date in FY 2012.

#### Context

- Following below-average 2011 spring rains in the eastern Horn of Africa, food security among pastoralists and populations in marginal farming areas sharply deteriorated. In addition to below-normal harvests, shortages of grazing resources for livestock resulted in abnormal migrations, with pastoralists travelling long distances in search of pasture and water, according to OCHA. In anticipation of worsening humanitarian conditions, USAID began prepositioning food assistance in the region in late 2010, providing significant humanitarian assistance by early 2011.
- In July and August 2011, the U.N. declared that acute malnutrition indicators, crude mortality rates (CMRs), and food access levels had surpassed Famine<sup>5</sup>— IPC 5—thresholds among internally displaced persons (IDPs) in Mogadishu and the Afgooye corridor and in areas of Bay, Bakool, Lower Shabelle, and Middle Shabelle regions in Somalia. In response, the USG, other international donors, and humanitarian agencies rapidly scaled up humanitarian assistance to Somalia. By November, FEWS NET and FSNAU reported improved humanitarian conditions in Somalia and downgraded areas of Bay, Bakool, and Lower Shabelle regions from Famine to Emergency—IPC 4—levels of food insecurity. On February 3, FEWS NET and FSNAU reported that Famine—as defined by the IPC continuum—no longer existed in southern Somalia.
- On July 6, 2011, USAID activated a regional Disaster Assistance Response Team (DART) in Nairobi, Kenya, and Addis Ababa, Ethiopia, to monitor regional drought conditions, identify humanitarian needs, and coordinate response activities with other donors. USAID also stood up a Response Management Team (RMT) in Washington, D.C., to support the DART and coordinate USG humanitarian efforts. On February 15, 2012, the DART and RMT transitioned responsibilities back to the USAID/OFDA East and Central Africa regional team.
- On October 13, 2011, U.S. Ambassador James C. Swan, Special Representative for Somalia in Nairobi, Kenya, renewed the disaster declaration for the complex emergency in Somalia for FY 2012. On October 19, 2011, U.S. Ambassador Donald E. Booth reissued the disaster declaration in response to the ongoing complex emergency in Ethiopia. On October 28, 2011, U.S. Ambassador J. Scott Gration renewed the Kenya disaster declaration for FY 2012 due to the effects of the drought.
- On November 28, 2011, al-Shabaab issued a public statement banning 16 U.N. agencies and international NGOs from operating in al-Shabaab-controlled areas of southern and central Somalia. In addition, on January 30, 2012, al-Shabaab terminated the agreement under which the International Committee of the Red Cross (ICRC) was allowed to deliver emergency food aid in al-Shabaab-administered areas of Somalia.
- Many FY 2011 USG-funded humanitarian assistance programs remain operational to date, providing ongoing support to affected populations. The USG continues to monitor the situation in order to provide additional humanitarian assistance in response to evolving or persisting needs.

# Security, Humanitarian Access, and Population Displacement Somalia

- As of June 8, an AMISOM offensive that captured Afmadow town in Lower Juba Region—previously controlled by al-Shabaab—at the end of May resulted in limited population displacement, with fewer than 500 people fleeing the area, according to OCHA.
- UNHCR recently created a consortium to monitor and track IDP returns in southern areas of Somalia to ensure that humanitarian standards are upheld in return and reintegration efforts in Somalia. UNHCR, the U.N. Food and Agriculture Organization (FAO), and other humanitarian organizations continue to address the needs of returning IDPs through the distribution of shelter materials and other relief supplies, as well as other livelihoods initiatives.

# Emergency Food Assistance, Food Security, and Livelihoods Ethiopia

• Following the late onset of the 2012 February-to-May belg rains, poor cereal harvests are expected in belg-producing areas of Ethiopia, including the northeastern highlands, and areas in Southern Nations, Nationalities, and Peoples (SNNP) Region, where the sweet potato harvest recently failed, according to FEWS NET. Emergency food assistance needs will peak between June and August in belg- and root crop-dependent areas of SNNP Region. Food security continues to deteriorate in eastern Amhara, central Oromiya, and southern Tigray regions, which experienced poor June-to-September kiremt rains in 2011 and below-average February-to-May belg rains in 2012. The current lean season will extend to July and August due to a two-month delay of the belg harvest—which normally takes place in

A population is downgraded from Famine once evidence suggests that it no longer meets at least one of the three aforementioned criteria. Therefore, a population may continue to experience famine-level conditions but not be classified as in Famine. For example, improved household food access could result in a downgrade from Famine to Humanitarian Emergency, even if malnutrition and mortality conditions remain at famine-levels.

- May and June—because of the late onset of rains. High population density, above-average food prices, widespread chronic food insecurity, and significant livelihoods protection and food consumption deficits will also contribute to Crisis—IPC 3—levels of food security in affected areas through July and August, according to FEWS NET.
- Afar Region, eastern parts of Oromiya Region, and northern areas of Somali Region continue to experience dry conditions despite recent favorable rainfall that alleviated water shortages in most other *belg* and *gu*-rains receiving areas. Parts of Oromiya Region did not experience new rainfall in the last two weeks of May, while Afar Region received below-normal rainfall. Results from a recent joint assessment of Somali Region by the Government of Ethiopia (GoE) and humanitarian organizations indicated that drought conditions continue to affect up to two-thirds of the population in central areas of the region. The assessment team noted the need for relief supplies and expanded nutrition and livelihoods support to assist affected populations, according to a June 11 OCHA report.
- A June 5 GoE-led Disaster Risk Management-Agriculture Task Force (DRM-ATF) report on the response to the 2011 La Ninã-induced drought indicates that donors contributed \$17.8 million for agriculture interventions included in the GoE's initial and revised 2011 Humanitarian Requirements Document (HRD) during 2011. DRM-ATF members have expressed concern that the agricultural sector received significantly less support than other sectors given the cost-effectiveness of agricultural interventions, particularly if implemented in the early stages of a drought crisis.
- Since the beginning of the 2011 drought, DRM-ATF members have provided approximately 117,500 sets of farming tools, an estimated 38.8 million root and tuber cuttings, and more than 2.4 metric tons (MT) of seeds to a total of approximately 85,000 households in Amhara, Oromiya, and SNNP regions. Up to 470,000 households—primarily in Afar Region, southern parts of Oromiya Region, and southwestern areas of SNNP Region—have benefitted from animal health services, as well as water point rehabilitation and destocking interventions.
- As of June 13, the GoE Disaster Risk Management and Food Security Sector (DRMFSS), the U.N. World Food Program (WFP), and the Catholic Relief Services (CRS)-managed Joint Emergency Operation (JEOP) had dispatched 76 percent of food assistance to 3.2 million individuals throughout Ethiopia targeted in the third round of food distributions, according to OCHA. The JEOP has dispatched approximately 98 percent of total allocations for the second round of distributions, which targeted 2.9 million people. The fourth round of distributions that began during the week of June 4 targets 3.2 million people and has dispatched approximately 8 percent of total allocations as of June 13.
- To date in FY 2012, USAID/FFP has provided \$146 million to support drought-affected populations and refugees in Ethiopia. USAID/FFP assistance includes more than 168,000 MT of food aid to drought-affected individuals and more than 19,000 MT of food aid to refugees. In addition, USAID/OFDA has provided more than \$8 million for agriculture and food security and ERMS interventions in Ethiopia to date in FY 2012, including support for Mercy Corps to improve animal health services and rehabilitate rangeland and water resources through cash-for-work activities.

### Kenya

- Vulnerable populations in northern, southeastern, and coastal areas of Kenya are likely to face Crisis—IPC 3—levels
  of food insecurity by September, the peak of the lean season, due to delayed and below-normal March-to-May long
  rains, FEWS NET reports. An anticipated decrease in labor opportunities in July, decreased milk availability, and
  high food prices are also expected to contribute to worsening food security conditions in these areas in the coming
  months. Crisis—IPC 3—levels of food insecurity are expected to persist until short-cycle harvests begin in
  December.
- On June 13, USAID/OFDA and USAID/Kenya staff met with GoK officials, including representatives of the
  newly-formed National Drought Management Authority (NDMA), to discuss ongoing drought management efforts
  in Kenya. In November 2011, the Kenyan Parliament authorized the creation of the NDMA as part of a regional
  effort to build resilience and prevent humanitarian crises by establishing institutions to better manage droughts and
  other natural disasters.
- To date in FY 2012, USAID/FFP has provided nearly \$92 million to support drought-affected and refugee populations in Kenya. This includes nearly 42,000 MT of food aid to drought-affected individuals and nearly 37,000 MT of food aid to refugees. USAID/FFP is also supporting cash-based programs in drought-affected areas through WFP and Adeso, formerly known as Horn Relief. In addition, USAID/OFDA has provided nearly \$820,000 for agriculture and food security activities in Kenya that work to mitigate food insecurity through fodder production, agricultural training, and asset protection.

#### Somalia

- Emergency humanitarian needs will peak in parts of southern Somalia between June and August due to significantly below-normal April-to-June gu rains, according to FEWS NET. Poor harvests are expected in agro-pastoral areas of Bakool, Bay, Gedo, Hiran, Lower Juba, and Middle Juba regions due to the poor gu rains and pest infestations. Food prices will continue to rise until the August harvest, after which FEWS NET expects modest seasonal improvements in food security due to an increased supply of food from the harvest. However, Crisis—IPC 3—and Emergency—IPC 4—levels of food insecurity are likely to persist as agro-pastoral households continue to face deteriorating access to humanitarian assistance, high debt burdens, limited livestock holdings, and a precarious nutrition situation, according to FEWS NET.
- In May, WFP reached more than 1.3 million people in Somalia—or 83 percent of the organization's targeted beneficiaries—with more than 13,400 MT of food through livelihoods, nutrition, relief, and social safety net programs. As of May 31, the WFP Somalia Emergency Operation had received more than \$306 million, or 72 percent, of the requested \$427.6 million.
- To date in FY 2012, USAID/FFP has provided nearly \$162 million in emergency food assistance to support food-insecure populations in Somalia through livelihoods, nutrition, safety net, and cash- and market-based programs.
- USAID/OFDA has provided approximately \$7.5 million for ERMS activities in Somalia to date in FY 2012. In central and northern Somalia, USAID/OFDA is supporting cash- and market-based interventions that strengthen and diversify the livelihoods of food-insecure households, as security and access conditions permit. In addition, USAID/OFDA supports ongoing ERMS activities in southern Somalia, including helping IDP communities meet essential food and non-food needs through voucher programs.

#### Health, Nutrition, and WASH

#### Ethiopia

- Following the conclusion of the initial phase of a mass meningitis vaccination campaign—which targets 3.8 million people in 63 high-risk areas countrywide—on May 21, health agencies have reported no new cases of meningitis in SNNP Region, according to OCHA. The initial phase of the campaign reached approximately 108,000 people—or 89 percent—of people between two and 30 years of age in the Kembata Tembaro and Wolayita zones of SNNP Region.
- Health agencies continue to report new malaria cases in areas of Amhara, Oromiya, and SNNP regions following
  initial reports of cases at the beginning of June. Health authorities are conducting preventive and control measures,
  including case treatment, insecticide-treated nets distribution, and mass mobilization for environmental management
  near river banks and other water bodies, according to OCHA.
- To date in FY 2012, USAID/OFDA has provided nearly \$4.2 million for health, nutrition, and WASH activities in Ethiopia. USAID/OFDA recently contributed more than \$2 million to GOAL in support of its rapid response program, which provides critical emergency nutrition assistance to children suffering from malnutrition by assessing affected areas and implementing community-based management of acute malnutrition.

#### Kenya

- In response to three diphtheria-related deaths in Dagahaley, one of the camps that form the Dadaab refugee camp complex, the Kenya Red Cross Society organized an emergency immunization campaign for approximately 13,000 children in Dadaab's Ifo 2 East and West camps to prevent further spread of the disease.
- To date in FY 2012, USAID/OFDA has provided more than \$880,000 for WASH activities and more than \$1.8 million for nutrition interventions in Kenya. USAID/OFDA-supported programs have included infant and young child feeding services and training for health care workers in the treatment and prevention of malnutrition.

#### Somalia

- The Health, Emergency Shelter/Non-Food Item (NFI), and WASH clusters—the coordinating bodies for health-, shelter and NFI-, and WASH-related activities in Somalia, respectively—have formulated a joint strategy to respond to IDP needs in Mogadishu. The clusters will focus on the Zona K settlement in Hodan District and the new "77" settlement in Dayniile District, as well as other settlements in Dharkeynley and Wadajir districts. Humanitarian conditions in these settlements are some of the worst in Mogadishu, according to OCHA. The Health Cluster also plans to provide health services through existing clinics, mobile health teams, IDP camp facilities, and community health workers to affected populations in these settlements.
- Health facilities continue to report suspected acute watery diarrhea/cholera cases across Somalia, including more than 470 suspected cases in central and southern Somalia between June 4 and 10, according to the U.N. World Health

- Organization (WHO). Health facilities in Somaliland and Puntland reported more than 90 and approximately 370 cases, respectively, during the same period.
- To date in FY 2012, USAID/OFDA has provided more than \$11.3 million to support health, nutrition, and WASH programs in Somalia. USAID/OFDA recently provided more than \$2 million to a partner for health and nutrition interventions, including improving disease detection through household screenings, setting up health sites, and training nutrition workers, as well as conducting targeted supplementary feedings, blanket supplementary feedings, and vaccinations for affected populations.

### **International Response**

- As of June 21, donors had provided more than \$324.2 million in humanitarian assistance to Ethiopia in 2012. The GoE 2012 HRD requests an additional \$179.3 million to address humanitarian needs between January and June; however, the HRD does not account for refugee-related needs.
- As of June 21, donors had provided approximately \$394 million toward the 2012 Kenya Emergency Humanitarian Response Plan—more than 51 percent of the requested \$763.8 million. Donors have provided a total of more than \$441.3 million in humanitarian assistance to Kenya in 2012.
- As of June 21, the 2012 Consolidated Appeal (CAP) for Somalia had received more than \$507.1 million, approximately 34 percent of the total \$1.5 billion requested. To date in 2012, donors have provided approximately \$620.2 million in humanitarian assistance to Somalia. The USG is the largest donor to the 2012 CAP, having provided more than \$98 million, or approximately 19 percent of international contributions to date, according to the U.N. Financial Tracking System.
