# HORN OF AFRICA - DROUGHT

#### KEY DEVELOPMENTS

- On October 10, fighting between the Somalia Transitional Federal Government (TFG)—supported by the African
  Union Mission in Somalia (AMISOM)—and al-Shabaab forces resumed in Mogadishu, with AMISOM and TFG
  forces taking control of Mogadishu's northern districts of Huriwa and Karan, according to AMISOM. Somalia's
  National Disaster Management Agency reports that recent fighting has displaced hundreds of families from Huriwa,
  Karan, and Dayniile districts and resulted in the closure of a hospital in Huriwa.
- As of October 10, light to moderate rains had begun in southern Somalia, with moderate to heavy rainfall anticipated for the week of October 12, potentially marking the beginning of the October to December *deyr* rains in Somalia, according to the U.N. Food and Agriculture Organization (FAO).
- On October 9, USAID Assistant Administrator for the Bureau for Democracy, Conflict, and Humanitarian Assistance Nancy Lindborg met with Assistant Secretary General for Humanitarian Affairs of the Organization of Islamic Cooperation (OIC) Ambassador Atta El-Mannan Bakhit and U.S. Special Envoy to the OIC Rashad Hussain in Turkey to discuss humanitarian conditions in Somalia and opportunities for coordinated humanitarian responses.

#### Context

- Following below-average 2011 spring rains in the eastern Horn of Africa, food security among pastoralists and populations in marginal farming areas sharply deteriorated. In addition to below-normal harvests, shortages of grazing resources for livestock have resulted in abnormal migrations, with pastoralists travelling long distances in search of pasture and water, according to OCHA.
- In Somalia, the U.N. has declared that acute malnutrition indicators, crude mortality rates, and food access levels have surpassed famine thresholds in areas of Bay, Lower Shabelle, Bakool, and Middle Shabelle regions, and among internally displaced persons (IDPs) in Mogadishu and the Afgooye corridor. Without improvement in humanitarian access, famine is expected to spread to areas of Gedo, Juba, and Hiran regions by December 2011, according to the USAID-funded Famine Early Warning Systems Network (FEWS NET).

- On October 13, 2011, U.S. Ambassador James C. Swan, Special Representative for Somalia in Nairobi, Kenya, renewed the disaster declaration for the complex emergency in Somalia for FY 2012. On October 25, 2010, U.S. Ambassador Donald E. Booth reissued a disaster declaration in response to the ongoing complex emergency in Ethiopia. On February 4, 2011, U.S. Chargé d'Affaires Tulinabo S. Mushingi declared a disaster due to the effects of the drought in Ethiopia. On January 28, 2011, U.S. Ambassador Michael E. Ranneberger declared a disaster due to the effects of the drought in Kenya.
- In response, the U.S. Government (USG) immediately increased assistance to affected areas of Ethiopia, Kenya, and Somalia. On July 6, 2011, USAID activated a regional Disaster Assistance Response Team (USAID/DART) in Nairobi, Kenya, and Addis Ababa, Ethiopia, to monitor regional drought conditions, identify humanitarian needs, and coordinate response activities with other donors. USAID also stood up a Response Management Team in Washington, D.C., to support the USAID/DART and coordinate USG humanitarian efforts.

# Emergency Food Assistance, Food Security, and Livelihoods *Ethiopia*

- FEWS NET anticipates normal to above-normal rains over the majority of central and northern Ethiopia and expects average to above-average harvest yields in northwestern Ethiopia, which generally produces surplus crops. Food security has begun to improve in some areas of Southern Nations, Nationalities, and Peoples (SNNP) Region due to successful current harvest yields of crops such as maize, beans, and potatoes. However, FEWS NET famine conditions populations in Ethiopia remain vulnerable to a variety of external shocks, such as drought, volcanic activity, pest infestations, and flooding, particularly in the Somali Region, eastern and southeastern Oromiya Region, and southern areas of SNNP Region.
- An average of 300 people transited the Somalia–Ethiopia border each day during the first week of October—a significant increase from the approximate 170 individuals who transited into Ethiopia in September each day, according to the U.N. World Food Program (WFP). The relief agency is providing high energy biscuits to new arrivals, as well as fortified food supplies to children under five years of age and pregnant and lactating women. WFP also continues to provide food assistance to approximately 1.2 million people in the Somali Region and 255,000 refugees throughout Ethiopia.
- During FY 2011, USAID/FFP provided more than \$213.6 million to support affected populations in Ethiopia, including approximately \$116.8 million for an estimated 150,000 metric tons (MT) of food assistance for the Government of Ethiopia (GoE) and WFP Hubs and Spokes (H&S) special operation in the Somali Region. The H&S program—operational since 2008—aims to address logistical challenges and improve the delivery of food assistance to vulnerable populations in the Somali Region.
- USAID continues to collaborate with the GoE to increase vulnerable populations' resiliency to the effects of future shocks. Since 2005, USAID/FFP has supported the Productive Safety Net Program (PSNP), the main component of the GoE's umbrella Food Security Program, which aims to reduce food consumption gaps and prevent asset depletion among chronically food insecure households through improved access to markets and natural resources. This safety net system has allowed individuals to withstand the worst effects of drought; beneficiaries of the PSNP are not among the 4.5 million individuals identified as requiring urgent humanitarian assistance during the current drought crisis. In addition, USAID/OFDA provided nearly \$3.9 million in FY 2011 to Ethiopia for food security and livelihoods activities, targeting the needs of approximately 470,000 drought-affected individuals.

### Kenya

- Western Kenya has received significant rainfall in recent weeks, while arid and semi-arid lands in northeastern Kenya
  remained dry as of the first week of October, according to OCHA. FEWS NET expects normal to above-normal
  October to December rains in northern and northeastern areas and anticipates improved conditions for livestock and
  crop production through December. However, households will remain extremely vulnerable to additional shocks as
  the drought has compromised agro-pastoral assets. As a result, agro-pastoralists will need several productive seasons
  to rebuild herd sizes and reduce debt levels, according to FEWS NET.
- Potentially increased rains raise the risk of flooding and livestock diseases related to floods, OCHA reports. To protect pastoralist livelihoods, FAO is distributing veterinary drugs, procuring 2.4 million doses of animal vaccines, and supporting increased disease surveillance. In addition, FAO and other relief agencies are providing drought-tolerant seeds to farmers in drought-affected areas of Kenya.
- Approximately 3.75 million people remain food insecure in Kenya. In an effort to scale up assistance to drought-affected populations, WFP has reported plans to coordinate with the Government of Kenya (GoK) to provide food assistance to approximately 2.8 million individuals through provision of food supplies and cash-for-food transfers during October. As of October 11, WFP was providing food assistance to approximately 1.4 million people in Kenya and more than 544,000 refugees in refugee camps.

- In FY 2011, USAID/FFP provided nearly \$128.2 million to support WFP efforts to address immediate food needs across Kenya.
- In FY 2011, USAID/OFDA provided nearly \$3.4 million in additional funding to support a three-year coordinated effort by four international non-governmental organizations—comprising the Arid and Marginal Lands Recovery Consortium (ARC)—to improve food security and household purchasing power through emergency cash transfers and livelihood-strengthening interventions. ARC activities include improving market access for pastoralists and marginal farmers, working with community elders to establish rangeland management schemes based on traditional pastoralist movements, improving access to credit, and providing alternative livelihoods for pastoralist dropouts. In total, USAID/OFDA provided approximately \$12.2 million to Kenya in FY 2011 for food security and livelihoods activities.

## Somalia

- Approximately 4 million people in Somalia are in crisis, including 750,000 people who are experiencing famine conditions, according to an October 8 food security assessment by FEWS NET and the U.N. Food Security and Nutrition Analysis Unit (FSNAU). Anticipated average rainfall during October to December deyr rains may improve pasture conditions and increase upcoming harvest yields. However, deyr harvest yields, which provide 35 percent of Somalia's annual crop production, will remain insufficient to meet food needs and sustain farming livelihoods, resulting in continuing need for humanitarian assistance in 2012.
- Due to a combination of rising food prices, increasing costs of living, and declining economic opportunities, urban populations in crisis—which increased from 475,000 people in January to approximately 585,000 people in July—will likely remain in crisis through December, according to FSNAU and FEWS NET. Famine conditions are expected to persist in Somalia through December.
- The Food Cluster, the coordinating body for food assistance in Somalia, is reportedly scaling up food distribution operations to reach more than 4 million individuals by the end of 2011. In September, the cluster provided food assistance to more than 2.2 million people—including more than 370,000 people in Mogadishu, 1.33 million people in other areas of southern Somalia, more than 330,000 people in central Somalia, and nearly 190,000 people in northern Somalia—representing a 70 percent increase in beneficiaries assisted since August. The cluster reports that logistical challenges, such as congestion at Mombasa port in Kenya, continue to hamper the efficient delivery of food assistance in Somalia.
- In FY 2011, USAID/FFP provided more than \$83 million to Somalia for emergency food assistance. In addition, USAID/OFDA provided approximately \$25 million in FY 2011 for agriculture and food security activities, as well as economic recovery and market systems programs, to improve the food security and livelihoods of more than 425,000 drought-affected individuals in Somalia.

# Health, Nutrition, and Water, Sanitation, and Hygiene (WASH) Ethiopia

- Due to current drought conditions, the GoE and partners are closely monitoring rainfall totals and water levels to assess water trucking needs. Currently, 137 water trucks are delivering safe water supplies to approximately 266,000 people; however, an additional 26 water trucks are needed to meet the country's water needs, according to OCHA.
- As of October 10, Sudanese refugees traveling from Sudan into Ethiopia have increased. The GoE Disaster Risk
  Management and Food Security Sector and UNHCR are conducting a joint food, health, and nutrition assessment of
  refugee conditions, with preliminary findings indicating that new arrivals are in relatively good health, according to
  OCHA.
- In FY 2011, USAID/OFDA provided more than \$25.9 million in health, nutrition, and WASH assistance to Ethiopia, responding to the health, nutrition, and WASH needs of more than 2.7 million people. USAID/OFDA is supporting provision of ready-to-use therapeutic foods and mobile health teams to provide vaccinations and identify and treat malnutrition.

### Kenya

- Health relief agencies have completed a polio immunization campaign in affected districts of Kenya, reaching approximately 275,000 children under five years of age, or 128 percent of the targeted population, as of October 11. Health partners plan to conduct an additional polio immunization campaign in late October.
- Relief organizations are scaling up hygiene and sanitation activities throughout Kenya to prevent the potential spread of waterborne diseases. The Kenya Red Cross Society is conducting hygiene promotion activities and training community volunteers in Turkana Central and Turkana North districts in Turkana County and in Mandera, Marsabit, and Wajir counties. Relief organizations are also targeting 75 health facilities in Turkana County—representing 63 percent of all Turkana health facilities—through an ongoing rapid hygiene promotion intervention.

- As of October 11, the recent dengue outbreak had affected approximately 10,000 people in Mandera, an increase from the 5,000 people affected as of October 6, according to OCHA. The GoK and relief agencies are increasing case management support and disease surveillance activities in Mandera, Wajir, and Isiolo counties. UNHCR and partners are monitoring for potential dengue cases in the Dadaab refugee camp complex.
- On October 7, USAID/OFDA-provided malaria medication, adequate to treat 165,000 people, arrived in Nairobi for onward transport to health clinics and mobile clinics in drought-affected areas of the Horn of Africa.
- In FY 2011, USAID/OFDA provided \$10.7 million to Kenya for nutrition and WASH programs, benefiting more than 1.4 million people countrywide.

#### Somalia

- The Nutrition Cluster—the coordinating for nutrition-related activities in Somalia—continues to scale up nutrition assistance to reach Somalia's 450,000 malnourished children under five years of age, including 190,000 children who are suffering from severe acute malnutrition (SAM). The cluster is also addressing the needs of pregnant and lactating women in Somalia. Since January, cluster partners have treated nearly 350,000 children for moderate acute malnutrition and SAM through outpatient therapeutic programs, stabilization centers, and targeted supplementary feeding centers throughout Somalia. Since August, the Nutrition Cluster has provided blanket supplementary feeding to families with malnourished children under five years of age, supporting nearly 73,000 households in Bay, Bakool, Hiran, Lower Shabelle, Middle Shabelle, and Middle Juba regions as of October 7.
- Vulnerable populations are at increased risk of transmitting waterborne diseases, such as acute watery diarrhea, during Somalia's second cholera transmission season, which lasts from October to November. The U.N. World Health Organization and partners are monitoring populations transiting into Mogadishu and other urban areas to identify potential increased risk for measles transmission. To date in October, relief agencies have vaccinated more than 150,000 children between six months and 15 years of age against measles. In total, relief agencies have vaccinated more than 1 million children since July, representing 44 percent of the targeted 2.3 million children, according to OCHA. In addition, relief agencies have also vaccinated more than 450,000 children under five years of age against polio.
- In FY 2011, USAID/OFDA provided more than \$26.5 million for interventions in health, nutrition, and WASH, benefiting more than 1.2 million people countrywide. USAID/FFP also provided an additional \$5 million in FY 2011 funding for nutrition programs.
