INTRODUCTION

The objective of USAID Energy Program is to support Georgia's efforts to facilitate increased investment in power generation capacity as a means to increase national energy security and facilitate economic growth. The Program will have a significant impact on energy market reform efforts of the Government of Georgia (GoG) to comply with the country's obligations under the Energy Community Treaty (EnCT). The investment objective will be achieved through the provision of technical assistance to a variety of stakeholders in the energy sector.

The ultimate goal of this Program is to enhance Georgia's energy security through improved legal and regulatory framework and increased investments in the energy sector. The ultimate expected outcome of this Program is an energy legal and regulatory framework that complies with European requirements and encourages competitive energy trade and private sector investments.

DONOR COORDINATION MATRIX

The Donor Coordination Matrix is a dynamic tool designed to improve *coordination* among government, stakeholders and the *donor* community of energy related programs and projects and promote coordinated support to the Georgian Energy Sector. The Donor Coordination Matrix purposes are to:

- (i) Provide a complete inventory of energy programs and projects;
- (ii) Facilitate access to stakeholders and representatives of the donor community to the inventory of energy programs and projects;
- (iii) Identify duplication and overlapping initiatives to improve efficient support by the donor community; and
- (iv) Identify omissions and gaps in donor supported programs that need to be filled to accelerate energy sector development.

The Donor Coordination Matrix is also meant to be used for the development of strategic partnerships to maximize the impact of projects through improved donor coordination.

The Donor Coordination Matrix identifies energy related programs and projects and includes information on Donor name, timeline (start & end), funding amount, points of contact, contact information for donor funding and USAID Energy Program.
