Executive Summary:

This Annual Progress Report covers the period of 3/1/2020 - 9/30/2020 as required in Section A11/1 of Cooperative Agreement 72026320CA00002 and consists of this summary document of the three previously-submitted, detailed quarterly reports.

USAID Scholars Activity works towards achieving the end outcome of "A better developed and gender-balanced cadre of skilled professionals who can apply and impart new knowledge and skills in priority sectors", which is subpurpose 2 of USAID/Egypt's Higher Education Initiative (HEI) Project Appraisal Document (PAD) – thus clearly showing the Activity's contribution to and alignment with USAID/Egypt's strategy.

AUC works in collaboration with six Egyptian public and private universities that are committed to providing quality education for the students who are enrolled in the Activity; Zewail City of Sciences and Technology, Cairo University, Ain Shams University, Alexandria University, Mansoura University and Assiut University.

This Annual Report highlights the USAID Scholars Activity's Year 1 (March 1, 2020 – September 30, 2020) accomplishments, challenges and action taken. This reporting period highlights the progress of the USAID Scholars Activity in various areas related to the progress of the program activities despite the prevailing unprecedented times in light of the COVID-19 pandemic which both USAID and AUC acknowledge.

AUC is committed to achieving these goals towards the students who will receive scholarships in various majors that contribute to Egypt's development. USAID Scholars Activity recipients will be supported by the members of the AUC Activity's team throughout the period of their scholarships to enable their academic success and to ensure that they gain the necessary leadership skills and practical experience that will prepare them for life and careers after graduation.

Since the inception of the USAID Scholars Activity team has been working very hard to achieve key milestones on the different fronts;

Recruitment of the majority of the USAID Scholars Activity team. The hiring of the remaining positions; the
Finance Manager and Ain Shams Program Coordinator is underway.
VAT Tax Exemption Letter issued within one month from receipt thereof.
MEL plan and progress reports were developed and submitted to USAID as per the due dates.
Conducted successfully the Strategic Advisory Board kick-off meeting.
Developed the USAID Scholars Activity Communication Strategy in addition to the USAID Scholars
Activity's digital outreach messages.
Completed the formulation of the Technical Steering Committee.
Prepared for signature the partner universities sub-agreements.
Students' agreements are developed and ready for signature by the students and their guardians.
Ordered laptops for cohort 1 selected students since July 2020.
Concluded the majority of the stages of the outreach, recruitment and selection activities for Cohort 1 students
using a blended approach of online and limited physical modalities.
a. Outreach and Recruitment Activities: Digital and limited physical outreach activities conducted

- a. <u>Outreach and Recruitment Activities:</u> Digital and limited physical outreach activities conducted by AFS-Egypt and Newton Educational Services;
- b. <u>Application Screening:</u> Successful outreach activities resulted in receiving 4406 applications from all over Egypt;
 - i. 2201 of which are eligible;
 - ii. 184 of which are Takafol and Karama;
 - iii. 84 students with disabilities.

- c. <u>Interviews:</u> AFS-Egypt conducted a total of 529 interviews out of the 560 short listed both face-to- face and online interviews based on the candidates preferred modality classified as follows:
 - i. 417 Face-to Face Interviews at AUC Falaki Campus;
 - ii. 112 Online Interviews via Zoom (also used AUC Falaki Campus to host interviewers);
 - iii. 31 candidates did not show up.
- d. <u>Home Visits:</u> AFS-Egypt conducted physically home visits to the 230 candidates who successfully passed the interviewing stage. All the health and safety measures taken by AFS to protect the candidates and volunteers/visitors. The home visit to the North Sinai candidate was conducted online due to security reasons. Most of the home visits are executed during the month of September and will continue towards the first week of October.

Successful outreach and recruitment efforts resulted in receiving 4406 applications from all over Egypt; 2201 of which are eligible;184 of which are Takafol and Karama and 84 students with disabilities.

Highlights of Project Activities

Strategic Advisory Board Kick-off Meeting

AUC formed an Advisory Board with a mandate of setting strategic placement policies and direction at partner universities for the life of the activity. The Board is chaired by AUC Counselor, the former Secretary-General of the Egyptian Supreme Council of Universities, and includes the Presidents of all partner universities and the current Secretary-General of the Supreme Council of Universities. The Board will convene bi-annually and the TOR of the Strategic Advisory board was shared and approved by USAID. *Please refer to Annex (1) The Strategic Advisory Board Terms of Reference*

The preliminary Advisory Board Kick-off Meeting was successfully convened on June 10th, 2020 with the virtual presence of the partner university presidents via ZOOM. During the meeting the following points were discussed;

- Adding nursing as a field of study which was welcomed by all university presidents and there has been a
 proposal by AUC Counselor to introduce a new credit-hour, fee-based and English-medium program for this
 specialization.
- The challenges posing around the students' requests to transfer between majors. This challenge will be mitigated through having in place clear and firm rules during the early stages of recruitment and announcement. These rules could be an integral part of the student scholarship agreements.
- The importance of a smooth process for credit transfer between universities, and this should be handled as a priority by both the Advisory Board and Technical Steering Committee.


Nursing Program


During the kick off meeting of the Strategic Advisory Board on June 10th, 2020, the members discussed adding nursing as a field of study to the majors offered by the USAID Scholars Activity. This was welcomed by all university presidents and there has been a proposal by AUC Counselor to introduce a new credit-hour, fee-based and English-medium program for this specialization to be run at all five public universities.

However, AUC encountered some challenges related to the process of obtaining approvals through the Cultural Affairs Committee at the Supreme Council of Universities. The AUC team has been pushing through other means to speed up the process through AUC Counselor and there was a small window of opportunity to start this program this academic year which kept the AUC hopeful. However, AUC has been in close touch with the HE Nursing Sector Committee and several other endeavors that all resulted in a decision to postpone this program to the next academic year 21/22.

USAID Scholars Activity Outreach and Recruitment Efforts

The USAID Scholars Activity digital campaign was launched on June 12, 2020. The announcement was shared by the Minister and Ministry of Education, Ministry of Youth & Sports, National Council for Women, Marj3, AUC Alumni Facebook Page and National Council for Disabilities Affairs. Partner's universities have also shared the announcement on their websites. Takaful wa Karama has shared with AUC a list of 500 families with Thanaweya Amma students who meet financial need, geographic distribution, and previous high academic score selection criteria. This list represented a very good target group for the program from all 27 governorates.





<u>USAID Scholars Activity Applications Screening, Interviewing and Home Visits</u> Processes

During this reporting period, the following activities have taken place in the applications screening, candidates interviewing and home visits.

Applications Screening:

The USAID Scholars Activity recruitment campaign which was launched on June 12, 2020 has resulted in receiving 4406 applications from governorates all over Egypt. Immediately after the applications deadline, AFS started the screening process for the received 4406 applications which are classified as follows:

Application screening stage of the 4,406 applications resulted in having 2,101 Eligible candidates; and 2,305 Ineligible candidates; 184 of which are Takafol and Karama and 84 students with disabilities.

The ineligibility of the applications was based on the following;

- 1- Incomplete applications
- 2- Incomplete essential requested documents
- 3- Type of school

Application Technical Review and Essay Assessment:

The 2,101 eligible candidates were filtered down to 560 candidates according to the criteria developed by the USAID Scholars Activity and approved by USAID. The criteria were developed according to the following metrics:

- Equitable gender balance; females constitute 50% of the scholarship shortlisted scholars
- Full country coverage, including rural areas and secondary cities from socio economically-marginalized sectors. (villages then marakez then cities)


- Governorates proportional distribution considering;
 - a. Population density. Source: https://www.capmas.gov.eg/Pages/populationClock.aspx# Accessed August 27, 2020.
 - b. Schools in the poorest villages or governorates according CAPMAS and Newton Thanawya Amma Research Study highlighted in the excel sheet.
 - c. Governorates with population density less than 0.5%, have a minimum of 4 eligible applicants. There were 9, 28, 13 and 17 eligible applicants from North Sinai, Red Sea, New Valley and South Sinai respectively. It was seen as necessary not to risk overlooking the frontier/border governorates.
- All eligible candidates with disabilities (32 applicants)
- All eligible Takaful and Karama students (78 applicants)
- All eligible orphans applied (2 applicants)
- Applicants who got the highest scores in all areas of; Application, Essay Review and Financial status.

The above selection criteria were primarily focused on the geographical distribution of the applications that the number of candidates who are eligible to be selected in each governorate proportioned to the population density in each governorate. The poorest villages and governorates as per CAPMAS and Newton Thanawya Amma Research Study have been given priority. *Please refer to Annex* (2) of this report for the Geographical Distribution of the Eligible Candidates.

Interviews Phase:

Based on the approved interview phase criteria, AFS-Egypt contacted the short listed 560 candidates, invited them for interviews and gave them the choice between face-to-face and online modalities. All the 560 eligible candidates received a Google form that allowed them to register for the interview with their preferred modality. Interviews were scheduled on four days; three face-to-face, September 3rd, 4th and 11th, and one day, September 12th was designated for online interviews, at AUC Falaki Academic Center.

AFS-Egypt conducted a total of 529 interviews classified (a per the applicants' documented preference) as follows:




- 417 Face-to Face Interviews at AUC Falaki Campus
- 112 Online Interviews via Zoom (also used AUC Falaki Campus to host interviewers)

The remaining 31 candidates either declined the scholarship or did not respond to the Google Form, where they entered their preference for interview modality.

AFS-Egypt Interviews Training:

Interviews per Governorate



On August 28th, 2020 and prior to the actual implementation of the interviews, AFS- Egypt conducted training attended by the volunteers who will participate in the interviews. The training was conducted by Manara Cultural Training Center¹ at AFS-Egypt premises on 6th of October and attended by approximately 35 volunteers who worked with AFS on several other projects.

The training was divided into two parts; the first part focused on orienting the volunteers on the USAID Scholars Activity and its objectives. Also, the application and the different sections it includes and the most important sections that the volunteers should focus on during the interview. The second part of the training was devoted to role play and simulation where young volunteers assumed the role of the candidates and the volunteers interviewed them. This simulation was followed by feedback and comments from the facilitators and other participants.

Home Visits:

The list of the 529 students who attended the online and face-to-face interviews was filtered down to 230 students who are eligible to receive a home visit by AFS-Egypt volunteers.

The 230 students were selected based on the following criteria;

First: Tanseeq Results

The colleges that the students got through el Tanseek must match the majors that USAID Scholars Activity is offering.

Second: Applicants who achieved the interviews cut-off score and beyond

Cut off score is 20 out of 50

Third: All eligible students with disability who achieved the interview cut off score of 20 or more All Takaful and Karama students who achieved the interview cut off score of 20 or more

Financial Need: Cut-off score around 50 out of 190

Fourth: Full country coverage

Fifth: Gender balance to the extent possible

The majority of the 230 Candidates received home visits by AFS-Egypt volunteers during September. Home visits for the rest of the candidates will continue during the first week of October with the exception of North Sinai which will be conducted online due to security reasons.

AFS-Egypt is in the process of holding 230 home visits (both online and in-person) while observing all precautionary measures such as the use of face masks and sanitizers for the physical home visits. AFS-Egypt opted to conduct online home visits for security reasons such as North Sinai.

The results of the home visits and the final selection of cohort 1 scholars and alternates will be reported during FY21, Q1.

AFS-Egypt Home visits Training:

On September 7th AFS-Egypt conducted two online training sessions for the volunteers who will undertake the home visits. The entire AUC team participated in the two training sessions. The training included different scenarios that the interviewers need to consider while verifying the financial status of the candidates. During the second half of the training, participants were divided into groups to join the breakout rooms to evaluate real/authentic applications. Volunteers were specifically asked to observe the most catching notes from the application that would translate to different scenarios other than what is stated in the application.

The training was an eye –opener on the home visits' protocol. It has served to explain where the visits fall on the timeline, their purpose, their ethic and dress code, and the importance of observing gender balance and hygiene. It was also highlighted not to improvise on behalf of the USAID Scholars Activity regardless of how much the family of the candidate wants an answer. Different measures and precautions were explained in light of COVID-19 to ensure the safety of both the volunteers and family members visited.

USAID Scholars Activity Communication Plan

The work on devising the USAID Scholars Activity Communication Plan is initiated to communicate the USAID Scholars Activity objectives, achievements, and results. This will assist in promoting the concepts of equitable access to higher education and quality education for employability and economic development, in sectors of high economic priority. *Annex* (3) *for the USAID Scholars Activity Communication Plan*.

Jameel Poverty Action Lab (J-PAL³)

As per the MEL plan, the USAID Scholars Activity will call upon, to the extent feasible, AUC's long-established centers and units with proven track records in areas related to the Activity's MEL system. These include, among possibly others: IT; Strategy Management and Institutional Effectiveness (SMIE); Access to Knowledge for Development Center (A2K4D); Center for Learning and Teaching (with its expertise in formative assessment); and, the Abdul Latif Jameel Poverty Action Lab (J-PAL). AUC is now hosting the Jameel Poverty Action Lab (J-PAL) as the new regional research center in the Middle East and North Africa that focuses on alleviating poverty and improving lives through evidence-informed policymaking. One significant sector of J-PAL interest is to measure to what extent interventions/training and study opportunities make a difference in the lives of disadvantaged students.

³ The Abdul Latif Jameel Poverty Action Lab (J-PAL) is a global research center working to reduce poverty by ensuring that policy is informed by scientific evidence. Anchored by a network of 227 affiliated professors at universities around the world, J-PAL conducts randomized impact evaluations to answer critical questions in the fight against poverty.

J-PAL showed interest in studying the interventions offered by the Scholars Activity program, while looking also at previous similar programs, such as LEAD.

On Wednesday August 26th, 2020, AUC team met with representative of the J-PAL to understand more about their scope of work, and what kind of research and impact could be measured to evaluate the immediate impact that USAID Scholars Activity could have on the students in their post academic life and if they will be able to;

- 1- Contribute to their community
- 2- Impact their peers positively
- 3- Enhance their entrepreneurship skills through the start-ups/companies they created
- 4- Become leaders with enhanced leadership skills and assume leadership roles.
- 5- Improve their English Language Proficiency skills
- 6- Benefit from Career Follow-up and Guidance reflected in their ability to join the job market
- 7- Qualify tojJoin the study abroad program

During the discussion, J-PAL team highlighted the fact that they are not a consulting agency. They do not charge money for their research studies and their professors volunteer their services. However, costs associated with data collection will need to be paid. The USAID Scholars Activity team filled out and submitted a match-making form to J-PAL in order to give them an idea on how best the Activity could benefit from their services.

Zewail City of Science and Technology Update

Zewail City of Science and Technology, according to a decree from the Supreme Council of Universities, has become part of the Tanseek system, and hence will be treated as other public universities. has come as one of the challenges facing the program, given that this information was not available at the time of the scholarship announcement. In addition, Zewail City has announced that they would not accept resident students this year due to the COVID-19 situation.

English Language Component

Both the One-Month Pre-Academic Program and the Preparation Year (for nominated AUC and Zewail students) will be conducted online. The third program is the Supplemental English Language Program designed to engage the students who are enrolled in Cairo, Ain Shams, Mansoura, Assiut and Alexandria Universities in English language activities throughout the Academic year. This program will be delivered through an online modality as well. The students will participate in this program through the online modality. Course content will cover critical thinking activities, information and digital literacy skills and academic content in English through reading, writing, listening and speaking. At the end of each course, students will need to pass an assessment to qualify for the course at the next level.

The different available pre-test options include paper-based ITP TOEFL and IELTS, computer-based IELTS, and iBT TOEFL that all require physical attendance of the test candidates. Other online exams, such as the IELTS Indicator and TOEFL Home Edition are not feasible options because they are either not being offered in Egypt, do not allow group registration or will cease to exist after October 30. Given the directions received from USAID AOR, no physical events can be arranged under any USAID activity at this stage AUC team has already been looking into other options that allow students to sit for a pre-test through an online modality.

Cohort 2 Online Application System

AUC is currently working on designing an online application system for Cohort 2, which the Activity did not have the chance to do given the time constraints between award and launch of the project amidst COVID-19 lockdown. The online Application is a digital database, to solicit adequate information on the applicants' basic information, community service and extracurricular activities, financial need data, and essays. AUC started to work on this project based on lessons learned driven from the Cohort 1 application system. Too many challenges have been faced with the paper-based application that all necessitated working on that front and using an online application system to improve the quality of the process and decrease the amount of labor needed to collect and follow up on the application back and forth with the Post Office as well as allowing real time statistics generated

This online application system will be designed to easily interphase with the USAID Scholars Activity database. This project will provide a consistent and solid data management system that includes all scholarship recipients and protects the validity of the data.

Study Abroad Component:

USAID TEAMS Orientation

On August 18th, 2020 AUC attended "From TRAINET to TEAMS" webinar organized by USAID and conducted by TEAMS in Washington DC. The webinar tackled the TEAMS application and highlighted changes from TRAINET and new features in TEAMS through the presentation of the application itself. Following the meeting, USAID Scholars Activity requested a more in-depth training on the system which is new to the AUC team who will work on the Study Abroad component. USAID advised that the AUC team could watch the 10 tutorial videos associated with TEAMS which will share in due respect. Then, if there is still a need for further training, it could be facilitated.

AUC International Program Office (IPO)

The AUC team met with the Senior Director of International Programs (IPO) at AUC where they discussed the selection criteria they use for the selection of the students who are eligible to travel for the U.S. semester abroad in addition to the steps that the students must take to complete all the requirements to travel abroad. The AUC Senior Director of International Programs stated that in order for the students to be eligible for the U.S. Semester Abroad they must have a minimum GPA of 3.2, they need to be in the sophomore year while applying, they need to be declared and meet English proficiency requirements at the time of applying. Lessons learned with previous scholars were also discussed including the most appropriate time to start working on the process of the semester abroad for the scholars. Finally, the Senior Director of the IPO promised to put the AUC team in contact with the New York Office to better coordinate efforts in the coming period and also to share the contact information of the 69 universities that AUC has partnered with in the U.S. to start the communication in that regard.

AUC Center for Students Well-being (CSW) Memorandum of Understanding (MoU)

AUC team is currently finalizing a Memorandum of Understanding (MOU) with the Center for Student Wellbeing, including their future role in supporting the public university disability centers. This MoU includes the following roles and responsibilities of the CSW in addition to the reporting requirements to ensure that the scholarship recipients are provided with the needed support to continue progressing in their academics and social integration.

- Review and support the application process to ensure that it is user-friendly to students with disability.
- Orient and train service providers during the recruitment and selection process to ensure the provision of an inclusive environment for students with disabilities.

- Provide support to AUC USAID Scholars Activity coordinators in monitoring and following up on student's well-being.
- Provide support to students that are considered at risk (2.0 GPA or below) of losing their scholarship and helping to put them back on track.
- Nominate/Provide access to a Psychological Advisor to support and lead students' mental, emotional, and
 psychological health across all the partner universities. This Advisor will also participate in some student
 selection activities, such as the Final Selection Camp and On-boarding Orientation.
- Conduct Workshops with the aim of raising students' awareness about maintaining their well-being, through the "Better You," "Healthier You," "Able You" series.
- Raise awareness through social media on the subject matter amongst the program SwDs as well as other interested students.
- Assess the need for and select the appropriate tools for partner university disability centers.
- Design and deliver Outreach Sessions to build partner university center staff, faculty and administrators' capacities.
- Train staff of the disability centers located in partner universities on the best practices and tools that promote the efficiency of those centers.
- Help facilitate a Study Tour at AUC to improve the partner university disability centers efforts in building their capacities.
- Help train partner universities' coordinators, facilitators, students, staff and faculty of the AUC USAID Scholars Activity on the Student Health 101 website and how to make the best use of it.

CSW Capacity Building Activities for AFS-Egypt teams

AUC organized two capacity building sessions for AFS volunteers facilitated by the CSW personnel. The first one which was conducted on September 2nd, 2020 focused on how to deal with the students with disabilities during the interviews. The second one is scheduled to be conducted on October 6th, 2020 and will tackle the techniques and messages that should be delivered during the online camp which is designed to include the students with disabilities among other students.

USAID Scholars Activity Technical Steering Committee

AUC established the Technical Steering Committee to provide support and guidance to the USAID Scholars Activity throughout the lifetime of the project. This committee includes high profile experts and major stakeholders who support the implementation efforts and build strong synergies with major USAID projects while ensuring private sector collaboration to achieve program objectives.

During this reporting quarter, the USAID Scholars Activity interviewed six candidates of the USAID scholarship programs alumni nominated by USAID as per guidance from the relevant project directors. The evaluation of the candidates was based on a scoring rubric that includes all the metrics required to provide a fair assessment of the proposed candidates. *Please refer to Annex (4) of this report for the Scoring Rubric and Annex (5) for the Technical Steering Committee Terms of Reference*

The interview panel decided on selecting 2 candidates from LOTUS Program and HEI/STEP Program who were the best to express how they will contribute to the mandate of the Steering Committee and for their similar backgrounds to the program's anticipated scholars.

Having all the members on board, the first Technical Steering Committee is scheduled to be convened on October 7th, 2020. The TOR was shared and approved by USAID.

Recruitment of Project Staff

Upon USAID/Egypt's approval of the proposed candidates for COP and DCOP positions, AUC proceeded with their recruitment and they were officially on-board starting May 3rd, 2020. AUC was working diligently on the hiring process for the remaining project staff where remarkable progress has been achieved and the following staff will be on board starting the month of July 2020:

Additionally, the recruitment of the remaining positions will be finalized during the next quarter so that the full team is on board. It is important to mention that the AUC selection of staff ensured that all personnel have relevant previous experience and capacity to ensure program successful implementation.

Monitoring and Evaluation

USAID Scholars Activity MEL Plan

AUC submitted a second draft of the MEL plan after addressing USAID and SIMPLE comments and questions. The AUC team met with members of the Program Office, M&E and AOR on September 1, 2020 to discuss these comments in detail and decide on the set of indicators that the Activity will report on throughout the lifespan of the Activity. The AUC team conducted a thorough review after which a second draft was submitted for AOR approval on September 20, 2020 on creating the relevant tools and systems to implement this plan.

Internal Observation Form for Physical and Online Interviews

In order to administer the Internal Monitoring process of the interview phase, the MEL Manager created an Observation sheet that includes all the areas of the interviewing in a holistic manner. The Observation Form was not created for the candidate's assessment, but for to monitor the process and flow of the selection interviews and to ensure that interviewers follow interview protocols. The observations of different team members were recorded and communicated to AFS for corrective action. Another observation tool will be created to monitor the Online Selection Camp and will be shared during the next quarter.

Introduction:

The USAID Scholars Activity is commencing the implementation of its activities at unprecedented times, as a result of the COVID-19 pandemic. While AUC is working with partner H.E. institutions and service providers on concluding different activities related to the selection and placement of the first cohort, it is still unclear whether the implementation modality will remain as initially foreseen.

The completed stages of the outreach and recruitment activities for Cohort 1 students were implemented using a blended approach of online and limited physical modalities. During the interviewing stage, it was determined in accordance with the candidates' preferred modality. AFS-Egypt is currently preparing for the implementation of the home visits stage for the shorted-listed candidates who successfully passed the interviewing stage. Home visits will be conducted physically with all the health and safety measures taken by AFS to protect the candidates and volunteers/visitors.

The AUC and partner HE institutions continue to monitor the situation to mitigate the implementation challenges due to the current pandemic and will adjust plans, as needed, to ensure efficient and secure implementation of activities planned to assist the settling in for Cohort 1 scholars. However, opting to the online option for the implementation of the activities will incur budget implications
