



EXECUTIVE SUMMARY

During Fiscal Year (FY) 2021, the Tetra Tech (Tt) Engineering Support Program (ESP) continued to provide services to the United States Agency for International Development (USAID) in Afghanistan. This support was delivered through the ongoing provision of quality assurance (QA) and construction management services (CMS) to several large-scale, USAID-funded construction projects. Additionally, Tt ESP and USAID collaborated on several new Activities, under which Tt ESP will provide planning, QA services, and prepare studies for the long-term growth of several sectors critical to Afghanistan's development.

During the first two quarters (Q) of FY 2021, expatriates returned to Afghanistan, and the local office staff returned to the Kabul office on a flexible schedule as needed while adhering to Coronavirus Disease-2019 (COVID-19) health and safety (H&S) requirements. The final quarter of FY 2021 found expatriates returning to their homes of record due to the political uncertainty and rapidly increasing security issues in Afghanistan. The field staff continued to provide on-site support at the active project sites. Although additional project challenges were encountered and resolved, support for all open Activities was maintained.

Tt ESP provided support to the Afghanistan Civil Aviation Authority (ACAA) under Activity 012 and its six corresponding tasks. Support during FY 2021 focused on deliverables through Task I to assist the ACAA with achieving compliance requirements for the future International Civil Aviation Organization (ICAO) audit. Other data-gathering efforts continued for Tasks 2 and 3, associated with master and transfer planning. Additionally, Tt ESP initiated recruitment and filled the 19 positions for the Software Development Team, which were embedded within the ACAA under Task 4, and conducted safety training sessions under Task 5, at the Afghanistan Civil Aviation Training Institute (CATI) as well as virtually. Tt ESP also received USAID approval to initiate Task 6 and began the feasibility study of the Kandahar Airport's passenger and cargo terminals.

In support of the Herat International Airport design efforts, Tt ESP conducted a project kick-off, multiple site investigations, data gathering, and design reviews with the stakeholders (Activity 023). During the fourth quarter, Tt ESP submitted the 35% Schematic Design Packages for site utility, infrastructure, and facilities.

During the reporting period, for the Energy Loss Management Visualization Platform (ELMVP) project (Activity 020), Tt ESP conducted the Milestone 3 and 4 Meter Integration and Technical Loss Verification reviews.

At the Recycling Plant in Mazar-e-Sharif (Activity 021), Tt ESP had inspectors at the construction site providing quality assurance when weather conditions permitted.

In support of renewable energy projects during FY 2021, Tt ESP conducted the Initial Environmental Assessment of the Herat Solar Power Plant and attended consultations with various stakeholders to determine potential environmental and particular impacts of the project (Activity 011). In addition, Tt ESP worked with USAID on the expansion of the scope of Activity 015 to include a load flow study for the Balkh Solar Power Plant. Tt ESP also provided support for the Herat Wind Farm (Activity 017), where the contractor began mobilization activities, and the Naghlu Floating Solar Power Plant (Activity 022), which remained in the pre-construction phase.

Other Activities under Tt ESP oversight continued towards completion during the reporting period. Tt ESP's support for the Salang Tunnel Substation project took the form of final inspections, investigation of site issues, and rectification of deficiencies. As of the reporting date, Tt ESP is awaiting to review the rectification of issues raised by the Special Inspector General for Afghanistan (SIGAR) and Tt ESP. Additionally, Tt ESP reviewed and recommended approaches to settle the contractual disputes between the contractor and Da Afghanistan Breshna Sherkat (DABS).

The Power Transmission Expansion and Connectivity (PTEC) program contractor returned to the site in early August 2021, after demining and time extension were resolved late in the Q3 FY 2021. Tt ESP



site inspectors returned in early September to the field to observe rectifications of deficiencies of the North East Power System (NEPS)-South East Power System (SEPS) Connector Transmission Lines towers and continued through the end of Q4 FY 2021.

During this reporting period, construction progressed under the Strengthening Watershed and Irrigation Management (SWIM) program (Activity 007), and Tt ESP continued site inspections at the active sites. At the end of the reporting period, there remained two active sites out of seventeen sites.

During FY 2021, Tt ESP expanded the 2020 Entry Level Engineers Program (Activity 013) to include software developers in support of the software development project under Task 4 of Activity 012. In total, Tt ESP onboarded 10 engineers and 2 software developers to support active Activities under the Tt ESP program during the FY 2021 reporting period.

Throughout FY 2021, COVID-19 challenged the start of the Internship Program (Activity 018). Due to the constraints from the academic schedules of the local universities and the restrictions imposed from COVID-19, Tt ESP was unable to start the Internship Program during FY 2021.

Tt ESP received a 45-day partial stop-work order on September 13, 2021, from USAID, for Activities under the ESP contract, with 6 Activities being completely stopped for the duration of the stop-work order. The affected Activities included Activity 012 Afghanistan Civil Aviation Authority Engineering, Planning, and Capacity Building Support (Tasks 1-6), Activity 013 Entry Level Engineering Professionals Program, Activity 018 Internship Program for Afghan Women in Engineering and Architecture, Activity 020 Energy Loss Management Platform, Activity 21 Quality Assurance Services for Recycling Plant Value Chain in Northern Afghanistan, and Activity 023 Herat International Airport Design. Just before the end of the quarter, USAID reinstated limited work effort under Activity 013 to allow for final training and reporting activities to be completed.

Tt ESP has retained staff affected by the stop-work order to retain readiness when lifted, as directed by the Contracting Officer (CO). For more details on all of ESP's Activities supported during this reporting period, please refer to Section 2.2 below.

1.0 BACKGROUND

Tt ESP provides technical assistance in the transportation, vertical structures, energy, and water and sanitation sectors to the USAID Afghanistan Office of Infrastructure (OI). Tt ESP is designed to provide rapid-response architectural and engineering services from a Kabul-based core of United States National (USN), Third Country National (TCN), and Cooperating Country National (CCN) technical professionals, as well as the necessary administrative support staff. Tt ESP has also established satellite offices in multiple Afghan cities to provide operation bases for site inspection activities that take place far from the main Kabul office. Tt ESP is backed up by a home office support network and approved subcontractor reach back staff located in offices around the world.

The Tt ESP team performs planning, design and design review, technical support, monitoring and evaluation of construction management, and QA oversight support of contracts funded by USAID and managed by other parties. Tt ESP also contributes to capacity development, mentorship, and collaboration, and coordination with USAID and other stakeholders as directed by USAID.

The current contract period of performance ends on January 22, 2022.

2.0 KEY PROGRAM ACTIVITIES

2.1 NARRATIVE

This report covers the reporting period from October 1, 2020 to September 30, 2021, the United States Government's Fiscal Year 2021.

The challenges raised by the COVID-19 outbreak found Tt ESP working to ensure that the performance of essential program services continued. The current Kabul-based expatriate staff



worked from the Kabul office during this period, with a portion of the local staff reporting to the office as needed while adhering to COVID-19 health and safety requirements. The local office staff supporting Activities primarily worked remotely from their homes and embraced flexible work hours while engaging online through meeting platforms and teleconferencing. Activity teams worked closely with their USAID counterparts through a combination of teleconferencing and approved chat platforms to maintain a clear line of communication and provide similarly efficient levels of responsive support to USAID as during the pre-COVID-19 environment.

Deliverable due dates were upheld unless circumstances requiring ground site visits, face-to-face engagement with stakeholders, or other issues arose that would impact the deadline to successfully complete the deliverable. In some cases, if reporting or data gathering required a site visit, face-to-face meeting, or other constraining requirements, Tt ESP staff evaluated and

2.2 ACTIVITY KEY ACCOMPLISHMENTS

The key accomplishments completed under each Activity during the FY 2021 reporting period are detailed below.

Activity 001 General Management and Program Support

- During this reporting period, Tt ESP continued to provide program management and operational assistance to Tt ESP's in-country team supporting the above-referenced 17 Activities and 6 Tasks under Activity 12. As of the end of FY 2021 Q4, this team included 10 USN/TCN long-term technical assistance (LTTA) staff, 126 full-time CCN staff, and 6 CCN on-call site inspectors. Ten of Tt ESP staff evacuated Afghanistan, of which three are supporting the Program from their new location.
- Tt ESP continued to review, audit, and maintain strict control of time billed and costs incurred under the Program.
- Tt ESP continued to review and assess the Level of Effort (LOE) allocation for each of the current and future Activities.
- A number of activities have been put on "Pause" within Tt ESP's office or at the contractor level. Tt ESP continues to provide design review services for projects for which construction activity has paused.

Activity 002 ESP Security Services

- Throughout FY 2021, Tt ESP monitored security operations within ESP's area of operations, maintaining awareness of ongoing security threats. When necessary, Tt ESP revised its security approach or rescheduled inspection activities.
- During FY 2021, many of the projects were interrupted due to insurgency activity in project areas. On August 15, 2021, the Taliban took control of Afghanistan, leading to a reduction in insurgent activities, and Tt ESP resumed inspection activities.
- Three Serious Incident Reports (SIRs) were submitted to USAID during this FY 2021.
- Tt ESP's security team provided security intelligence and services in support of project work during the reporting period in a total of 26 provinces across Afghanistan.
- In response to the takeover of the Afghan government, the Taliban have ceased hostility towards ongoing construction projects. As a result, Tt ESPs security footprint has been reduced to providing and monitoring by Tt ESP Risk Management Consultant (RMC), guard services at our offices, and transportation from the offices to and from the job sites.

Activity 005 NEPS-SEPS Connector Transmission Lines

- The list below provides a summary of completed work under the NEPS-SEPS Connector Transmission Lines (TLs), as verified by Tt ESP's site inspectors through the end of FY 2021 Q4. Progress is based on construction at the site and not invoicing, which lags behind the physical construction.
 - o Foundation excavation is 96.8 percent (1,354 of 1,399) complete.
 - Pad plain cement concrete is 94.5 percent (1,322 of 1,399) complete.
 - Pad reinforced cement concrete is 92.35 percent (1,292 of 1,399) complete.
 - o Tower leg reinforced cement concrete is 92.21 percent (1,290 of 1,399) complete.
 - Earth resistance testing is 11.8 percent (165 of 1,399) complete.
 - o Backfilling is 74.84 percent (1047 of 1,399) complete.
 - o Field Density Tests for backfilling is 42.39 percent (593 of 1,399) complete.



- Tower erection is 64.26 percent (899 of 1,399) complete.
- Aluminum Conductor Steel Reinforced conductor stringing is 5.2 percent (18.98 of 362.83 kilometers [km]) complete.
- During FY 2021, Tt ESP reviewed contract Amendment No. 6 (250-day time extension), Amendment No. 7 (demining re-clearance subcontract), and Amendment No. 8 (211-day time extension) and provided comments and recommendations to USAID.
- During FY 2021, Tt ESP completed reviews of seventeen of the contractor's invoices and submitted the corresponding Invoice Review Reports to USAID for approval.
- During FY 2021, Tt ESP submitted twenty-six Bi-weekly Construction Progress Map Reports to USAID, which outlined and explained the impact of the Land Acquisition and Resettlement Plan (LARP) and war damages on construction progress.
- During FY 2021, Tt ESP attended six inspections to verify material delivered to the contractor's Gelan Store.
- On January 10, 2021, Tt ESP submitted a recommendation memo evaluating DABS' Demining Subcontract Bid Evaluation Report for the October 22, 2020 bid opening to USAID.
- On February 20, 2021, Tt ESP submitted Letter No. A-005-0058, which detailed long-standing project delays and resolution recommendations to USAID.
- On March 9, 2021, Tt ESP submitted Letter No. A-005-0059, which analyzed the project LARP issues and provided recommendations to USAID.
- On March 29, 2021, Tt ESP submitted a memo memorializing the demining re-clearance bid opening that occurred on March 27, 2021, to USAID.
- On August 2, 2021, Tt ESP submitted Letter No. A-005-0061 to USAID, addressing the request from the contractor and DABS for the release of 50% payment for tower erection invoices and price breakdown.
- On August 28, 2021, Tt ESP's third-party inspection team started inspecting erected towers at all five sections based on the contractor's schedule.
- On September 9, 2021, Tt ESP mobilized its CMS and health, safety, and environmental (HSE) inspectors to all five sections for the inspection of construction activities.
- On September 14, 2021, Tt ESP submitted recommendation Letter No. A-005-0062, which reviewed the merit of the contractor's force majeure claims to USAID.

Activity 006 Salang Tunnel Substation Construction Oversight and Quality Assurance

- During FY 2021, Tt ESP conducted two site visits to the Salang Tunnel Substation to monitor
 the substation's general performance, investigate system technical issues, and confirm proper
 rectification of open defects and delivery of spare parts.
- On October 10, 2020, and December 12, 2020, Tt ESP conducted site visits at the Salang Tunnel Substation to investigate the damaged medium voltage (MV) cable sections and defects on the Power Transformer Control Cabinet and provided its findings and recommendations to USAID through Letter No. A-006-0083 and email correspondence.
- On December 6, 2020, Tt ESP submitted Letter No. A-006-0084 to USAID, which included an analysis and recommendations to the contractor's claims for equitable adjustment.
- On January 21, 2021, Tt ESP submitted USAID's requested documents in response to the Request for Information (RFI) received from the SIGAR.

- On September 13, 2021, USAID issued a 45-day stop-work order to Tt ESP for this Activity.

Activity 020 Energy Loss Management Platform

- During this reporting period, Tt ESP reviewed multiple lists of additional meters supplied by DABS against the corresponding Single Line Diagrams for the Kabul area MV networks, junctions, and substations to assess the continuity of meters and the feasibility of loss evaluation.
- During this reporting period, multiple routine and ad hoc meetings were held with USAID, DABS, the contractor, and their subcontractors to coordinate and perform verifications of the ELMVP.
- Throughout the reporting period, Tt ESP conducted the Milestone 3 and 4 reviews to verify meter integration, technical losses, data exports to the Head End System (HES), and flare map logic layer in the developer's version of the ELMVP.
- On October 15, 2020, Tt ESP submitted a memorandum with Tt ESP's recommendation on the contractor's proposal to adjust the Milestone requirements for this Project to USAID.
- On January 12, 2021, Tt ESP completed the review of the developer's version of the ELMVP along with the contractor's Milestone 3 Report. Following the review, Tt ESP recommended the report for USAID's approval.
- On January 17, 2021, Tt ESP submitted the Milestone 3 Payment Verification Report to USAID.
- On February 16, 2021, Tt ESP attended a demonstration of the ELMVP virtually organized by the contractor, with DABS and USAID in attendance.
- On May 6, 2021, Tt ESP conducted reviews of the contractor's proposal, contract requirements, approved methodology, and the data constraints for Milestone 4 and submitted the technical recommendation to USAID.

- On September 13, 2021, USAID issued a 45-day stop-work order to Tt ESP for this Activity.

- On January 5, 2021, all work was stopped due to inclement weather. The subcontractor resumed work at the site on March 30, 2021.
- On February 23, 2021, Tt ESP submitted Letter No. A-021-0001 detailing recommendations for raised recycling plant design concerns to USAID.
- On February 27, 2021, Tt ESP submitted Letter No. A-021-0002 detailing recommendations for raised electrical design concerns to USAID.
- On September 13, 2021, USAID issued a 45-day stop-work order to Tt ESP for this Activity.

Activity 022 Quality Assurance Services for 20 MWac Floating Solar - Naghlu

- During this reporting period, Tt ESP reviewed and shared comments and recommendations with the contractor on design submittals received.
- During this reporting period, Tt ESP completed the processing of the contractor's submittal packages for the technical specifications and transmission line layouts, photovoltaic (PV) modules, and mobilization plan.
- During this reporting period, Tt ESP, USAID, DABS, and the contractor conducted regular monthly meetings and ad hoc Engineering coordination meetings to discuss and review the project progress status, concerns, and any expected delays or challenges.
- On April 14, 2021, Tt ESP completed the review submittal No. 0004_Rev3, the contractor's revised Mobilization Plan, and returned marked "Reviewed."
- On June 3, 2021, Tt ESP completed the review of submittal No. 0005_Rev4, the contractor's revised Quality Management Plan (QMP), and returned it marked as "Reviewed."
- On September 16, 2021, Tt ESP completed the review of the submittal No. 0019_Rev1, contractors EMMP and submitted it to USAID for their review.

Activity 023 Herat International Airport Design

- During the reporting period, Tt ESP conducted a project kick-off meeting, 10% Conceptual

- On May 24, 2021, Tt ESP submitted 10% Concept Design Packages for the site utility and infrastructure to USAID for review and comments.
- On June 3, 2021, Tt ESP submitted 10% Concept Design Packages for the facilities to USAID for review and comments.
- On August 28, 2021, Tt ESP submitted 35% Schematic Design Packages for site utility, infrastructure, and facilities to USAID for review and comments.
- On September 13, 2021, USAID issued a 45-day stop-work order to Tt ESP for this Activity.

Activity 005 NEPS-SEPS Connector Transmission Lines

- During the next reporting period, if Amendment Nos. 7 and 8 are executed, invoice processing issues are resolved, funding is confirmed, contractor's 45-day stop-work order concludes, and the contractor resumes construction activities, Tt ESP will conduct daily site visits to witness the progress of critical tasks at all five sections of the TL.
- During the next reporting period, if an application for change proposal to supply aircraft warning spheres is received from the contractor and approved, Tt ESP will complete a review.
- During the next reporting period, if materials are delivered to the contractor's store in the Gelan District of Ghazni Province, Tt ESP and the contractor will conduct joint materials receipt inspections if directed by USAID.

Activity 006 Salang Tunnel Substation Construction Oversight and Quality Assurance

Hassan Abad, and Jalal Abad canals in Jawzjan Province (Qanjogha Canal warranty expired on September 20, 2021, and Hassan Abad and Jalal Abad canals warranties expired on September 22, 2021). The Ghaznigak Canal warranty period will expire during FY2022 Q1, and a warranty inspection will be coordinated with the SWIM contractor.

 During FY 2022 Q1, Tt ESP will review and provide comments and/or recommendations to USAID for the IFC design drawings, As-Built Drawings, and other construction submittals received for the ongoing canals.

4.0 ACTIVITY MONITORING, EVALUATION, AND LEARNING

The primary goal of Tt ESP is to provide engineering support to the USAID Afghanistan Mission through a variety of activities. Per the approved Activity, Monitoring, Evaluation, and Learning Plan (AMELP) (Rev13), which was approved on January 13, 2020, Tt ESP reports on the following two indicators:

Indicator I-I rate ESP's performance through a quarterly evaluation meeting held with the USAID Contracting Officer's Representative (COR), the USAID Alternate Contracting Officer's Representative (ACOR), the Tt ESP Chief of Party (COP), the Tt ESP Construction Services Director, and the Tt ESP Communications Manager.

Indicator 2-I data is collected through quarterly requests to all related stakeholders (ESP Human Resources, Security, and Construction Contractors).

Both ESP indicators were developed under the following Sub-Intermediate Results (IRs), as identified in the USAID/Afghanistan Country Cooperation Development Strategy 2019–2023. These IRs are in support of USAID/Afghanistan's Development Objective of "Private Sector-Driven and Export-led Economic Growth Accelerated." ESP's IRs are:

- Sub-IR 1.2.4: Transportation and Energy Services Improved

5.0 CONTRACTUAL

During FY 2021, Tt operated under the Cost-Plus Fixed Fee (CPFF) Option Period Years I and 2. Tt finalized Modification II, which realigned and expanded the LOE and budget to account for the expanded scope on Activity I2, additional renewable energy activities, and the design of Herat International Airport. Additionally, during FY 2021, Tt received payment for Amendment 03 to Job Order (JO)-M-0001, finalizing the Firm Fixed Price invoicing portion of the ESP contract.

During Q4 FY 2021, Tt submitted the Closeout Plan outlining closeout procedures in preparation for the contract end date of January 22, 2022. On September 13, 2021, Tt received a 45-day partial stopwork order for Activities under the ESP contract, with six Activities being completely stopped for the duration of the stop-work order.

5.2 POTENTIAL MODIFICATIONS AND AMENDMENTS

During the next quarter, Tt ESP will continue planning closeout activities and submit the Property Disposition Plan. Tt ESP anticipates receiving feedback from USAID regarding closeout planning. Tt ESP anticipates a contract modification to reconcile the level of effort and budget realignment for the remainder of the ESP period of performance.

Additionally, Tt ESP, along with USAID, continues to monitor the situation in Afghanistan and anticipates receiving direction from USAID on whether the current stop-work order will be extended, canceled, or USAID will inform Tt ESP of its need to partially/completely terminate for convenience any of the Activities under the ESP Contract.



6.0 PROGRAM ADMINISTRATION

6.1 STAFFING / PERSONNEL

COOPERATING COUNTRY NATIONALS

During the FY 2021 reporting period, Tt ESP hired a total of 19 software engineers (Activity 012 Task 4), 12 entry-level engineers (Activity 013), 2 Project Administrators, 2 HSE On-call Site Inspectors, Electrical Engineer, Buyer, Deputy External Affairs Manager/Project Administrator, Project Specialist, Deputy Activity Manager, and a Project Administrator – HR based in Kabul and Field Office.

During FY 2021 Q4, Tt ESP received the resignation notice for the following positions: 2 Entry Level Engineers, Project Administrator, Software Developer, Lead Cook, Engineering Liaison, Construction Inspector, Cleaner, Database Programmer, External Affairs Manager, IT Manager (Kandahar) and Lead Cook (Kandahar). Most of the positions are on hold due to the uncertainty of the political situation in Afghanistan resulting from the Taliban taking over the government. The following resignations were received in FY 2021 prior to Q4, Senior Administration Manager, Buyer, Project Administrator, and five standby On-call Site Inspectors.

The Associate Director of Finance was transferred from a CCN position to a TCN position under UK Tetra Tech and is executing her Tt ESP duties remotely.

In this reporting period, Tt ESP announced job advertisements for Deputy Activity Manager, Buyer, Entry Level Engineers, HSE/Civil On-call Site Inspectors, Project Administrator, Electrical Engineer, Deputy External Affairs Manager/Project Administrator and 19 IT Software Positions via Afghan Career Search Engines (i.e., ACBAR and Job.af) and these positions were filled during the FY 2021 Q4.

There were also several staff promotions: Technical Administrative Assistant was promoted to Project Administrator, Deputy External Affairs Manager/Project Administrator was promoted to External Affairs Manager, and Deputy of Construction Management Services was promoted to Aviation Team Coordinator.

All CCN staff were organized to work from home during the outbreak of COVID-19 in FY 2020. This remained in effect during FY 2021. Although during FY 2021, CCN staff returned to the Kabul office on a flexible schedule when needed while adhering to COVID-19 H&S requirements.

UNITED STATES NATIONAL / THIRD COUNTRY NATIONAL LONG TERM TECHNICAL ASSISTANCE

During the FY 2021 reporting period, 12 staff members were on LTTA assignments for Tt ESP. The Senior Software Development/Project Manager, Aviation Analyst, and Director of Construction Services were mobilized to Tt ESP, and Construction Services Director, Activity Lead, Aviation Team Coordinator, Quality Assurance Manager, and Operations Manager were demobilized. Due to the COVID-19 outbreak in Afghanistan, all expatriate staff started FY2021 working from their home of record but returned to Kabul between November 2020 and January 2021. Furthermore, all CCN staff were allowed to work from home, effective March 26, 2020.

UNITED STATES NATIONAL / THIRD COUNTRY NATIONAL SHORT TERM TECHNICAL ASSISTANCE

During FY 2021, the Activity 012 Project Manager and seven consultants arrived in Kabul at various times during the reporting period to conduct site visits, provide training and attend stakeholders' meetings for Activity 012, Afghanistan Civil Aviation Authority Engineering, Planning, and Capacity Building Support.

GENDER

Gender equality plays a key role in staff planning for Tt ESP. During this quarter, Tt ESP staff consisted of 81.88 percent men and 18.12 percent women. The Tt ESP gender distribution is skewed heavily



towards men due to the substantial number of staff required to perform in the field. In Afghanistan, field and on-site positions are considered unsafe for women.

7.0 QUALITY

Tt ESP's QA department provides oversight and management of the underlying QA infrastructure that supports all Activities. The Tt ESP QA team emphasizes the identification of issues and monitoring of quality measures as a preventative process. These measures are based on adherence to approved processes, policies, and procedures associated with project management requirements.

Tt ESP QA activities focused on monitoring construction standards and procedures for Activity 005, including the identification and rectification of deficiencies along the NEPS-SEPS Connector Transmission Lines.

Tt ESP QA team monitored the construction and focused on the identification and rectification of deficiencies on SWIM irrigation canals (Activity 007).

Tt ESP QA team reviewed and recommended approval of the QCP for the Herat Wind Farm Power Project (Activity 017). A comprehensive QAP Plan is under development for this Activity by the QA team.

Tt ESP QA team reviewed and recommended approval of the QMP for the 20 MWac Naghlu Floating Solar Power Plant (Activity 22). A comprehensive QAP is under development for this Activity by the QA team.



8.0 SCHEDULE

The following section provides an update of construction contractor's performance under the Activities for which Tt ESP provides QA and CMS on behalf of USAID.

8.1 NARRATIVE

As of September 30, 2021, of the ongoing Activities for which Tt ESP provides QA and CMS, five Activities were behind schedule, one Activity has reached its end of the period of performance (POP), and for one Activity, a respective schedule was not provided to Tt ESP. The Activities currently behind schedule are due to contractor delays or delays caused by USAID-supported entities in providing solutions or approvals in response to critical issues. Project works have also been affected by the impact of the fall of government and COVID-19.

10.0 POTENTIAL ISSUES / RISKS / OPPORTUNITIES

10.1 SHORT TERM

Tt ESP identified the following short-term issues and risks during Q4 FY 2021. Some of the issues and risks identified below as short-term could become long-term risks if proper mitigative actions, as suggested in this section, are not taken.

- I. Risk (Activity 001): Tt ESP received a partial 45-day stop-work order from USAID for (Activity 012) ACAA Engineering, Planning, and Capacity Building Support (Task 0-6), (Activity 013) Entry Level Engineering Professionals Program, (Activity 018) Internship Program for Afghan Women in Engineering and Architecture, (Activity 020) Energy Loss Management Platform, (Activity 021) Quality Assurance Services for Recycling Plant Value Chain in Northern Afghanistan and (Activity 023) Herat International Airport Design on September 13, 2021, resulting from the takeover of the Afghan government by a terrorist organization (Taliban). Due to the nature of the Activity work and directive from USAID that no material support can be offered to any Ministry or organization overseen by the Taliban, there is a possibility that these Activities will not be restarted following the release or expiration of the stop-work order or before the end of Tt ESP's contract of January 22, 2022. The work completed to date on each Activity could become unrealized.
 - <u>Mitigation:</u> Tt ESP will include hand-over/next steps recommendations in the Activity closeout report to support planning for follow-on work by USAID.
- 2. Risk (Activity 001): Tt ESP's contract expires on January 22, 2022. Closeout processes have begun, including property disposition planning, which will be a challenge due to the political changes and the unavailability of approved entities to receive property from Tt ESP. The most challenging will be the disposition of sensitive equipment and furnishings (armored vehicles, IT equipment, office furniture, etc.). In the past, there was the option to transfer property to another Implementing Partner, but due to the evacuation, this might no longer be a viable option.



<u>Mitigation:</u> Tt ESP will review if past approved recipients are still present and available to accept the property. Tt ESP will seek USAID guidance for the disposition of sensitive equipment and consider alternative disposition options.

- 3. Risk (Activity 001): Tt ESP is challenged with paying salaries, transferring funds between incountry accounts, and converting USD to Afghanis due to recent developments in the country. Losing the ability to pay employees might limit the staff's willingness to work and local vendors' willingness to provide services and goods.
 - <u>Mitigation</u>: Various ideas and options are being considered by Tt ESP, but guidelines from USAID regarding alternative payment mechanisms or the use of US currency would be welcomed and quite possibly alleviate this issue. Tt ESP will continue to seek USAID guidance for the approved actions to address this problem.
- 4. <u>Risk (Activity 002):</u> Since the reduction in fighting due to the Taliban takeover, Tt ESP has been able to move out to project sites on a regular basis. With the reported increase in violence, be it from Islamic State in Khorasan or fractioning of the Taliban alliance, security concerns may resurface and limit access or present restrictions in the future.
 - <u>Mitigation:</u> RMC will continue to monitor security throughout the country with a focus on areas where Tt ESP is active and notify the Program of any dangers or areas of concern.
- 5. <u>Risk (Activity 005):</u> The project is behind schedule. Factors such as suspension of the construction work due to the demining re-clearance contract, LARP concerns, security, political unrest, and COVID-19 have contributed to delays and have pushed out the project completion date beyond that of Tt ESP's contract end date.
 - <u>Mitigation</u>: Tt ESP recommends that USAID consider providing guidance within the guidelines of the OFAC requirements to resolve the contract and address outstanding amendments on time extensions, disagreements, and POP extension, processing of invoices, funding confirmation source, and address unresolved LARP issues.
- 6. <u>Risk (Activity 005):</u> Prior to the stop-work order and demining contract issue, the contractor constructed tower foundations at their own risk as the cross-section drawings for the towers were not approved. Tt ESP cannot recommend payment for towers that do not have approved cross-section drawings.
 - Mitigation: Tt ESP recommends that USAID direct the contractor to promptly provide the remaining 10 cross-section drawings to Tt ESP for review. This will ensure that Tt ESP can verify completed work in accordance with the approved designs and review invoices for payment.
- 7. Risk (Activity 005): The contractor's completed and invoiced work during the stop-work order from USAID is at risk of not being paid as the contractor's contract expired on September 7, 2021.
 - Mitigation: USAID may consider paying the contractor directly for work performed.
- 8. <u>Risk (Activity 006):</u> The rectification and closure of the following open defects are outstanding. The contractor has rectified the related defects and is ready to schedule an inspection before the snowfall at Salang Tunnel Substation.
 - Twenty-one deficiencies Tt ESP identified during the several visits conducted after the final inspection and during the project warranty inspection held June 15 - 16, 2021.
 - Twelve deficiencies SIGAR identified in their report dated March 15, 2021.

<u>Mitigation:</u> Tt ESP will coordinate with the contractors to schedule a site visit to verify that deficiencies have been rectified before snowfall at the Salang Tunnel Substation site.



- 9. Risk (Activity 006): Following the substation's energization, DABS and the contractor both filed claims against each other. On May 3, 2021, DABS and the contractor had a meeting in this regard, and as a result, they submitted Letter No. H-0274 dated May 3, 2021, the contractor offered to reduce their total claim cost from United States Dollars (USD) to the contractor offered to reduce their last and final proposal provided that:
 - DABS wave the liquidated damages raised against the contractor on December 18, 2019, by DABS in Letter No. 488859; and
 - O DABS processes payment of Invoice Nos. 19 and 20 in favor of the contractor.

<u>Mitigation</u>: Tt ESP recommends that USAID coordinate with DABS to communicate with the contractor to find a common solution for the open claims in order to achieve effective completion of the Salang Tunnel Substation contract.

- 10. <u>Risk (Activity 007)</u>: On June 24, 2021, Balkh Canal construction was completed but, due to the deterioration of security and planting of mines on the access roads to the project site, the SWIM contractor and Tt ESP's site inspectors were not able to conduct an SCI or the FSCI of this canal.
 - <u>Mitigation</u>: On July 15, 2021, during the bi-weekly coordination meeting, the alternative options of SCI and FSCI were discussed. According to the reports received from the SWIM contractor and Tt ESP's Risk Management Consultant, the risk of deploying inspectors to the site is too high. The SCI and FSCI of the canal will be coordinated once the conditions at the site improve and release of the stop-work order by USAID.
- 11. Risk (Activity 007): Tt ESP's inspectors have never been deployed to the Mohammad Salabeg Canal in Baghlan Province due to security incidents along the highway and at the project site.
 - <u>Mitigation:</u> Tt ESP recommends that USAID direct the SWIM contractor to conduct robust oversight and monitoring of the construction activities to avoid non-compliant work.
- 12. Risk (Activity 007): On September 20, 2021, the warranty period expired for the Qanjogha Canal, and on September 22, 2021, the warranty period expired for the Hasan Abad and Jalal Abad canals, but due to stop-work order issued by USAID, Tt ESP and SWIM contractor cannot conduct the warranty inspection.
 - <u>Mitigation</u>: Tt ESP recommends that USAID direct the SWIM contractor to inform their subcontractors about the stop-work order issued by USAID. The warranty inspection can be scheduled after the release of the stop-work order.
- 13. <u>Risk (Activity 007)</u>: On September 15, 2021, the SWIM contractor reported a stoppage of SWIM activities due to stop-work order issued by USAID. The stoppage is affecting the completion date of the Qadeem and Mohammad Salabeg canals.
 - <u>Mitigation</u>: Tt ESP recommends that USAID direct the SWIM contractor to plan the remaining works accurately and assign required resources following the release of the stop-work order to complete the projects before the upcoming cold-weather season; otherwise, the remaining activities might not be completed, and the projects remain incomplete.
- 14. <u>Risk (Activity 012, Task I):</u> Due to the 45-day stop-work order received from USAID, there is a risk the requirements of the Implementation Plan will not be completed before the Tt ESP's contract end date
 - <u>Mitigation:</u> If the stop-work order expires or is released, Tt ESP will evaluate the status of Task I and seek guidance from USAID on how to proceed.
- 15. <u>Risk (Activity 012, Task 1):</u> Due to the interim government's association with persons and groups on the OFAC sanction list, pursuing comments from the ACAA is prohibited. Up to the time of this report, the ACAA has not provided comments related to the Task. This poses



a risk because unless Tt ESP receives guidance, Tt ESP will have no option but to proceed without ACAA's inputs.

<u>Mitigation:</u> Depending on the political situation in Afghanistan, Tt ESP will await guidance from USAID on how to proceed. If engagement with the new government is considered, the following actions are recommended to mitigate issues:

- The ACAA provides USAID and Tt ESP the current organizational structure to ensure and understand to what extent the deliverables will need to be reviewed and/or modified.
- Tt ESP and USAID share all the documents with the new ACAA leadership and prepare and deliver a presentation(s) as needed.
- Tt ESP provides a roadmap to the new ACAA leadership on how to implement all the documents and further steps to become compliant for future ICAO audits.
- Tt ESP informs ICAO if a restart of work occurs to ensure that they reinsert Afghanistan into their auditing schedule.
- 16. Risk (Activity 012, Task 1): There is a possibility the ACAA may not use any of the work performed thus far on Task 1. This poses a risk because many of the documents may become invalid as each document is dependent on each other (ACARs dependent on CAL, CADs dependent on ACARs, PQs to ACARs and CADs, etc.).
 - <u>Mitigation</u>: Tt ESP has no control over the views of the new leadership; therefore, if the new ACAA is unwilling to accept the work completed thus far, Tt ESP can only explain the risks associated with not implementing the provided documents to the ACAA if so directed by USAID.
- 17. Risk (Activity 012, Task I): The ACAA has not uploaded the PQs into the OLF. ICAO will not re-audit Afghanistan unless the PQs are uploaded to the OLF, thus, limiting Afghanistan's chances of meeting the compliance requirements and being removed from the ICAO's ban list.
 - <u>Mitigation:</u> Tt ESP has explained the current situation to the ICAO. As soon as the stop-work order expires, Tt ESP will seek guidance from USAID on how to proceed with the ICAO audit assistance.
- 18. Risk (Activity 012, Task 1): The information contained in the documents drafted by Tt ESP in support of this Task is highly dependent upon the ACAA's organizational structure. The new ACAA's organizational structure has not been made public. If there are significant changes to ACAA's organizational structure, there is the possibility of significant effort re-drafting the relevant documents.
 - <u>Mitigation:</u> If requested by USAID, Tt ESP will investigate the changes in the ACAA's organizational structure, followed by an evaluation of documents drafted by Tt ESP and present a way forward to USAID.
- 19. <u>Risk (Activity 012 Task 2):</u> Due to the partial 45-day stop-work order received from USAID, there is a risk the requirements of the Implementation Plan will not be completed before the contract end date. This poses a risk because it is possible that the Plans will not be completed.
 - <u>Mitigation:</u> As soon as the stop-work order expires, Tt ESP will evaluate the status of the Plans and seek guidance from USAID on how to proceed.
- 20. Risk (Activity 012 Task 2): Due to the interim government's association with persons and groups on the OFAC sanction list, pursuing comments from the ACAA is prohibited. Tt ESP has not received feedback from the ACAA for the Maulana Jalaluddin Mohammad Balkhi International Airport's Handover Plan nor the Compliance Action Plan.



<u>Mitigation:</u> Tt ESP will evaluate the status of the Plans if the stop-order is lifted and seek guidance from USAID on how to proceed.

- 21. <u>Risk (Activity 012 Task 3):</u> Due to the 45-day stop-work order received from USAID, there is a risk the requirements of the Implementation Plan will not be completed before Tt ESP's contract end date. There is a possibility that the Plans will not be completed.
 - <u>Mitigation:</u> Tt ESP will evaluate the status of HKIA MP and NAN MPs and the time required to complete plans, and what follow-on opportunities are available while seeking guidance from USAID.
- 22. Risk (Activity 012 Task 3): Due to the interim government's association with persons and groups on the OFAC sanction list, pursuing comments from the ACAA is prohibited. Tt ESP has received no guidance and/or feedback from ACAA representatives since the takeover and, prior to this time, has not received feedback from the ACAA on the working draft chapters of the HKIA MP and NAN MP.
 - <u>Mitigation:</u> Tt ESP will await guidance from USAID on how to proceed and engage with the new ACAA for comments on the submitted working documents of the HKIA MP and NAN MP.
- 23. Risk (Activity 012 Task 3): Due to the security situation in Afghanistan and the stop-work order from USAID, Tt ESP has not been able to complete all the required airport inspections. This poses a risk because if the stop-work order is lifted and unless Tt ESP can complete the inspections, the NAN MP would not include findings documented during the inspections.
 - <u>Mitigation:</u> If the work under Activity 012 Task 03 is resumed, Tt ESP will evaluate the security situation and seek contract extensions, if necessary, and develop an alternate plan for documenting the facility situation at the airports which have not been inspected
- 24. Risk (Activity 012 Task 4): Due to the 45-day stop-work order received from USAID, there is a risk the requirements of the Implementation Plan will not be completed before Tt ESP's contract end date. This poses a risk because it is possible that the Data Center would not become operational.
 - <u>Mitigation:</u> If the work under this Task is resumed, Tt ESP will evaluate the status of activities and seek guidance from USAID on how to proceed with this Task.
- 25. Risk (Activity 012 Task 4): Due to the interim government's association with persons and groups on the OFAC sanction list, pursuing comments from the ACAA is prohibited. This is a risk, as Tt ESP requires guidance and/or feedback in order to proceed with the development of the Data Center and ACAES
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will seek guidance from USAID on how to proceed.
- 26. Risk (Activity 012 Task 4): The requirements for two modules (Safety Management and Asset Management Systems) are on schedule. However, the completion has and continues to lag behind schedule. The stop-work ordered by USAID to Tt ESP on this Task is affecting the schedule as well. In addition, the ACAA's system integration activities for third parties (airlines, banks, airline agents, etc.) continue to lag behind schedule. There is a risk the ACAES implementation will not be completed within schedule unless the ACAA completes the requirements for the two modules and the system integration activities.
 - <u>Mitigation</u>: If the issued stop-work order is lifted by USAID for this Task, and OFAC requirements can be met, Tt ESP will work closely with USAID to complete the pending requirements and system integration activities. Tt ESP will work with USAID to support the ACAES integration process by communicating the new system benefits to third parties and tying all integration activities to a timeline.



- 27. <u>Risk (Activity 012 Rask 4):</u> Afghan Telecom is not willing to commit to an internet installation timeline. There is a risk the ACAES will not be fully operational unless Afghan Telecom commits and adheres to a viable installation timeline.
 - <u>Mitigation:</u> If the issued stop-work order is lifted by USAID for this Task and OFAC requirements can be met, Tt ESP will pursue a commitment from Afghan Telecom to adhere to an installation timeline.
- 28. Risk (Activity 012 Task 4): Tt ESP is awaiting vetting approval from USAID's Vetting Support Unit (VSU) for procurement of major equipment for the data center and for the installation contractor. This presents a risk because receiving some of the equipment may take in excess of 19 weeks after the purchase order is placed; therefore, it is possible for the equipment to arrive after Tt ESP's period of performance expires in January 2022.
 - <u>Mitigation:</u> If the issued stop-work order is lifted and VSU provides feedback, Tt ESP will assess the amount of time elapsed, amount of time needed to have equipment delivered and advise USAID accordingly.
- 29. <u>Risk (Activity 012, Task 5)</u> Due to the 45-day stop-work order received from USAID, there is a risk the requirements of the Implementation Plan will not be completed before the contract end date.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will evaluate the status of Task 5 and seek guidance from USAID on how to proceed.
- 30. <u>Risk (Activity 012, Task 5):</u> Unless the new ACAA leadership agrees with the training program and other program objectives provided by Tt ESP, there is a risk the objective of this task will not be met.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will communicate with USAID to determine a way ahead.
- 31. <u>Risk (Activity 012, Task 5):</u> Based on the current political and COVID-19 situations in Afghanistan, on-the-job training (OJT) abroad may remain very limited. This poses a risk because ACAA personnel may not be able to receive proper OJT.
 - <u>Mitigation</u>: If the stop-work order is lifted, Tt ESP will evaluate the situation and determine if OJT abroad is feasible. If not feasible, it is still possible to conduct OJT for AIR, OPS, and PEL in Kabul; however, this requires expatriates to travel to Kabul from abroad, and it may be difficult to secure such expatriates travel to Kabul.
 - Tt ESP would continue pursuing the current open channels of communication with Dubai and Jordan. Unfortunately, Tt ESP does not recommend OJT in Kabul for domains other than AIR, OPS, and PEL due to the lack of infrastructure and advanced knowledge within these domains. Therefore, OJT for domains other than AIR, OPS, and PEL will need to be conducted from Dubai or Jordan.
- 32. Risk (Activity 012, Task 5): There is a risk that the new leadership of the ACAA would require new individuals to attend training. If so, then these new individuals would be very far behind the training schedule, and it would be difficult to accommodate the training within the Tt ESP contract's current period of performance. In addition, Tt ESP must reassess the competence and knowledge of each individual to ensure proper qualifications are met. Finally, accepting individuals into the training program without proper screening could generate an ICAO finding in the future.
 - <u>Mitigation</u>: Tt ESP does not recommend accepting additional individuals into this program. Further, Tt ESP recommends that the ACAA be made aware of the risks associated with engaging with non-assessed individuals for the inspectorate program if the stop-work order is lifted.



- 33. <u>Risk (Activity 012 Task 6):</u> Due to the stop-work order issued by USAID, Tt ESP will not be able to submit the final deliverables according to the dates in the approved Implementation Plan.
 - <u>Mitigation:</u> When the work under Activity 012 Task 06 is resumed, Tt ESP will submit a revised Implementation Plan with modified deliverable dates.
- 34. <u>Risk (Activity 017):</u> Tt ESP believes that the two-month duration in the contractor's baseline schedule for the site delivery of the long-lead equipment items into Afghanistan, notably the wind tower components, is not adequate. Tt ESP believes that it could be much longer than planned due to border delays, government change, security conditions, the number of trailers for turbine blades, and the difficulties of navigating the hazardous road route with the long low-boy type trailers.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP recommends USAID direct the contractor to re-evaluate the delivery times after procurement is awarded to their vendors. Tt ESP recommends that the contractor provide their equipment delivery plan and an updated schedule to Tt ESP and USAID.
- 35. <u>Risk (Activity 018):</u> On August 15, 2021, the Afghan government collapsed, and all classes were suspended. At the time of this reporting, there is no specific plan for resuming classes, especially for female students. There is a possibility that the Internship Program will not start before the end date of the Tt ESP contract.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will review the university academic calendars and the viability of offering a women's internship within the time remaining on the Tt ESP contract and provide its recommendations to USAID.
- 36. Risk (Activity 021): Late delivery of the recycling equipment to the site could possibly cause additional delays to the project.
 - <u>Mitigation</u>: If the stop-work order is lifted, Tt ESP recommends that USAID direct the contractor to expedite the purchase and delivery of recycling equipment to the site to avoid design and construction delays of the plant hangar.
- 37. <u>Risk (Activity 022)</u>: Although the contractor has submitted a couple of design packages to Tt ESP for review and approval, there are still a few outstanding design packages including, the basis of design package. All design packages and the basis of design package should be reviewed and approved before starting construction activities at the site in order to avoid delays. Any further delays in these submissions will likely result in procurement delays for long-lead items.
 - <u>Mitigation:</u> Tt ESP recommends that USAID direct the contractor to submit critical design packages to avoid potential delays to the procurement phase of the project.
- 38. <u>Risk (Activity 023)</u>: Due to the 45-day stop-work order received from USAID, there is a risk the requirements of the Implementation Plan will not be completed before the contract end date. This poses a risk because it is possible that the design will not be completed.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will evaluate the status of the design and seek guidance from USAID.
- 39. Risk (Activity 023): Due to the interim government's association with persons and groups on the OFAC sanction list, pursuing comments from the ACAA is prohibited. Tt ESP has not received feedback from the ACAA. Prior to the change of the political scene, ACAA neither provided comments for the 35% Schematic Design Package nor replied to the 14 outstanding RFIs.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will evaluate the status of the Plans and seek guidance from USAID on how to proceed.



10.2 LONG TERM

I. <u>Risk (Activity 005)</u>: LARP problems could negatively affect the project completion date. DABS is in violation of the contract by allowing construction to commence on privately owned land prior to payment being made to the landowner. There is a risk of landowners demanding a higher price once foundations are completed, and tower erection takes place. DABS should expedite the Project Affected Persons (PAPs) compensation process under the LARP to avoid further contract violations. As of September 30, 2021, based on the latest Tt ESP tracker updated on September 27, 2020, work was stopped at 47 locations due to LARP concerns. Per DABS' LARP tracker dated July 31, 2021, 460 of the 656 PAPs have been paid.

Mitigation: Tt ESP recommends that USAID:

- Work on LARP issues closely with the contractor to resolve.
- Expedite the process of compensation to PAPs under the LARP at all five sections of the TL.
- 2. Risk (Activity 005): The contractor will not be able to perform testing and commissioning of the TL sections until the five substations along the NEPS-SEPS Connector TLs are built, and the gantry structures are available. Additionally, the locations of dead-end towers and gantries at the Qalat and Shah Joy substations are still outstanding. The deviation angle between the gantries and dead-end towers is an issue that both the substation and the TLs contractors need to work closely together to resolve to avoid possible delays with the construction of dead-end towers at the Qalat and Shah Joy substations' loose points. On August 14, 2021, Tt ESP completed a review of the contractor engineering analysis on dead-end towers issues and provided comments.

<u>Mitigation</u>: Tt ESP will await guidance from USAID regarding the prioritization of the design and construction of the five substations in order to allow the contractor to perform testing and commissioning of the TLs and that USAID set up a regular meeting between contractors and Tt ESP until resolution of the issue of the dead-end tower is resolved.

3. Risk (Activity 007): The SWIM contractor informed Tt ESP during FY 2020 Q2 that the SWIM project is scheduled to end in 2021 and that once the last canal is finished, no further inspections will be performed by the SWIM contractor, and the responsibilities will be handed over to the River Basin Authority and local government. If issues or problems arise, it is the insurance company's responsibility to take corrective action or pay for the corrective action.

On April 25, 2021, USAID responded by email to ESP's Letter No. A-007-0007 – SWIM Contractor's Warranty Responsibilities for all Canals Following Construction Completion Acceptance, submitted on January 3, 2021. The email indicated that USAID and the SWIM contractor were discussing the warranty issue and that Tt ESP would be informed of their decision. In addition, USAID would advise Tt ESP if additional support is required.

As of the end of this reporting period, Tt ESP has not received the final decision or update on the matter from USAID.

<u>Mitigation</u>: Tt ESP recommends that USAID direct the SWIM contractor to provide all related information regarding the warranty period for all canals and the actual start dates of the warranty periods. Tt ESP recommends that USAID requests all relevant information about the repairs of any defects or deficiencies during the SWIM contractor's warranty period.

4. Risk (Activity 007): According to the SWIM contractors report, since August 11, 2021, due to a security incident, all construction activities have been on hold at the Mohammad Salabeg Canal in Baghlan Province. Through the weekly report No. 93 submitted by the SWIM contractor, the sub-contractor has withdrawn from the site, "Although SWIM had virtual and in-person meetings with the sub-contractor to address all the issues and resume the works,



ultimately, the sub-contractor officially informed SWIM they would withdraw from completing Mohammad Salabeg canal."

<u>Mitigation</u>: Tt ESP recommends that USAID direct the SWIM contractor to find a suitable resolution for the completion of remaining activities or structures, which are affecting the canal inversely and possibly increasing its vulnerability.

- 5. Risk (Activity 012, All Tasks): On August 15, 2021, anti-government organizations took over the government of The Islamic Republic of Afghanistan and occupied Kabul. It is unknown how this change will affect progress towards completion of all tasks under Activity 012 supporting ACAA's engineering, planning, and capacity building.
 - <u>Mitigation:</u> Resolution or mitigation of this unknown risk is possibly outside of the Tt ESP period of performance. Tt ESP will coordinate and engage with USAID to seek guidance on the way forward.
- 6. Risk (Activity 012 Task 4): It appears the ACAA lacks the ability to continuously support the operations on the Data Center and Innovation Laboratory. For example, it appears the ACAA lacks the ability to fund building facilities maintenance and comfort upkeep, internet service fees, utility costs, and subscription-based software license renewals, etc. There is a risk that ACAA will not be able to fund the continued operation of the Data Center and the Innovation Laboratory hence endangering the ACAA's future operations.
 - <u>Mitigation:</u> If the stop-work order is lifted, Tt ESP will seek USAID's guidance on how to proceed with this Task.
- 7. Risk (Activity 012 Task 6): On August 15, 2021, anti-government organizations took over the government of The Islamic Republic of Afghanistan. Due to the interim government's association with persons and groups on the OFAC sanction list, much of the assets of Afghanistan's central bank have been frozen, which has sharply impacted Afghanistan's economy. It is currently anticipated that international governments, companies, or other organizations will have little appetite to fund the interim government besides humanitarian relief. Thus, funding a large-scale infrastructure project like KHD Airport looks unlikely in the near future. This risks the data collected and proposed mechanism for funding put forth in the current feasibility recommendations under this task could become obsolete.
 - <u>Mitigation:</u> Tt ESP will follow USAID's recommendation on completing the feasibility study. If USAID recommends updating to reflect recent events, Tt ESP may need further effort to review the applicability of data, reassess historical examples to predict future trends in feasibility, and identify likely funding mechanisms considering the updated socio-economic situation in Afghanistan.
- 8. Risk (Activity 023): In order to complete the design, it is necessary to conduct a Topographic Survey and a Geotechnical Investigation at Herat Airport. Tt ESP requested from the ACAA the demining and UXO certificates applicable to the site; however, ACAA informed Tt ESP that such certificates were not available. Tt ESP conducted its own research and indeed located applicable demining and UXO certificates for the majority of the site. There is a small area (approximately 14,200 sqm, designated as MF-WA-53) that was found to be declared "cleared" in the Government of the Islamic Republic of Afghanistan official record, but the applicable demining and UXO certificates were not located. This poses a safety risk because while the official record clearly shows the area free from mines or UXOs, Tt ESP was not provided the applicable demining and UXO certificates.

<u>Mitigation</u>: Tt ESP has included the MF-WA-53 area in all of the field maps and has instructed all personnel to avoid the area while on site. If the stop-work order is lifted, Tt ESP will provide direction in the construction documents to require the construction contractor to demine the area prior to commencing construction work.



9. <u>Risk (Activity 023):</u> All field activities supporting the topographic survey and the geotechnical exploration has been completed except for areas where NATO denied access. This poses a risk because assumptions made in the design may require rework by the contractor, including the potential for an additional cost.

<u>Mitigation</u>: If the stop-work order is lifted, Tt ESP will provide direction in the construction documents to require the construction contractor to provide a topographic survey and geotechnical investigation of the area commencing construction work for verification by the design team.

II.0 FRAUD

During FY 2021, Tt ESP reported no instances of perceived fraud to the Office of the Inspector.

12.0 SECURITY

As the security in Afghanistan is dynamic, the security overviews of Kabul, southern Afghanistan, and northern Afghanistan provided below consider only the most recent quarter (Q4) and do not recount events during the entirety of FY 2021.

12.1 KABUL

Anti-Government Elements (AGE) activity increased over the first two weeks of this reporting period; however, this was in keeping with the seasonal norms, and these were predominately magnetic improvised explosive devices (MEID) attacks. Prior to mid-July, there were on average just over 1.5 incidents a day in the city, and given the extensive security footprint, Kabul remained a relatively secure operating environment provided effective mitigation measures were in place.

On July 6, 2021, the US military withdrew from the last American base in Afghanistan (Bagram Airfield), leaving only six hundred and fifty US Marines to defend the US Embassy and Kabul International Airport. This and the fact that most NATO forces had also withdrawn had a devastating effect on the morale of the Afghan National Defense Security Forces (ANDSF), and across Afghanistan, the Taliban continued to gain control of provinces at an alarming rate without any significant resistance from the ANDSF. The Taliban captured prominent land ports bordering Tajikistan, Uzbekistan, Turkmenistan, Iran, and Pakistan, putting further pressure on the capital with possible shortages of food and supplies.

International flight schedules were becoming erratic, and many flights were canceled at short notice, adding to the security concern of the expatriate's community, and many embassies advised their citizens to leave Afghanistan.

On July 20, AGE fired three rockets at the presidential palace while the President and a number of government officials were praying together at the palace mosque. On August 3, AGE carried out a complex attack against the residence of the Acting Minister of Defense situated just outside the Green Zone. These incidents were a clear indication that despite the heavy presence of ANDSF in Kabul, the AGE could deploy and attack prominent targets at will.

On August 15, the Taliban were at the gates of Kabul and the following day entered the city without any opposition from the ANDSF, prompting a mass exodus of the expatriate's community and Afghans with legitimate documentation to enter America or Europe.

American and NATO troops returned to Kabul to assist with the evacuation, and by August 31, 2021 all the expatriates and the majority of those Afghans entitled to enter either America or Europe had been evacuated. During the evacuation period on August 26, 2021, at 1750 local time, two suicide bombers and gunmen attacked crowds of Afghans waiting to be processed at Kabul Airport with devastating results.

The Taliban are in the process of establishing a legitimate government in the eyes of the rest of the world, and it remains to be seen if this is possible. The new administration in Afghanistan is now on



the other end of its own terrorist tactics and is experiencing attacks from the terrorist group Islamic State in Khorasan.

12.2 SOUTH

As in the latter month of the third quarter, AGE continued to capture Districts in Wardak, Ghazni, Zabul, and Kandahar Provinces with little or no resistance from ANDSF.

Ghazni City was completely surrounded for weeks, and although the city was fortified by ANDSF, the general feeling of the civilian population was that the Taliban could enter at will. It was suggested that the Taliban were not willing to risk unnecessary casualties attacking a provincial city and preferred the siege tactic, as was the case across Afghanistan. Their approach was successful, and on August 13, 2021, the city of Ghazni was handed over to the Taliban by the Governor.

A similar situation occurred in Qalat City, Zabul Province, on the same day, again with trivial resistance from the ANDSF.

Unlike Ghazni and Qalat, the capture of Kandahar City was an essential component of the Taliban propaganda machine, Kandahar City being the second-largest city in Afghanistan and always thought of as the Taliban's capital. The assault on Kandahar City began on July 9, 2021; this time, the ANDSF, with the aid of US airstrikes, resisted, resulting in weeks of heavy fighting. In August, the city defenses dissolved due to a lack of reinforcements and resupply. The Taliban managed to enter and overrun most of the city by August 12, 2021, including Sarposa prison, where they released over a thousand prisoners. On August 16, 2021, Kandahar Airport was the last location to fall after government loyalists were finally evacuated.

During this time, Tt ESP operations were paused, and the staff was urged to remain at home to prevent any chance of becoming a causality in the kinetic activity between the Taliban and ANDSF.

After a settling-in period, it appeared that the new administration was very keen to proceed with Tt ESP project activities. At the beginning of September 2021, Tt ESP engineers resumed their operations along the PTEC line; however, all tasks are being closely monitored by Tt ESP's RMC.

12.3 NORTH

By early July, AGE had captured most of the district in the Northern Provinces of Afghanistan, surrounding the provincial cities of Mazar, Kunduz, and Faizabad.

On August 8, 2021, Kunduz City was the first major city in Afghanistan to fall to the Taliban despite the forming and arming of local militia by the Afghan government to assist ANDSF. After the fall of Kunduz City, ANDSF's retreated northwest to Mazar, leaving the northern and northeastern provinces totally exposed.

On August 11, 2021, Faizabad City collapsed to the Taliban with minimal resistance from the ANDSF, whose forces also withdrew to Mazar. Mazar City, the only remaining provincial city in the north, was captured without a fight on August 14, 2021; most of the ANDSF had surrendered or deserted, escaping across the border into Tajikistan.

The Taliban now controlled all of the Northern Provinces of Afghanistan and, two days later, the whole of Afghanistan.

During this period, some of the canals still under construction on SWIM (Activity 007) could not be visited by Tt ESP site inspectors such as Qadeem and Balkh canals due to the occupation of the western districts of Balkh Province by Taliban fighters. However, Tt ESP activities such as the Mazar Recycling Plant (Activity 021) situated within Mazar City continued until a couple of days before the final collapse of Mazar City.



As we have witnessed in other provinces in Afghanistan, the new administration was eager to proceed with projects beneficial to the country, and activities in the Northern Provinces have continued under the careful monitoring of the RMC.

12.4 SERIOUS INCIDENT REPORTS


