PROGRESS REPORT

Across the globe, the Health Policy Plus (HP+) project is working to advance U.S. Agency for International Development (USAID) policy priorities in health to improve equity, access, availability, and information for all people. The project has supported the provision of accessible, affordable healthcare for vulnerable citizens; the ability of youth to advocate for themselves to access targeted health services; and advances in respectful maternity care, universal health coverage, and rights and protections for individuals living with HIV. Through both field- and core-supported activities, HP+ has worked in 48 countries, fostering self-reliance to achieve strong health sector responses to end preventable child and maternal deaths; reduce unmet need for family planning





and reproductive health; achieve an AIDS-free generation; and decrease morbidity and mortality while containing the spread of COVID-19.

Over the past six months, HP+ has achieved a total of 133 results, bringing the total number of results achieved over the life of the project to 1,682 (Figure 1). During this time, HP+ documented three additional instances of cost-share valued at U\$\$308,631, bringing the number of cumulative cost-share results to 116. Total U\$AID funding through September 2020 was U\$\$160.6 million and total cost share was U\$\$18 million, or 11 percent of project expenditure.

This reporting period, the project demonstrated its strengths in adaptability and flexibility by continuing to achieve impressive results in the face of significant challenges caused by the global spread of COVID-19. By shifting to remote working conditions, pivoting to online platforms to continue knowledge sharing and training sessions, and supporting countries to make rapid, strategic policy implementation actions to aid in the pandemic response, HP+ has displayed resilience and adaptability in these unprecedented times.

HP+ is building on previous years to support the provision of sustainable health financing mechanisms, improve access to high-quality services, engage the private sector, and generate evidence to support decision making and advocacy for increased domestic resources for health. The project has strengthened the accountability of governments to their citizens by promoting transparent management and monitoring of health systems and budgets and has supported an empowered and engaged civil society. It continues to ensure that local solutions feed into global policy dialogue by sharing best practices, fostering independent data use, and creating effective models and tools that strengthen health reform worldwide.

The ability to realize any of these achievements hinges on the project's diverse partnerships, its focus on issues of gender and equity, and its expertise in strengthening the capacity of individuals and institutions and the effectiveness of their interactions to sustain and increase self-reliance of local health systems.

ENGAGING IN THE GLOBAL PANDEMIC RESPONSE

Over the past eight months, the global health landscape has undergone a seismic shift due to the sudden appearance of COVID-19 in the first months of the year. Now, with tens of millions infected and more than one million lives lost, the pandemic has gripped the global community, disrupting economies and daily activities on an unprecedented scale. As scientists race to develop a vaccine and governments and donors direct resources to respond to the pandemic, countries are experiencing gaps in resource needs and disruptions to essential health services.

In many parts of the world, already fragile health systems are rushing to put critical disease response systems in place. Leveraging its decades of experience and global presence in the health sphere, HP+ is aiding in COVID-19 response efforts by supporting countries on three continents to make rapid, strategic policy implementation actions to improve quality service delivery, optimize response efforts, and ensure continuity of essential health services (Figure 2).

The project is supporting global health systems and the pandemic response in a variety of ways, leveraging flexible mechanisms and approaches to respond to evolving needs. Through its four pillars of policy, financing, governance, and advocacy—as well as helping to strengthen countries' human resources for health—HP+ is aiding efforts to combat the pandemic with the aim of creating long-lasting, sustainable health systems worldwide. By supporting countries to decrease morbidity and mortality and contain the spread of COVID-19, the project is improving health outcomes and saving lives.



Over the reporting period, HP+ has supported countries' COVID-19 response efforts in the following ways:

POLICY

By supporting countries to develop, adopt, implement, and monitor health policies that support strong health systems and bolster COVID-19 response efforts:

HP+ supported the Ministry of Health (MOH) in Honduras to revise criteria to end COVID-19 isolation using a symptoms-based strategy instead of laboratory results-based processes and developed *COVID-19 Infection Prevention and Control Guidelines* for national implementation among healthcare workers. The project also supported the country to revise its guidelines to healthcare workers, forensic experts, funeral homes, local governments, and the Honduran population for the adequate handling of the deceased in the context of COVID-19 to reduce spread of the virus.

The project—known as Health and Education Policy Plus (HEP+) in Guatemala—supported government efforts in Guatemala to develop family planning and logistics guidelines for reproductive health services within the context of the pandemic, enabling continuity of services and reducing a potential shortage of contraceptives. At the request of the government, HEP+ also developed a strategy to apply

objective, standardized measures to establish epidemiological phase by territory and a COVID-19 contract tracing and case follow-up strategy to enable confinement and containment of the virus.

In conjunction with partner the White Ribbon Alliance (WRA), HP+ supported Malawi to integrate priorities expressed by women and girls into its *Maternal and Newborn Health Services Including Family Planning Guidelines during COVID-19* policy. Maintaining and prioritizing essential health services that meet women's and girls' self-expressed needs during the pandemic is critical to protect the gains previously made in reducing maternal mortality and morbidity in Malawi.

Across Central America, HP+ is supporting local professional associations such as Honduras's Association of Intensive Care Specialists, El Salvador's Association of Anesthesiologists and National Nursing Association, and Guatemala's Association of Infectious Diseases to address the COVID-19 pandemic. These local partners are developing and revising technical guidelines and protocols, ensuring that staff in underserved areas receive training and mentorship; supporting scale-up of training programs developed by HP+ staff and consultants; providing strategic advice on testing strategies and equipment purchase; and engaging in policy-level discussions with MOHs and key partners.

FINANCING

By increasing domestic resource mobilization and strengthening stakeholder capacity to manage financial resources in the pandemic response:

Following an analysis conducted in May by HP+ West Africa on available equipment and supplies to fight COVID-19 in Niger, the Bank of Africa

Foundation invested US\$1,700 in the form of handwashing kits to fight COVID-19 in the country. This investment, which joins US\$640,000 already granted by the Association of Banks and other financial establishments to the Nigerien government to aid in its pandemic response, underpins the country's private sector commitment to mobilizing domestic resources for health amid the pandemic.

The project supported Guatemala's MOH to streamline procurement processes for protective equipment and medicines and to raise the level of

execution of the budget assigned to aid in the country's pandemic response. As a result, this level of execution has nearly quadrupled between June and August, from 97.9 million to 358.2 million quetzal (US\$12.8 million to US\$47 million) at the hospital level and from 32.2 to 112.6 million quetzal (US\$4.2 million to US\$14.8 million) at the level of health area directorates. These investments are essential to improving the supply of protective equipment for front-line personnel who care for patients with COVID-19 as well as ensuring adequate supply of medicines required to treat infected patients.

HP+ Cambodia worked with government counterparts to develop a COVID-19 monitoring and evaluation concept note for a new cash transfer program for the poor and vulnerable as part of the Ministry of Economy and Finance's COVID-19 response. This support helped to ensure the effective implementation by country stakeholders of the first rounds of the program, which transferred approximately US\$50 million to 560,000 poor households to help mitigate the economic shock caused by the pandemic.

HP+ also hosted a <u>webinar that featured recent analyses of fiscal space for health</u> in Indonesia and the Philippines that highlighted current fiscal constraints, government budgetary responses to the COVID-19 crunch on revenues, and possible avenues through which additional financing could be raised.

GOVERNANCE

By strengthening the capacity of country stakeholders to develop and implement advocacy strategies, collaborate on partnerships, and engage in participatory processes to ensure the provision and continuity of essential health services:

HEP+ supported civil society youth groups in Guatemala to raise awareness about the importance of respecting governmentmandated measures to mitigate the spread of the virus, such as confinement and social distancing, through art, music, and media disseminated in both Spanish and Mayan that garnered an average of 7,000 daily views on social media. Guatemalan civil society also carried out advocacy campaigns about the importance of continuing to provide reproductive health services during the COVID-19 emergency to prevent an increase in the number of unplanned pregnancies caused by a disruption in family planning/reproductive health (FP/RH) services.

In Malawi, HP+ supported members of the intergenerational mentoring program to

pivot their advocacy work to focus on addressing FP/RH needs of youth in the context of the COVID-19 pandemic. Members chose to focus on advocating to district response teams to prioritize FP/RH services for youth in their pandemic response plans. As a result, the Salima District Youth Network received 1.5 million Malawian kwacha (approximately US\$1,990) from the district council to support its work. To date, mentees have visited 250 households in their communities to share information on how to prevent COVID-19, access local FP/RH services, and connect with community health workers.

HP+ partner WRA convened a partnership of government representatives and nongovernmental organizations (NGOs) in Pakistan to ensure evidence-based, respectful maternity care and reproductive and maternal health services continue to be prioritized as essential during the COVID-19 pandemic. By ensuring that policy designates these services as essential priorities, Pakistan can avoid a severe increase in maternal and neonatal deaths if maternal health coverage continues to decline as a result of diverted services and reduced coverage indirectly caused by the pandemic.

ADVOCACY

By strengthening the evidence base for decision making in health services, supplies, and delivery systems to support COVID-19 response efforts and ensure continuity of essential health services is maintained:

Following a 38 percent increase in call volume to a domestic violence hotline following the Guatemalan government's implementation of self-isolation requirements to prevent the spread of COVID-19, HEP+ worked with civil society networks to train 65 members of civil society on the topic of masculinities for gender equality in the time of COVID-19. HEP+ also supported revision of an application that consolidates demographic and FP/RH data at national and departmental levels to include COVID-19 news and information.

HP+ partner WRA convened a special working group within the Global Respectful Maternity Care Council to design an advocacy and communications campaign to ensure maternal and newborn health remains a priority during COVID-19. The campaign was used by WRA National Alliances and others in USAID priority countries to convene stakeholders, advocate for action, and disseminate joint messages to women, communities, and providers to address the secondary effects of COVID-19 on maternal and newborn health.

The project is also providing thought leadership by urging governments to consider issues of equity in their responses, modeling indirect impacts of COVID-19 on maternal and newborn health; highlighting gender considerations within the pandemic response; and offering policy recommendations to ensure essential services for women and girls are maintained during this and future pandemics.

HUMAN RESOURCES FOR HEALTH

In addition to these four pillars, HP+ is working closely with governments and other partners to ramp up prevention, mitigation, and service delivery measures to save lives and manage the surge of COVID-19 patients that threatens to overwhelm health facilities. The project is leading the response to improve COVID-19-related laboratory capacity, surveillance, and case management, with an emphasis on infection prevention and control, in three Central American countries: El Salvador, Guatemala, and Honduras.

In Honduras, HP+ helped to develop, apply, and deliver a comprehensive training curriculum to 1,000 healthcare workers to build capacity on mechanical ventilation, critical care, and infection prevention and control. The project also developed laboratory testing projections for different scenarios using existing PCR, Abbott, and Bioneer platforms to increase COVID-19 sample management capacity, including test-kit supply projected needs. The USAID Global Health Supply Chain Program used HP+'s projections to procure lab equipment and supplies to increase Honduras's maximum daily processing capacity, strengthening the country's pandemic response.

In Guatemala, HEP+ developed a rapid monitoring tool for health districts throughout the country to provide critical data on inputs needed to address acute malnutrition during COVID-19, including data on the availability of and access to ready-to-use therapeutic food, micronutrients, and anthropometric equipment. This information is being used by civil society groups to advocate for addressing malnutrition within Guatemala's emergency response plans.

ADVANCING HEALTH POLICIES THAT IMPROVE EQUITY, ACCESS, AVAILABILITY, AND INFORMATION (IR1)

HP+ supports governments and other country stakeholders to develop, adopt, implement, and monitor health policies; strengthen the capacity of institutions, individuals, and health systems; and secure predictable and increased funding for essential services.

POLICY PROGRESS

Over the past six months, HP+ supported the development, revision, adoption, implementation, and monitoring of national, subnational, and operational policies throughout multiple countries. Figure 3 provides an overview of some of the project's major policy achievements between April and September 2020.

ADVOCACY FOR ACTION

During this reporting period, HP+ fostered individual and institutional capacity to develop, implement, and monitor policies and improve advocacy efforts and their impact on policy action. In addition to supporting Indonesia's advocacy efforts for health sector reform (see Spotlight) and bolstering global COVID-19 response efforts, the project supported advocacy for action in the following ways:

In Cambodia, HP+ supported the National AIDS Authority to undertake costing, financial analysis, and development of strategic inputs to <u>The Fifth National Strategic Plan for a Comprehensive, Multi-Sectoral Response to HIV/AIDS (2019-2023)</u> and an <u>Antiretroviral Financing in Cambodia policy recommendation brief</u>. As a result of this support, the Ministry of Economy and Finance committed to increasing antiretroviral drug funding from the current annual amount of US\$1.5 million to US\$2.5 million in 2021, US\$3.5 million in 2022, and US\$5 million in 2023. This commitment will allow the Global Fund to Fight AIDS, Tuberculosis, and Malaria to reallocate resources to critical, underfunded HIV prevention activities and support the country on its path to achieve its goal of domestically funding 50 percent of the HIV response by 2023.

In **Mali**, HP+ supported the National Program for the Abandonment of Gender-Based Violence (GBV) to engage representatives from ministerial departments, technical and financial partners, and civil society organizations (CSOs) in revising the draft roadmap for the law against GBV. The law, which has seen renewed support by religious leaders in recent months, would criminalize violence against women, including the practice of female genital mutilation. With the support of HP+, a revised version of the national roadmap for the adoption of the law on GBV is now available—an essential step in guiding stakeholders through the process of preparing and adopting the draft law text, with the ultimate aim of improving gender equity in Mali.

In **Malawi**, youth champions trained by HP+ reported several instances of successful advocacy efforts leading to changes in policy at the district level. One year after participating in a training focused on introducing youth

advocates to the policy process, the importance of evidence-based decision making, and the role of strategic communication, youth champions are putting these advocacy and policy communication skills into practice to improve youth access to health services and information. These efforts include engaging with the Center for Environmental Policy to assess effectiveness of the National Youth Policy and making recommendations to improve policy language and dissemination so that youth are better able to understand their rights. Another trainee successfully advocated to district council officials and chiefs to construct a youth-friendly health services space for youth to access the minimum service package in Mchinji District.

Spotlight: Prioritizing Public-Private Partnerships in Indonesia's Health Policy

In a diverse, geographically vast country such as Indonesia, <u>private sector engagement in the health sector is a critical component</u> of increasing access to and improving the quality of health services for all—particularly in areas where these services are lacking. The government of Indonesia has prioritized private sector engagement and public-private partnerships (PPPs) as strategic initiatives in achieving the country's development goals. Through PPPs, each partner leverages the resources, expertise, and efficiencies of the other to achieve better health, societal, and economic outcomes.

HP+ has been working with Indonesia's Centre for Health Financing and Risk Protection (PPJK) at the MOH to develop technical guidelines on non-infrastructure PPPs so that the processes and tools are readily available for use by public and private sector partners. Non-infrastructure PPPs focus on health services, such as contracting with NGOs for community prevention and promotion campaigns; with professional associations for service provider quality assurance; with technology companies to develop software for electronic referral systems; or with private training institutions to scale up new curriculums across the archipelago. As a result of advocacy by PPJK, Indonesia's Ministry of Planning listed non-infrastructure PPP policy adoption and implementation as one of the priority areas for health sector reform. In June of this year, the Secretary General of the MOH authorized presenting the technical guidelines, developed with HP+ support, to MOH senior leadership at their next meeting as part of the final steps of the policy adoption process.

These partnerships present a unique, innovative opportunity for the health sector to better address health access, gaps in achieving quality targets, and system inefficiencies—ultimately benefiting not only the public and private sectors, but the health and well-being of all Indonesians.

INCREASING SUSTAINABLE, PREDICTABLE, AND ADEQUATE FINANCING FOR HEALTH PROGRAMS AND POLICY (IR2)

HP+ provides strong technical support and leadership for sustainable financing of essential services; areas include HIV; family planning; tuberculosis (TB); and maternal, newborn, and child health (MNCH). We help governments to better understand the resource requirements for scaling up programs and introducing new commodities and interventions; forecast financial scenarios; develop investment plans; integrate sustainable financing agendas; and improve efficiencies.

INCREASING DOMESTIC RESOURCES FOR HEALTH

During the past six months, HP+ has continued to support government stakeholders at all levels to mobilize domestic resources for health, including in Niger and Cambodia (see Spotlights) and to support global COVID-19 response efforts. But budget allocations are just one step in increasing resources for health; governments also must release and spend funds efficiently and effectively to deliver high-quality programs and services.

In this reporting period, the project built upon its work in helping Nigeria to increase sustainable, predictable financial resources for health by supporting the Lagos State Agency for the Control of AIDS to submit and follow-up on funding request memos, leading to the disbursement of 80 million Nigerian naira (approximately US\$207,000) by the Lagos state government. In total, the agency has obtained a 150 million naira (US\$392,000) release from the state government through HP+ support, which is being spent on community mobilization, HIV testing, and monitoring and evaluation activities.

STRENGTHENING CAPACITY TO PRIORITIZE AND EXECUTE HEALTH BUDGETS

Spotlight: In Niger, a Local Leader Makes Family Planning a Priority

In Niger, where the modern contraceptive prevalence rate is 18.1 and the total fertility rate is 7.6, supporting family planning initiatives has become a national priority. The country's costed implementation plan (CIP) for family planning identified an implementation cost of approximately 64 billion West African francs (FCFA), or US\$128 million, that would be required to support its activities and initiatives—far surpassing the national government's available funding resources.

Following an HP+-supported regional workshop in August 2018 aimed at engaging community leaders in family planning advocacy to support CIP implementation, local leaders began to take action. In the southwestern city of Dosso, Mayor Issoufou Idrissa has invested FCFA 57 million (US\$97,500) over a period of six months for the purchase of family planning products and the financing of income-generating activities for women in the municipality—about 2.7 million individuals.

Of the FCFA 57 million, 40 million (US\$68,000) has been allocated to the rehabilitation of health centers. Nine million (US\$15,000) has been reserved for the purchase of medical supplies for pregnant women and consumables for the insertion and removal of contraceptive implants and intrauterine devices in health facilities. And 8 million (US\$14,000) has been allocated to income-generating activities for women—amounting to about 50,000 (US\$85) per woman in the municipality.

These resources have already enabled health facilities in the municipality to provide high-quality FP/RH health services to 966 new users. Mayor Idrissa's commitment to supporting family planning initiatives by mobilizing local resources exemplifies the immediate, effective impact that leaders at all levels can have in improving the health and well-being of their communities.

Spotlight: Supporting Vulnerable Populations through Community-Managed Health Funds in Cambodia

Community participation is instrumental in facilitating access to health services. In Cambodia, the Community-Managed Health Equity Fund (CMHEF)—established by the NGO Buddhism for Health (BfH) in 2004—is a self-funded, community-based social structure that operates in the catchment area of the local health center.

Since early 2019, HP+ has partnered with BfH to support the CMHEF in its mission to be a responsive, inclusive, sustainable community participation structure that enables rural poor and vulnerable population groups to access high-quality healthcare services. At a time when many NGOs are reducing support to programs that target people living with HIV and TB due to shortfalls in external funding, HP+ and BfH initiated an expansion of current

CMHEF support to include these populations and provided capacity development support to commune councillors, clerks, and CMHEF leaders. HP+ provided hands-on training and technical assistance to support BfH in mobilizing community resources, public funds, and district-level leadership support to CMHEFs, and provided organizational capacity building through coaching and mentoring in areas such as financial management, governance, and communications.

As a result of these efforts, 136 CMHEFs have expanded their support to include HIV and TB patients. In addition, 143 communes integrated CMHEF activities into their Commune Investment Plans for 2020, with an estimated budget allocation of US\$100,653. As of May 2020, 110 communes had disbursed funds to CMHEFs. Most significantly, 24,046 individuals classified as most vulnerable have accessed healthcare services through CMHEFs—a two-fold increase from the beginning of the project. This support comes at a particularly critical time, as CMHEFs, in conjunction with BfH, have helped 974 poor and vulnerable families to weather the economic impact of COVID-19 by providing emergency financial support and education on measures to mitigate the potential spread of the virus within their communities.

IMPROVING THE POLICY ENVIRONMENT FOR PUBLIC STEWARDSHIP, ACCOUNTABILITY, AND TRANSPARENCY (IR3)

Strengthened stewardship, accountability, and transparency are critical components of sustainable policy. HP+ focuses on improving these foundations in collaborative ways, bolstering relationships among stakeholders within government and across sectors, and bridging gaps between national and subnational levels of government, civil society, and the private sector. Building and supporting these relationships improves understanding of roles and responsibilities and breaks down barriers that can impede progress in achieving health goals.

PROMOTING EFFECTIVE, TRANSPARENT, AND LOCAL MANAGEMENT AND MONITORING OF HEALTH BUDGETS AND SYSTEMS

Governments have a duty to provide high-quality public health services to their citizens and to ensure that private health services are well-regulated. To do so, governments and country stakeholders need mechanisms and systems in place to effectively manage and monitor health systems and health budgets that promote citizen engagement and improve transparency.

Spotlight: In Mali, Local Leaders Oversee Domestic Funding of Community Health Workers

In Mali, as is the case in many African countries, <u>community health workers (CHWs)</u> <u>provide essential healthcare services</u>—and the need for services provided by this essential workforce is only expected to increase over time. Despite a strong reliance on CHWs, the program is largely donor-dependent, jeopardizing the sustainability of the workforce in the long term.

Between October 2019 and January 2020, local stakeholders—including mayors, community health associations, and communities—mobilized more than 7.8 million FCFA (approximately US\$13,305) in local resources to support payment of CHWs in the regions of Kayes and Sikasso following the end of stipend payments from USAID's

High-Impact Health Services Project in September 2019. In February 2020, HP+ Mali, in collaboration with the Association of Malian Municipalities, developed an interview guide for monitoring municipal commitments in favor of CHWs and support given to the Essential Community Care program.

During this reporting period, regional health directorates used these tools during field trips to Kayes and Sikasso to assess management of the funds and become acquainted with locally developed mechanisms that support the CHWs. The assessment revealed that approximately 95 percent of CHWs have remained at their posts following cessation of donor funding and more than 50 percent of these workers are being supported by locally developed mechanisms. Critically, local authorities are transparently managing the community-mobilized funds, ensuring that local contributors are involved in verifying the appropriate allocation to the intended beneficiaries. By taking ownership over these processes, local stakeholders are ensuring that the essential health services provided by

CHWs continue to be available to communities, creating an enabling environment for health that is sustainable, transparent, and effective.

SUPPORTING AN EMPOWERED AND ENGAGED CIVIL SOCIETY

Citizens have a role to play in ensuring government transparency and holding leaders accountable for upholding their commitments. An essential component of sustainable, successful policy reform is ensuring that the systems and structures put in place support stewardship, accountability, and transparency.

In 2012, as part of the FP2020 Initiative, the nine francophone West African countries in the Ouagadougou Partnership made commitments to accelerate progress toward achieving their countries' family planning goals. Historically, though, it has proven difficult to assess the level of achievement of these commitments. To ensure effective implementation and track progress made to date, this reporting period HP+ engaged civil society in West Africa to monitor FP2020 commitments using Samasha Medical Foundation's Motion Tracker. Under the leadership of the MOHs in Burkina Faso, Côte d'Ivoire, and Togo, and in collaboration with a variety of civil society partners and stakeholders, HP+ supported development and validation of indicators, data collection, and creation of reports assessing each

country's progress in implementing its commitments in the period between July 2017 and December 2019. By engaging in these participatory processes to ensure that leaders are being held accountable for commitments made, civil society in West Africa is supporting sustainable, successful policy reform.

Other notable instances of HP+ supporting civil society to engage in participatory processes that enable accountability and transparency over the past six months include:

- Guatemala's multisectoral groups successfully continued to monitor implementation of family planning and maternal health laws during a transition of government authorities
- Malawi integrated CSOs, such as the Coalition of Women Living With HIV/AIDS and the Association of Journalists Living with HIV/AIDS, into the steering committee of the newly permanent Cervical Cancer Program Task Force
- Nigeria supported a multisectoral coalition of CSOs to formally request that TB and HIV services be included in the benefit package of the Basic Health Care Provision Fund
- Zambia applied a Legal and Policy Framework to Accountability approach that engaged key stakeholders
 in the health sector to identify influences in the legal and policy framework that affect accountability for
 FP/RH services

In addition to capacity development trainings and workshops related to the COVID-19 response, the project conducted five trainings and 10 workshops over the reporting period, reaching 365 individuals through virtual platforms that enabled capacity development activities to continue amid remote working conditions (Figure 4):

ADVANCING SUSTAINABLE DEVELOPMENT GOALS THROUGH GLOBAL LEADERSHIP AND ADVOCACY (IR4)

HP+ serves as a conduit to advance best practices and global advocacy agendas, strengthening the evidence base for decision making and ensuring that local solutions feed into global policy dialogue.

ADVANCING BEST PRACTICES

From hosting webinars and implementing tried-and-tested approaches to producing peer-reviewed journal articles, convening global gatherings, and conversing on social media, HP+ is developing and sharing best practices worldwide.

Over the past six months, HP+:

Hosted 10 webinars focused on family planning, maternal health, financing, private sector engagement, and topics related to COVID-19 (Figure 5). At these webinars, case studies on key HP+ activities were presented along with introductions to new tools. Webinar recordings and accompanying supporting materials were shared on the HP+ website and through email outreach. In August, HP+ delivered a webinar for more than 60 members of the Reproductive Health Supplies Coalition focused on the newly developed Approach for Diagnosing Inequity in Family Planning Programs.

Participated in global knowledge sharing through virtual conferences, contributing four posters focused on HIV financing and co-hosting a satellite session, "<u>Data Matters: The Role of Local Stakeholders and Data in Influencing HIV Services and Programs</u>," at AIDS2020. At a meeting of the International AIDS Economic Network, HP+ moderated a panel session, "<u>HIV Integration into Health Insurance</u>." During the reporting period, an additional

five posters and one oral presentation were accepted for the upcoming Sixth Global Symposium on Health Systems Research (HSR2020) virtual conference.

FOSTERING DATA USE

HP+ investments in strengthening individual and institutional capacities of host-country partners evolve into local partners using project-generated data to inform evidence-based advocacy agendas and influence decision making. Over the past six months, Indonesia has leveraged project-generated data in several ways to inform policies and programs to better address health needs: In Papua Province, the Papua Health Office used data generated through HP+'s costing and Local Epidemic Assessment for Prevention epidemic modeling study to inform its HIV service scale-up strategy. A detailed HIV service and financing mapping, produced by HP+, was presented by the national government in high-level discussions regarding inclusion and exclusion of HIV benefits in the national health insurance package. In addition, findings from an HP+ analysis informed the government's development of a policy note that was shared with MOH senior leadership on key considerations for maternal and newborn health strategic purchasing.

Also during this reporting period, HP+ developed, refined, and/or disseminated a range of methods, tools, and approaches, including the following with global reach and impact:

To support countries in achieving equitable healthcare, HP+ independently developed an Approach for Diagnosing Inequity in Family Planning Programs. This approach identifies inequities for

New Blog Series Focuses on Multisectoral Actions for Health and Economic Growth



This reporting period, HP+ launched a new blog series, "A Multisectoral Endeavor Called Health: Working Across Sectors for Quality and Sustainability," featuring HP+ and other expert voices discussing a range of health development challenges and examining how multisectoral actions can help to address complex, interrelated issues. The first two blog entries, "Unity is Strength: Improving Health is a Multisectoral Endeavor" and "Reducing Malnutrition: A Multisectoral Approach to Addressing Underlying Causes," were published in June and September, respectively. Focusing on high-level objectives, such as achieving UHC, addressing pandemic threats, and reducing malnutrition, the blog series considers how multisectoral actions contribute to better health status of populations and play a role in achieving economic growth and other development goals.

disadvantaged subgroups, programmatic components of family planning, and at national and subnational levels. The approach can be used to improve the design of and to tailor family planning activities; to support public and private sectors with information to coordinate national and subnational efforts; and to justify the allocation of health and family planning resources.

HP+ developed a <u>framework and corresponding checklist</u> that examines the <u>integration of family planning into the legal, regulatory, and policy aspects of health financing arrangements</u> aimed at achieving universal, affordable access to essential health services. This work aims to support countries to integrate family planning into universal health coverage reform.

The project developed a **new tool for assessing the technical efficiency of family planning programs** that can be adapted to any developing country context. An April webinar that brought together approximately 100 attendees,

including prominent health economists and global health implementing partners, <u>featured the tool's ability</u> to diagnose family planning technical inefficiencies, identify their root causes, and evaluate proposed solutions.

To encourage further information-sharing to help stakeholders learn more about health financing and determine sustainable ways for countries to fund family planning, HP+ launched **new, revamped message boards** in the Family Planning Financing Roadmap's Community of Practice.

Drawing on lessons learned from a 2019 workshop in Kilifi County, Kenya, HP+ revised its <u>curriculum on joint</u> <u>accountability for faith and community leaders</u> to support advocates, program implementers, and decisionmakers to increase knowledge of accountability within health systems, gain skills to better understand existing accountability linkages, and seek consensus-driven recommendations for action.

CHALLENGES

The most considerable challenge currently facing the project is the impact of COVID-19 on project activities and timelines. Movement restrictions, border closures, quarantine regulations, spread of COVID-19 among our partners and counterparts, and diversion of funding and counterparts' time and attention to focus on pandemic response efforts have posed challenges in undertaking project activities as planned. In response, we are employing a variety of approaches to overcome these limitations, including pivoting to digital platforms to enable continuation of workflow and maintain communication with in-country partners and stakeholders. An unforeseen benefit of this shift has been to expand the reach of our thought leadership by pivoting from in-person policy forums to online webinars, allowing for greater knowledge sharing and impact.

Additionally, over the reporting period, the project faced challenges that required adaptive management to overcome. The election of new leadership in Malawi, a coup d'état in Mali, political sensitivities around family planning programming in Tanzania, and alleged misuse of pandemic response funds by government officials in Kenya have impacted project activities and product completion. From an operational perspective, changes in leadership and government ministry structures have posed challenges, as non-COVID-related work is being deprioritized and funding diverted to pandemic response efforts.

In response, HP+ used and is continuing to use approaches such as the Collaborating, Learning, and Adapting Framework to work with missions and country counterparts to address such challenges and adapt accordingly. In a time of unprecedented uncertainty and an ever-evolving public health landscape, we have risen to the challenge, enabling continuity of technical support and leadership and pivoting our activities and support quickly and efficiently in response. We will continue to support countries to make rapid, strategic shifts in service delivery to ensure continuity of essential health services, supporting efforts to combat COVID-19 with the aim of creating long-lasting, sustainable health systems worldwide.


