SRI LANKA - Cyclone

Date: November 23-24, 1978 (FY 79)

Location: Struck the eastern coast of Sri Lanka, took a northwesterly course from Batticaloa to Nuwara Eliya, crossed Anuradhapura to Mannar, and headed over the Gulf of Mannar

No. Dead: 740 officially reported

No. Injured: 5,000

No. Affected: Approximately 150,000 families

Damage: Some 100,000 buildings were destroyed and another 150,000 were damaged. Other damage included the destruction of 2.5 million coconut trees, 37,000 acres of teak, and \$1.6 million worth of fishing equipment

The Disaster

On the night of November 23-24, 1978, a tropical cyclone struck the south-eastern coast of Sri Lanka. Taking a northwesterly course from the districts of Batticaloa and Amparai, the cyclone moved in a wide arc over the districts of Polonnaruwa, and Anuradhapura to Mannar. The storm, accompanied by torrential rains and winds of up to 160 mph, left a trail of destruction. Over 100,000 houses of wattle and daub were completely destroyed and another 85,000 houses were damaged. Damage to public buildings, including hospitals, schools, and food stores, was severe. Sea water penetrated 5-10 km. inland, destroying agricultural land and causing massive damage to water, sanitation, power, and communication systems.

Action Taken by the Government of Sri Lanka (GSL)

As soon as weather conditions permitted, GSL officials made a preliminary survey of the disaster area. A state of emergency was declared in Amparai, Batticaloa, and Polonnaruwa districts and at the Colombo sea and air ports. In Colombo the armed forces were placed on standby to provide vehicles and personnel, and two government relief committees were established to implement and oversee emergency operations. Because roads were blocked by fallen trees and debris, the GSL airlifted relief supplies to the affected areas. Medical teams were also dispatched and dry rations consisting of rice, flour, sugar, milk, and kerosene were distributed to the needy. Contributions by local voluntary agencies were coordinated by the GSL.

To aid the victims in rehabilitation, the GSL made bank loans on easy repayment terms. The government also began preparing long-range reconstruction plans for the disaster area, including a program to mitigate future destruction by building cyclone-resistant structures.

Assistance Provided by the United States Government (USG)

On November 25, 1978, the Charge d' Affairs determined that an emergency existed and a \$25,000 grant from the International Disaster Account was given to the GSL for the purchase of medical supplies.....\$25,000

From the stockpile in Guam, the Office of U.S. Foreign Disaster Assistance (OFDA) airlifted 1,361 tents, 10,000 cotton blankets, 19 two-person saws, 500 shovels, 50 axes, 100 machetes, and 14 radio sets. Replacement value for these items (\$472,950) and airlift costs (\$356,858) came to a total of......\$829,800
