I. SUMMARY

The goal of ACDI's Farmer-to-Farmer (FtF) project is to assist in the development of a functioning agricultural credit system resulting in more opportunities for producers and agribusiness which, in turn, will result in higher incomes from agriculture and greater investment in the sector.

Project activities began October 1, 1992; this report covers the quarter of January 1, 1994, to March 31, 1994. During the reporting period, ACDI's project accomplished most of the targets established as presented in its second annual workplan.

II. QUARTER ACTIVITIES

A. HIGHLIGHTS OF PROJECT IMPACT

1. Academy of National Economy, Phase IV

In the fourth phase of ACDI's cooperation with this educational establishment, a volunteer team instructed a group of 24 professionals in diverse agricultural-related occupations on the following subjects: (1) macro and micro agricultural economics in a market economy, and US agricultural policy; (2) history, organization, and use of farmer cooperatives; and (3) agricultural finance.

The agricultural economics course explained the functions of a market economy and the role of government with reference to agriculture. The agricultural cooperatives course covered what U.S. cooperatives do and how to start a cooperative. The agricultural finance course provided an understanding of the principles, concepts and applications of agricultural finance, specifically for the financial planning of farm businesses in order to enhance obtaining credit.

The professionals learned how to determine credit worthiness and analyzed the availability of credit. After learning the history of farmer cooperatives, several participants expressed interest in organizing their own co-ops.

The team developed outlines of the training materials that can be used by the Academy in preparation of a "train-the-trainer" future course. The Volunteers envision a three part approach. First, ACDI will bring a Russian trainer to the

US to work with his/her US counterpart. Second, the US trainer will present a seminar at the Academy, in conjunction with the Russian counterpart. Third, Russian continuation of the course would be coordinated with U.S. counterparts.

The team stressed that the impact of the project will not necessarily be measurable in the next six months or even a year. The information they presented is important for the future of Russian banks and private farmer associations.

2. Dinitrov Financial Management for Private Farmers Project

ACDI, in conjunction with Volunteers for Cooperative Assistance (VOCA) and Churches United in Global Missions (CUGM), organized a workshop designed to acquaint private farmers with farm financial management. 12 private farmers attended the program. Private farmers in Russia have little experience in managing the financial affairs of their farm business in a market economy.

Topics covered in the workshop included: the importance of money management, inflation, "know your customer" concept, how to work with your assets, and storage and distribution. The team taught how to integrate cash basis record keeping into a sound business planning model.

As a result of this project, a group of private farmers are now better able to analyze the financial aspects of their farm business and use credit more effectively. The participants demonstrated their grasp of these concepts by their in-depth solutions to the case studies given at the end of the seminar.

The team left extensive materials with the host, including disks containing a practical guide to the Farmer Record Keeping System and a workbook on financial management. The team stated that in one year, someone could return to examine the Dmitrov Farmers and they will be able to show improved financial plans as a result of ACDI assistance.

The volunteers recommended that another team return in one year to review the farmers' progress in record keeping and business planning.

3. Buryatia Rosselkhozbank Project

This team travelled to Ulan Ude in the Republic of Buryatia in March, 1994. During the first week, the team visited bank branches to review loan files and to develop an understanding of the present credit delivery system. The volunteers prepared a loan officer training program which they delivered to the loan office

staff of approximately 10 branches of the Resselkhozbank in the Buryat Republic. 77 loan officers attended their program.

The team recommended that the bank develop a mission statement and a marketing plan. The volunteers discussed forming a banker's association similar to the American Bankers Association in order to accomplish key objectives regarding Russian banking legislation. They also suggested that the bank improve the credit administration process with a more detailed analysis of the borrowers financial information. They recommended that the bank establish a risk rating system for all loan accounts.

The team left extensive training materials with the bank that will be used in the future. The volunteers held a session with the senior management to discuss business planning for the bank to review internal controls and to review recommendations regarding loan administration.

B. FIELD - OFFICE SUPPORT ACTIVITIES

- ACDI's new Chief of Party, Charles Taylor, arrived in Moscow on February 15, 1994. Since his arrival, ACDI field staff have been successful in recruiting new host organizations through intensive field trips to Saratov, Volgograd, Novosibirsk, Moldova, Kazakhstan and Kyrgyzstan. Project applications have increased.
 - a. ACDI staff travelled to Saratov and Volgograd on February 23 25. In Saratov, they visited with the Economics Institute to follow up on the project ACDI held at the institute in May 1993. They developed new subprojects with the Povolzhsky Training Center and the Farmers School, the first private agricultural college for private farmers. They also discussed project development with Complexbank, the main provider of agricultural loans in Saratov. In addition, they met with VOCA's office staff and a farmer-chairman of a grain cooperative who provided important information on agriculture and agricultural credit in the province.
 - b. In Volgograd, they met with the head of Agroprombank to develop a sub-project. Agroprombank is the main provider of agricultural credits in the province. They also met with local AKKOR leaders who explained the drastic situation of the private farmers in the province.
 - c. On March 9 10, 1994, The ACDI Moscow staff travelled to Novosibirsk to meet with the Siberian Peasant Bank to discuss the details of the scope of work and the workplan for ACDI's upcoming project.

- 2. ACDI's Program Director, Robert Brennan, concluded his involvement with ACDI on March 24, 1994. ACDI is actively recruiting to fill the position.
- 3. The USAID evaluation team spent two weeks in Moscow. They visited the Academy of National Economy (Ye. Ivankina and V. Lishchenko), the Land Resources Committee (G. Popov and T. Kulakova), AKKOR, (Y. Linin and K. Mezentsev). They discussed ACDI/Moscow Farmer to Farmer operations with the Chief of Party and Program Director. A member of the evaluation team observed an ACDI project in Dmitrov.
- 4. The Chief of Party and Program Director attended the closeout session of the Dmitrov Project for Financial Management for Private Farmers in Dmitrov raion/Moscow province.
- 5. The Chief-of-Party met with the other Farmer to Farmer implementors and representatives of several foreign banks Banko di Roma, Banque Naitonale de Paris, Bank of America, EBRD, and the World Bank to discuss the present banking situation in Russian and other NIS countries. These efforts are part of our planning process to make certain our focus is concentrated on the most appropriate banking institutions.
- 6. The Chief of Party is in discussion with representatives of the Russian-American Enterprise Fund to determine how that program might coordinate with Farmer-to-Farmer. The FtF program may be able to provide technical assistance to the clients of banks which have already received FtF assistance. FtF volunteers could help draft business plans for the banks to present to the Russian-American enterprise fund.
- 7. The chief of Party is in discussion with representatives of Ernst & Young regarding Russian agribusiness clients of the firm. At the present time, the focus is on food processing companies. Ernst & Young is installing financial controls in these companies and preparing financial data on them in compliance with AICPA standards. Ernst & Young has inquired whether the Farmer-to-Farmer program could assist these clients.

C. WASHINGTON OFFICE SUPPORT ACTIVITY

1. The Field Office and Headquarters staff developed new strategy guidelines based on lessons learned from this first year of implementation. The ACDI Farmer to Farmer program continues to target its efforts on creating credit facilities for private farmers and improving the ability of private farmers to access credit. The programs technical assistance and training activities will focus on three areas: financial intermediaries, policy, and institutional development/capacity building.

2. ACDI completed the following three projects involving 9 volunteers during the quarter. The number in parentheses represents the number of volunteers recruited for the assignment.

Academy of National Economy Phase IV (3) Dmitrov Farm Financial Management (2) Buryatia Rosselkhozbank (2)

- 3. ACDI's refined <u>Project Monitoring Matrix</u> tracks volunteer project assignments, purpose of assignment, dates of assignments, positions required, potential recruits, volunteer team, initial orientation, debriefing, and action needed. This system intends to facilitate smooth coordination between the local participating organizations, ACDI/Washington and ACDI/Moscow. ACDI attempts to get the volunteers to the field as quickly as possible to maximize the time they spend working with host country counterparts.
- 4. The ACDI-Washington staff spent time with the evaluation team. The team was supplied with complete briefing binders on the ACDI Farmer to Farmer Program. ACDI also attended an implementors conference at DAI with the evaluation team members to assist in planning their trip.
- 5. The Assistant Recruiter made a site visit to the Moscow office. She participated in two Moscow team orientations and two team debriefings. She attended a meeting with Land of Lakes to discuss cooperation in a future FtF project. She met with representatives of AKKOR and USDA. She participated in a FtF Implementors Conference. She also had the opportunity to meet with the Russian Enterprise Fund.

This field trip provided the Assistant Recruiter with first hand knowledge of Farmer to Farmer operations. Her experience enables her to further facilitate recruitment and volunteer preparation in the U.S.

6. ACDI is continually updating the briefing packets for FtF volunteers. The Moscow office is supplying project-specific information for each group. ACDI attempts to provide each volunteer with a custom-made briefing book.

D. UPCOMING ACTIVITIES AND NEW RECRUITING NEEDS

- 7. April
 - a. **Siberian Peasant Bank** Two volunteers will develop and conduct a seminar on Mortgage Finance. They will also provide advice on bank marketing and ways to increase the owner's equity.

- b. **Nizhny Novgorod/Vyksa AKKOR** Two volunteers were to help local AKKOR prepare business plans for private farmers to receive bank loans. The project was cancelled due to severe flooding caused by melting snow.
- c. **Mosfermbank** This project will focus on assisting the bank on mortgage finance. Mosfermbank is the main provider of agricultural loans to private farmers of the Moscow Oblast.

8. May

- a. **Vologograd Agroprombank** A team of two volunteers will advise bank officers on banking issues with special emphasis on agricultural lending.
- b. Povolzhsky Training Center in Saratov Two volunteers experienced in computer software will assist the training center in developing a database on private farming in the oblast. This assistance will enable the Povolzhsky to be the center for information on agriculture in Saratov. The data-base will be instrumental in helping banks obtain information on potential clients. Private farmers can utilize the data-base to obtain valuable information regarding crops and planting.

9. June

- a. Saratov Municipal Bank. Two voluntcers will spend three weeks with the newly created bank to help develop a business plan. This will enable the bank to better provide credit to agricultural business in its market area.
- b. **Complexbank** A team of two volunteers will develop and conduct seminars to bank employees. The emphasis of the seminars will be on agriculture credit, bank marketing and mortgage finance.

E. PROJECT MANAGEMENT ACTIVITIES

1. Staff

ACDI has selected a new Chief of Party. He began work in Moscow on February 14, 1994.

2. Contractual Documentation

ACDI continues to hire a local driver who provides his car rather than purchase a vehicle.

Volunteer Database

Work proceeds. The database assists in recruiting experienced volunteers who have expressed an interest in NIS Farmer-to-Farmer assignment. It also provides information on former volunteers.

4. Volunteer Recruiting

Work proceeds as planned. The recruiter works closely with other organizations such as Iowa State University and CARD to select qualified professionals for ACDI volunteer positions. See previous sections for details.

6. Involvement of Women

ACDI continues to work with host organizations where women play an important role. 46% of our beneficiaries this quarter were women.

F. COORDINATION WITH AID AND OTHER ORGANIZATIONS

ACDI's new Chief of Party met with the AID Moscow staff upon arrival in February. Also, the Program Director and the Chief of Party met with the USAID FtF evaluation team twice.

ACDI and Land O'Lakes FtF projects are discussing joint sub-project activities in the Kalinigrad oblast. ACDI attends all FtF wide meetings called by AID/Moscow. ACDI and VOCA are also working closely together on the distribution of extension publications in Russian and other languages.

G. COORDINATION WITH ACDI FOOD SYSTEM RESTRUCTURING PROJECT

ACDI's Food System Restructuring Project is concentrating on the Central Asian nations that were republics in the former Soviet Union. ACDI FtF and FSRP field staff are discussing a redesign of the Food Systems Diagnostic Study to focus on a food group in critically short supply in Kazakhstan, baby food. ACDI FtF field staff have also sent inquiries from banks and other institutions with which it has worked in Russia on to Tri Valley Growers and CNAA FGRP representatives.

H. MONITORING AND EVALUATION

The ACDI Moscow staff met with several organizations that hosted ACDI volunteers to discuss the impact of ACDI's technical assistance and possible continuation of cooperation. These organizations included the Academy of

National Economy, AKKOR, Siberian Farmers Bank, and the Saratov Economics Institute.

All of the other ACDI hosts were contacted to obtain the necessary feed-back on the impact of ACDI's projects.

The ACDI field office has developed a questionnaire that will be submitted to our host institutions three months after the end of a sub-project. This will allow ACDI to better evaluate the impact of our projects. The first questionnaires were mailed in March 1994. (See attachment B)

III. OTHER PERTINENT INFORMATION

The FtF Project met most of the goals for the quarter.

Volunteers observe that the Russian economy is deteriorating under conditions of decreasing government support. Interfax reports that the Russian government has not paid for the grain it bought from private farmers last year. Thousands of farmers will not have any money for spring sowing. This spring, 40 percent of private farmers are expected to sow nothing at all.

At the debriefing sessions following each project, many volunteers comment on the lack of agricultural credit policy in Russia. The Russian government has channeled credit through Rosselkhozbank instead of the banks which handle private farm accounts. As a result, many farmers banks are on the verge of bankruptcy.

The question of land titling and registration is still a pending issue.

All volunteer project teams remarked that observational or study tours to the U.S. by Russian bankers, private farmers, agro-entrepreneurs and others involved with private farming would be vary beneficial. Their observation, in general, is that the opportunity to see a solid example in the U.S. would have great value. All ACDI volunteers have been requested to submit the names and positions of people who would benefit most if such a program begins in the future. In cooperation with other FtF providers, ACDI submitted nearly 80 candidates for USAID funded study in the USA, including 14 in agricultural banking.

IV. STATUS OF FINANCES AND EXPENDITURES

Project expenditures for the reporting period were less than planned, due primarily to volunteer field costs less than expected. See Attachment D for details.
