Implementing Policy Change Project

The Implementing Policy Change Project (IPC) began in 1990 as an ambitious, ten-year, USAID-financed endeavor, to improve policy implementation and democratic governance around the world. Building on its track record of hands-on technical assistance in more than 40 countries, and a related program of applied research and dissemination, IPC:

- helps governmental organizations use strategic approaches to: (1) modify their purposes, structures, activities, and procedures in ways that enhance their policy performance and transparency; and (2) respond to and collaborate with nongovernmental organizations and other groups in the policy environment.
- helps non-governmental organizations formulate and implement strategic plans to: (1) clarify and develop consensus on the policy issues that affect them; (2) build a constituency for policy change and an understanding of its process; (3) initiate actions that involve the non-governmental sector; and (4) influence policy decisions, implementation, and management.
- helps to bolster momentum for democracy and democratic governance by: (1) helping governments to discharge their policy responsibilities in a democratic and effective manner; (2) helping stakeholders affected by a policy change to have a constructive influence on policies; and (3) promoting government/non-governmental interaction and an enhanced

role for civil society in solving problems of importance to the society.

The IPC Approach

IPC brings a focused approach drawn from its extensive experience. This approach is characterized by the following "signature" elements:

- A concentration on the management of large system change -implementation of broad economic policies, or restructuring a government's policy-making or policy-implementation process.
- Explicit concern with issues of *governance* accountability, transparency, and effectiveness.
- A preference for *process approaches* -- facilitation, organizational development, and conflict resolution.
- A commitment to government and non-government ownership and capacity building in the host country.

IPC consultants assist host country managers to acquire the skills, build the constituencies, undertake the planning, strengthen the institutions and carry out the complex sets of activities needed to translate policy guidelines into action. Using a combination of facilitation, process consultation, training, management advice,

and technical expertise, IPC's multi-disciplinary teams help host country officials and civil society representatives solve concrete problems in ways that simultaneously improve the policy process and open it to effective participation from a broader cross-section of the citizenry.
