

Summary of World Economic Forum Travel & Tourism Competitiveness Report 2007¹ 1 March 2007

The World Economic Forum today released the first ever Global Travel and Tourism Competitiveness Report covering 124 countries around the world. The report aims to "measure the factors and policies that make it attractive to develop the Travel and Tourism (T&T sector in different countries."

T&T is one of the most important international economic activities and the fastest growing economic sector, according to the UNWTO, in terms of foreign exchange, earnings and job creation. Furthermore, is the largest economic sector for many countries, and is an important driver for growth, prosperity and poverty reduction.

To measure the competitiveness of the travel and tourism industry, WEF developed the Travel & Tourism Competitiveness Index (TTCI) with relevant travel industry counterparts. The index is comprised of 3 main subindexes, which are based on 13 pillars of T&T competitiveness:

T&T Regulatory Framework

- 1) Policy Rules & Regulations
- 2) Environmental Regulation
- 3) Safety & Security
- 4) Health & Hygiene
- 5) Prioritization of Travel & Tourism

T&T Business Environment & Infrastructure

- 6) Air Transport Infrastructure
- 7) Ground Transport Infrastructure
- 8) Tourism Infrastructure
- 9) ICT Infrastructure
- 10) Price Competitiveness in the T&T industry

T&T Human, Cultural & Natural Resources

- 11) Human Resources
- 12) National Tourism Perception
- 13) Natural & Cultural Resources

Overall Rankings

Armenia's rankings in the main TCCI index and the three subindices are shown in the chart below along with 20 other countries that CAPS believes Armenia should benchmark themselves against.

Armenia's overall ranking from 124 countries is 74. It is ranked 3rd within the CIS and 14th among its 'Competitor & Comparator' countries.

In terms of the Regulatory Framework subindex, Armenia ranks 65th in the world and 15th position among its 'Competitor & Comparator' countries.

Within the Business Environment & Infrastructure subindex, Armenia ranks 96th in the world and 18th among its 'Competitor & Comparator' countries.

Within the Human, Cultural and Natural Resources subindex, Armenia ranks 62nd in the world and 13th among its 'Competitor & Comparator' countries.

The indicators used in each of the subindices are outlined in the following pages along with further analysis of Armenia's position relative to its Competitor & Comparator Countries.





Regulatory Framework

In the Regulatory Framework subindex, Armenia ranks 65th in the world and is in 15th position among its 'Competitor & Comparator' countries.

- 5) Prioritization of Travel & Tourism



<u>Figure 4. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Policy</u> Rules & Regulations Segment




Armenia performs poorly (ranking below 60) for all of the indicators under this segment, except for Rules Governing FDI. Armenia ranks overall in 92nd position in the world for this group of indicators and in 16th position amongst the 20 Competitor & Comparator Countries.

Environmental Regulation

The following indicators were used in calculating nation rankings. The number provided in brackets is Armenia's global ranking. SD – Soft Data, HD – Hard Data.

<u>Figure 5. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Environmental Regulation Segment</u>




Armenia performs poorly (ranking below 60) for all of the indicators under this segment. Armenia ranks overall in 102nd position in the world for this group of indicators and in 16th position amongst the 20 Competitor & Comparator Countries.

Safety and Security

<u>Figure 6. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Safety & Security Segment</u>




Armenia performs poorly (ranking below 60) only for the reliability of its Police Services under this segment. Armenia ranks overall in 49th position in the world for this group of indicators and in 10th position amongst the 20 Competitor & Comparator Countries.

<u>Figure 7. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Health & Hygiene Segment</u>




Armenia performs poorly (ranking below 60) only for the Government Efforts to Reduce Health Risks from Pandemics under this segment. Armenia ranks overall in 40th position in the world for this group of indicators and in 8th position amongst the 20 Competitor & Comparator Countries.

<u>Figure 8. Rankings of Armenia and its 20 Competitor & Comparator Countries in the</u> Prioritization of Travel & Tourism Segment




Armenia performs poorly (ranking below 60) in its Effectiveness of Marketing & Branding to Attract Tourists and its T&T Fair Attendance under this segment. Information was unavailable during the analysis on the T&T Government Expenditure as a percentage of total budget. Armenia ranks overall in 67th position in the world for this group of indicators and in 9th position amongst the 20 Competitor & Comparator Countries.

Business Environment and Infrastructure

In the Business Environment & Infrastructure subindex, Armenia ranks in 96th in the world and 18th position among its 'Competitor & Comparator' countries.



<u>Figure 10. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Air</u> Transport Infrastructure Segment





Armenia ranks overall in 95th position in the world for this group of indicators and in 16th position amongst the 20 Competitor & Comparator Countries.

<u>Figure 11. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Ground Transport Infrastructure Segment</u>





<u>Figure 12. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Tourism Infrastructure Segment</u>



Armenia ranks overall in 110th position in the world for this group of indicators and in 20th position amongst the 20 Competitor & Comparator Countries.

<u>Figure 13. Rankings of Armenia and its 20 Competitor & Comparator Countries in the ICT Infrastructure Segment</u>




Armenia performs poorly (ranking below 60) for all indicators under this segment. Armenia ranks overall in 84th position in the world for this group of indicators and in 18th position amongst the 20 Competitor & Comparator Countries.





<u>Figure 16. Rankings of Armenia and its 20 Competitor & Comparator Countries in the Human Resource Segment</u>




Armenia performs poorly (ranking below 60) for its Primary Education, Quality of Educational System, Local Availability of Specialized Research & Training Services, Extent of Staff Training, Malaria Incidence, Tuberculosis Incidence and Life Expectancy under this segment. Armenia ranks overall in 53rd position in the world for this group of indicators and in 11th position amongst the 20 Competitor & Comparator Countries.



Armenia ranks 74th in the world by Travel and Tourism Competitiveness Index

Economy and Values Research Center being a partner organization of the Global Competitiveness Network (GCN) of the World Economic Forum (WEF) participated in the development of the Travel and Tourism Competitiveness Report 2006-2007. The World Economic Forum published this report for the first time. It is a comprehensive analytical study providing the assessment of the travel and tourism competitiveness of 124 countries.

In compliance with the report, Switzerland is the most competitive country in the world in terms of travel and tourism, followed by Austria and Germany, while Chad, Burundi and Angola are among the most non-competitive ones.

Results for Armenia

Armenia ranks the 74th among 124 countries within the Tourism Competitiveness Index. It is 3rd among NIS countries with only Georgia and Russia ahead. Georgia is positioned in 66th position and Azerbaijan ranks 75th.

The Global Tourism Competitiveness Index consists of 3 subindexes:

- 1. Tourism regulatory framework
- 2. Tourism business environment and infrastructure
- 3. Human, cultural and natural resources

The business environment and infrastructure index was the one which especially had a negative impact on the rank of Armenia making it the 96th country in the world. However, from the point of view of the tourism regulatory framework and human, cultural and natural resources, Armenia is positioned comparatively higher, ranking 65th and 62nd correspondingly.

The most significant among Armenia's competitiveness advantages are:

- Health and hygiene
- Safety and security
- Price competitiveness in T&T industry
- Attitude towards tourists

The main disadvantages of the competitiveness of Armenia's tourism industry were those connected with:

- Visa requirements in relation with those countries the citizens of which travel most of all (for instance Germany, Italy)
- Environmental protection
- Domestic transport network
- International air transport network
- Passenger air transportation infrastructure
- Bilateral air service agreements
- Presence of major car rental companies
- ATMs accepting Visa cards
- Hotel rooms
- Local availability of research and training services and extent of staff training
- Business concern for ecosystems
- Carbon dioxide damage
- Effectiveness of marketing and branding
- Extent of business internet use

By the way, Armenia highest ranking is level of primary education coverage and lowest, port infrastructure.
